Our office received four California Public Records Requests this week and forwarded to the appropriate department for a response. Two responses were provided by the City Clerk's office.

The Special Election for State Senate District 7 was held on Tuesday, March 17th. Mail-in ballots were accepted at the City Clerk's Counter in a secure ballot box. The County Elections Office picked up the ballot box the following morning to be processed and counted. The City Clerk provided polling location to Antioch residents who called on Monday and Tuesday.

Unsuccessful candidates in the SD-7 race are reminded to have all their yard signs and 4x8 signs removed by March 28th, 10 days after the Special Election. Successful candidates and their supporters are reminded that campaign signs may only be placed on private property with the property owner's permission. Campaign signs are not permitted on lamp posts, telephone poles, sidewalks, city right-of-ways or public property (including Caltrans property).

RECREATION UPDATES:

- Staff began preparing for "Keep Antioch Beautiful" day on April 18th. Prewett Community Park is one registration and check-in location. Come help clean up our park and trails!
- First Five of Contra Costa and the City of Antioch Youth Sports & Aquatics Spring Programs have a few openings before filling to capacity! These collaborative programs begin the week of April 4th.
- On Saturday and Sunday March 14th & 15th the Antioch Community Park was host facility for the USSSA youth hardball tournament for boys 12 years and younger. Seventeen teams from all over California participated-visiting Antioch, spending their travel funds in our community and basking in the beautiful weather weekend.
- Staff continued interviews for several seasonal positions at the Antioch Water Park. Many applicants have stated their interest in working at the Water Park is largely because they were involved in swim lessons and Junior Lifeguard programs at the park. Other applicants stated that they were interested in working at the Water Park because they want to be a part of the community they grew up in.
- **EVERYONE INTO THE WATER!** Water Park Season Passes are on sale now. Purchase before May 23 and save 25%! Join the twenty year celebration of community memories and fun.
- Last Saturday, the first of 4 Lifeguard Certification classes began. Lifeguards working at the Water Park must have a valid American Red Cross Lifeguard Certification. Lifeguards ensure that all customers at the Water Park have a safe and memorable experience.
- Spring Irrigation checks for Prewett Community Park are 20% complete. The City's park maintenance contractor is in the process of making necessary repairs.
- On Wednesday, maintenance staff completed the removal of Water Park pump number 10 and its associated plumbing. Staff will complete the installation of the new pump and plumbing next week. The pump that was removed operated above and beyond its expected lifespan, giving the City an opportunity to use resources wisely.
- Throughout the week, recreation maintenance staff focused on spring startup tasks for the pools at the Water Park. The sports pool had a new heat exchanger installed by the City's pool boiler maintenance company and is now ready to open for classes on March 21st.
- On Thursday, March 19th the Antioch Community Center and Contra Costa Library hosted the Lawrence Hall of Science "Catapult program for Kids". This no-cost program taught Kindergarten-8th graders all about how engineering and physics come together. Kids working in groups created miniature catapults and then began launching! Learning and enrichment happens all over the City!
- Staff joined the Prewett Community Park Development Project team to interview the consultants who submitted proposals for design services of the final phase development project.

- On Wednesday, the Parks and Recreation Director and Deputy Director of Public Works met with the families of the First Five/East County Regional Group to brainstorm ideas for improving the playground at Contra Loma Estates Neighborhood Park.
- On March 19, the Parks and Recreation Commission held their regular meeting.
 Commissioners focused on the importance of park stewardship programs and discussed ways to involve more residents in park watch programs.
- Last week, members of the staff attended the California Park and Recreation Society statewide education and training conference in Sacramento. The Conference focused on the newest trends in the marketplace, offered networking opportunities with vendors and other professionals, and provided innovative workshops that emphasized best practices for engaging the community around you.
- Antioch recreation and park services has partnered with the "Parks Make Life Better" campaign to enhance resident awareness about the value of parks for health and fitness, nature, community and family. Look for the logo to show up around the City!

Senior Center Services

- The Antioch Senior Nutrition program served 12,725 meals from July 2014 to February 2015. Of the 18 cafes, Antioch serves the highest number of participants – 10% higher than the next highest serving café. Last week, staff met with the Contra Costa Health Services Senior Nutrition Program Operations Manager to consult on quarterly cafeteria participant numbers.
- Last week, 464 affordable, healthy meals were served which was an increase of 83 meals from the previous week. No membership or income requirements are required to eat at the C.C. Cafe.
- On Friday, March 13th, seniors enjoyed the monthly movie mania day, a wonderful gathering for socialization and providing a fun and safe outing for seniors to enjoy a movie and treat with friends.
- On Monday, March 16th, free blood pressure screenings were offered to senior community members at the Senior Center facility. This service is worth a value of \$20 per participant. Twenty three senior participants utilized this free service to maintain quality health.
- On Tuesday, March 17th, 106 senior participants attended the annual St. Patrick's Day celebration accompanied by a traditional Irish meal provided by the senior nutrition program. Seniors participants wore green and enjoyed socialization and holiday cheer.
- On Thursday, February 19th, Antioch Senior Services and AARP collaborated to provide free tax services to low income seniors over the age of 60. The tax services reached full capacity of 40 + appointments. Throughout the months of February and

March, this program has serviced 216 low-income senior participants offering affordable solutions to seniors in the Antioch community.

to the area for two weeks prior to the clean up. Shelter and other services were repeatedly offered to anyone in the area who wanted it. Several people accepted services, many did not. Over 300 cubic yards of debris was left behind by those staying in the area. Prior to and during the clean up, the City also offered to store belonging for anyone leaving the area, several people took advantage of this service.

The amount of actions will dwindle over the next few months as more time is spent by staff working on Eco-events and other environmental projects.

PUBLIC WORKS UPDATES

Administration

- PG&E is continuing work on their 27-mile Contra Costa to Moraga 230 Kilovolt transmission line upgrades. This 27-mile project will begin in Antioch. Work which will involve raising transmission towers and replacing existing lines is scheduled to continue through May in Antioch. Crews and contractors are using helicopters and truck-mounted cranes to perform the work. Work will generally occur daily between 7:00 a.m. and 5:00 p.m. PG&E has fenced the area they will be utilizing at Chichibu Park. They will also be staging work at another site near the Mira Vista Hills Reservoir off Cambridge Drive during much of the construction in Antioch as staging and construction locations for their operations. - SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The Contra Loma Blvd./'L' St. undercrossing will be closed to through traffic this Friday evening from 10 p.m. – 5 a.m. Punchlist items are being completed for the 'G' Street Bridge.
- Community Development Block Grant (CDBG) Downtown Roadway Pavement Rehabilitation: The completed reconstruction of the intersection of K & 4th Streets are expected to commence in the near future. Concrete repairs throughout the downtown area are scheduled to begin next week. The contractor will need to close streets to accommodate the work. Road closures are limited to short segments (1 to 2 blocks long) to minimize inconvenience.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for new home construction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: Staff is reviewing a second revision to the approved plans and construction submittal documents. Parcel map, appurtenant easements, right-of-way dedications and quitclaim deed sent to the County Recorder's Office for filing. Grading and construction of improvements begun. Phase 2 environmental clearance and USBR permit in process.
- Cellular Providers on City-owned Property: Metro PCS is decommissioning their Via Dora site. AT&T is pursuing a lease modification for their James Donlon site. Crown Castle is seeking to renegotiate a lease for their Putnam Drive site.
- City Sports Club, located at 5001 Lone Tree Way: At the developer's request, staff returned "at risk" plan check comments and approved lot merger and easement vacation documents pending a Planning Commission hearing.
- Contra Loma Estates HOA Privatization: Contra Loma Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrances to their subdivision. Staff has requested additional documentation. Planning Commission and City Council approvals are required.
- DeNova Homes Mixed Use Project at Hillcrest Ave./Wildflower Dr.: Application for mixed use project consisting of 9.5 acres commercial, 8 acres multi-family, and 2.2 acres single family development. Staff reviewing for conditions of approval.
- Golden Bow Estates HOA Privatization (PW 652): Golden Bow Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrance to their subdivision. Planning Commission and City Council approvals are required.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: The developer is preparing a final development plan submittal.
- Nelson Ranch Unit 1 Subdivision 6893, a 102-unit housing development by Standard Pacific Housing, located northeasterly of Wild Horse Road and Ridgeline Drive and southwesterly of State Route 4: Developer's engineer is preparing revisions to 2011 State Freeway Maintenance Agreement that include the Wild Horse Road undercrossing. Developer is mobilizing to remove graffiti from soundwalls along SR4.
- Oakley Knolls Subdivision 9353, a 31-lot development by Discovery Builders, located north of Oakley Road 1,300 feet west of Phillips Lane: Staff prepared conditions of approval for the tentative map application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Staff returned 2nd map and

- plan check comments and prepared conditions of approval for landscaping plans design review approval.
- PG&E Lot Line Adjustment, located at the southwest corner of Somersville Road/Buchanan Road intersection: Staff approved lot line adjustment documents for recording purposes.
- Taco Bell, 1706 'A' St.: Staff prepared conditions of approval for a use permit application.
- Wilkinson-VanSandt LLA: Application has been made for a lot line adjustment between 4316 and 4325 Berryessa Ct.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The Contra Loma Blvd./'L' St. undercrossing will be closed to through traffic this Friday evening from 10 p.m. – 5 a.m. Punchlist items are being completed for the 'G' Street Bridge.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Bridge construction is underway at the Lone Tree Way/'A' Street and Cavallo Road undercrossings.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and eBART Tunnel Project: Trucks will be hauling dirt across the Hillcrest bridge from excavation of the new eBART maintenance of works (MOW) access tunnel from March 18-23.
- eBART Parking Lot and Maintenance Facility: The contractor has requested permit final on the encroachment permit for Slatten Ranch Road improvements. Staff is reviewing plans and easement dedications for a proposed 12" sanitary sewer main from the new Maintenance Facility north underneath the S.P.R.R. railroad line and along the extension of Willow Avenue from Oakley Road.
- SR4 Lone Tree Way 4-Lane Widening/Sand Creek Road Interchange Project: Installation of irrigation and landscaping in the Lone Tree Way/SR4 "Bypass" undercrossing median has been completed.
- Wal-Mart expansion: Processing easements and vacation of existing easements.
- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: Processing abandonment of existing easement.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues.
- Aviano, a proposed 533 unit housing development located on Sand Creek Road west of future Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The revised tentative map has been submitted for review and staff is updating conditions of approval.
- The Ranch, a proposed 1,667 unit housing development located between Deer Valley Road and Empire Mine Road: Staff is preparing comments for preliminary development plan.

- Heidorn Village, a proposed 117 unit housing development located at the northwest corner of Prewett Ranch Drive and Heidorn Ranch Road: The tentative map has been submitted and staff is creating conditions of approval.
- Quail Cove, a proposed 32 unit housing development located on the south side of Prewett Ranch Drive west of Heidorn Ranch Road: The tentative map has been submitted and staff is creating conditions of approval.

Capital Improvements Division

- Sanitary Sewer Main Replacement at Various Locations: RGW Construction is installing new sanitary sewer service laterals on Acacia Avenue and West 19th Streets. Roadway surface restoration is being performed on Belshaw Avenue, Deodar Avenue, Chestnut Avenue and Birch Avenue. Concrete repairs have commenced on Evergreen Avenue.
- Williamson Ranch Plaza Water Main Replacement: D.R. Lemings is performing additional chlorination and flushing of the new water main on the western side of Williamson Ranch Plaza in preparation for supplementary bacteriological testing.
- Piping Reconfiguration of Canal Pumps 2 and 4 and Pump 2 Replacement: Work is continuing at the Canal East Pumping Station. Contra Costa Water District has removed their flow meter and Con-Quest Contractors has removed the deteriorated pipe segment. A new valve has been installed and the existing concrete pipe supports are being modified to fit the new pipeline.
- Curb, Gutter and Sidewalk Repair Program: Anchor Concrete continued to remove and replace deteriorating, damaged and uneven concrete throughout the city. Over the past week a total of 140 lineal feet of curb and gutter were repaired.
- Community Development Block Grant (CDBG) Downtown Roadway Pavement Rehabilitation: MCK Services, Inc. has reconstructed portions of the intersections at K and 3rd Streets and K & 5th Streets. The completed reconstruction of the intersection of K & 4th Streets are expected to commence in the near future. Concrete repairs throughout the project area are scheduled to begin next week. The contractor will need to close streets to accommodate the work. Road closures are limited to short segments (1 to 2 blocks long) to minimize inconvenience.
- Ninth Street Roadway Improvements: MCK Services, Inc. commenced lowering existing water valve boxes and manhole tops on West Ninth Street between 'A' to 'H' Streets. Reconstruction of the intersections in this area is scheduled to start next week. Road closures will be needed to accommodate the construction.
- Marina Boat Launch Facility, Third Boarding Float: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for April 7, 2015, at 2:00 P.M. in the City Council Chambers located at 200 'H' Street.
- Water Treatment Plant Disinfection Improvements: Requests for Proposals have been sent to various engineering consulting firms to perform comprehensive feasibility studies and alternative analysis on various disinfection processes to

- replace the existing chlorine gas pre-treatment and post-treatment currently utilized at the City's Water Treatment Plant. Consultant responses are due March 31st.
- Rubberized Cape Seal Program: The City Council awarded the 2015 Pavement Maintenance Cape Seal project to the low bidder, American Pavement Systems. Construction is scheduled to start June 8, 2015, and be completed by July 31, 2015.
- 2015/2016 Transportation Development Act (TDA) grant: Staff met with the Countywide Bicycle Advisory Committee to field review the grant application to MTC to install 35 new curb ramp locations along 'A' Street, Blue Rock Drive and West Tregallas Road.
- Safe Routes to School Grant (Cavallo/Garrow/E. Tregallas curb ramps): Staff opened bids for the installation of 85 curb ramps and sidewalk improvements along Cavallo Road, Garrow Drive, East Tregallas Road and Drake Street. The City Council awarded the construction contract at the February 24th meeting to JJR Construction. Construction is scheduled to start in April 2015.
- Transportation Impact Fee Study: The kick-off meeting was held February 24th and staff is gathering data requested by the consultant. The study is scheduled to be completed within a 12 month period.
- Preventative Pavement Maintenance Program: The City Council awarded the project to MCK Services, Inc. and staff is preparing the construction contract. Construction of the project is scheduled for April 2015.
- Cavallo Road and Country Hills Drive Pavement Rehabilitation: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project has been rescheduled for March 24, 2015 due to an addendum issued March 13th. Construction is scheduled for May 2015.
- Prewett Park Improvements: Staff received four proposals for consultant services for the design of the final improvements at Prewett Park. Staff interviewed three consultants on March 16th as part of the selection process for design services of the final phase development for Prewett Community Park. The design process will incorporate new features into the water park as well as new areas of play in the community park. A second interview for the top consultant is scheduled for March 24th. Construction is anticipated to start in January 2016.

Traffic Engineering

- Downtown Electric Vehicle Charging Station: 511 Contra Costa has purchase a ChargePoint dual 240V station for installation in the City Hall parking lot, 200 'H' Street. Installation should be complete in the next few weeks.
- Staff has received several requests for information related to procedures to have speed tables installed on City streets. The requirements include but are not limited to: receiving 75% agreement from property owners affected by the proposed speed tables, speed tables complete with related signing and striping installed at no cost to the City, excessive speeding on the street to receive the speed table(s), written concurrence from the Antioch Police, Contra Costa Fire, Tri-Delta Transit and the

Antioch Unified School District, and agreement that the speed tables will be removed with a 51% petition of affected property owners and removal of the speed tables at no cost to the City. Water Treatment Plant

- Installed a new flow meter for "A" plant zone II pumping.
- Added a new sample point in "A" plant clear well. Installed new pump and piping to "A" plant instrumentation.
- Installed a new roll up door on "B" plant generator building.
- Cleaned solar bees out on the reservoir. Also cleaned the staff gauge on the tower. This is reoccurring and ongoing.

Water Distribution

- There were 253 stops for water service including disconnections.
- There were a total of 54 USA tickets completed for utility location.
- Meter reading for the month of March is on schedule.
- Annual backflow test program continues and is on schedule.
- Water crews have started the meter testing program to monitor water conservation and usage.
- Water crews are continuing to maintain the backfill material area and dumpster area at Fulton Yard.
- Water field tech continues responding to customer related calls city wide.
- Water crews replaced a three inch meter and backflow device on E. 16th St.
- Water crews replaced a fire hydrant on Deer Valley Rd.
- Water crews replaced a one inch water service on Wilbur Ave.
- Water staff second shift continues city wide fire hydrant preventative maintenance program.
- Stores staff began updating the vehicle keys in the Stores office and the emergency box in the training room.
- Stores staff continues removing graffiti and debris from Amtrak station and Fulton boat ramp.
- Stores staff continues to identify non-moving stock items for distribution and/or disposal.

Public Works Maintenance Operations – Parks and Landscape

- Playground and Park Safety Inspections: Completed at Nelson Ranch and Hillcrest Parks.
- Playground Maintenance Repair: The belt swings at Knoll Park have been repaired and are now back in use.

- Playground Vandalism: Mira Vista Hills Park playground was the latest scene of malicious vandalism. The Mogul Slide has a hole punched in the exit zone necessitating closing the slide for safety reasons. Replacement parts are on order.
- Park Tree Removals: Chaparral Park had five established African Sumac Trees removed for High Voltage Line clearance safety per PG&E. This week the old stumps were ground out to make way for replanting trees more fitting to PG&E height restrictions imposed.
- Staff was in training this week to refresh playground safety knowledge and recertified as CPSI (Certified Playground Safety Inspector).
- Irrigation leaks were attended to and repaired.
- Spot Spraying: Deer Valley Rd., Prewett Ranch Dr., Mammoth Dr., Lone Tree Way, Dallas Ranch Dr., Laurel Rd., Goode St. and Davison Dr. medians.
- Weed Control: Deerfield Corridor.
- Assist Cleanup of Homeless Encampment at Tommy's Harbour/Rodger's Point.
- Tested nine irrigation controller sites for future antenna hookups to our central irrigation system.

<u>Public Works Maintenance Operations – Street Maintenance</u>

- Annual Weed Abatement Spray Program: Completed.
- Traffic Striping and Pavement Marking: Painted 900 feet of 12 inch bars and 176 stencils.
- Debris: 320 yards removed from homeless encampment near Roger's Point under the direction of Code Enforcement.
- Graffiti removed from city property in numerous areas.
- Potholes: Four potholes filled.
- Pave Service Cuts: 14 service cuts paved.
- Signs: Ten signs replaced due to poor reflectivity.

Public Works Maintenance Operations – Collections Division

- Calls for Sewer Service: Received and responded to 13 calls for service from the public, responding crews televised 34 public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 7,429 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the hot spots.
- CIP Projects: Crews televised 3,080 feet of sewer main lines and 30 public sewer laterals in preparation of CIP's Pavement Management Cape Seal project.
- SSMP (Sewer System Management Plan): We are updating the City's SSMP to meet the requirements established by the State Water Resources Control Board. The goal of the SSMP is to minimize the frequency and severity of sanitary sewer

- overflows. The SSMP covers the management, planning, design, operation and maintenance of the City's sanitary sewer system.
- OERP (Overflow Emergency Response Plan): We are updating the City's OERP.
 The OERP provides guidelines for City personnel to follow in responding to,
 cleaning up, and reporting SSOs that may occur within the City's service area and
 supports an orderly and effective response to sanitary sewer overflows (SSOs).
- Overflow Emergency Response Trailer: The design and construction of the overflow response trailer is in process. This equipment supports OERP/SSMP programs.
- Manhole Inspection Program: Crews inspected 21 manholes. Manholes are inspected for loose lids, debris, locking mechanisms and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- CCTV (Closed Caption Televising): The CCTV Preventative Maintenance program is under development for inspection of sewer mains to identify the condition and causes of blockages and SSOs.
- NPDES (National Pollutant Discharge Elimination System): Crews removed 369 yards of debris and trash out of various creeks and channels. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

<u>Public Works Maintenance Operations – Fleet Maintenance</u>

- Preventative Maintenance: 15 services on city vehicles as scheduled.
- Unscheduled Repairs: 47 necessary repairs to city vehicles.

Marina

- Received six inquiries for berthing and gave one tour of the facility.
- Maintenance repairs included removing Hyacinth, primrose and debris from F dock.
 Power washed four marina benches and table, repaired broken drinking fountain and repaired top to pump out station.
- Advertising and outreach: Craigslist weekly ads posted in the Sacramento, Bay area, Stockton, Santa Cruz and Monterey areas.
