RECREATION UPDATES:

- On Saturday, March 18, family and friends packed the Antioch Community Center Amphitheater for the Recreation Department Winter Dance Recital. Youth participants enrolled in the Recreation Dance Program blossomed with confidence and pride as they performed a choreographed dance to the utter delight of their families! In addition to increasing children's confidence, dance increases flexibility, agility, coordination, and spatial awareness.
- This week, Recreation Staff implemented new procedures to provide ongoing maintenance and inspection at the new playground. Staff is now permanently assigned to important routine maintenance to keep the new Prewett Community Park Playground looking new and inviting.
- To date, the Water Park has 12 Buyouts, 2 Slide Rentals, and 2 City of Antioch Buyouts scheduled for the 2017 season along with 4 picnic area reservations and 7 group ticket reservations. COME SPLASH WITH US!
- On Friday, over 100+ seniors at the Antioch Senior Center enjoyed a St. Patrick's Day celebration and enjoyed a CoCo Café themed lunch which included corned beef and cabbage as the main course, with a side of red potatoes, and a slice of key lime pie.
- On Thursday, AARP continued their annual income tax season at the Antioch Senior Center. They will have free tax services for Antioch Senior Citizens every Thursday through April 13th.
- This week, over 70+ seniors participated in our daily Beginners, Intermediate and Advanced exercise classes. The Antioch Senior Center exercise classes allow senior citizens the opportunity to develop and maintain healthy workout routines and live a more active lifestyle through group exercise and group support.
- To date, the Senior Club has received a total of 602 new and renewal membership applications. New membership for 2017 began on December 28th and the membership drive has been steady.
- Over the last week, 404 affordable, healthy meals were served through the CoCo Café. This program helps prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the CoCo Café. All supplies are provided by the County for participating cafés.

Eco-Hero school assemblies - The City sponsored Eco-Hero assemblies started this week. Staff was able to attend one of the performances at Belshaw Elementary.

Community Development Block Grant (CDBG):

The federal budget process has begun with the President's proposal, which eliminates all funding for CDBG and HOME. This is not likely to be the final outcome, however. The CDBG program has enjoyed widespread bi-partisan support, and the last several years Congress funded CDBG at a higher level than the President's recommendation in his budget proposal. Unfortunately, the HOME program has been under attack for the past four years, and may well be eliminated or severely reduced.

The FY 16-17 budget is presently under a continuing resolution until the end of April. The CDBG notice of funding will likely not come until sometime after the fiscal year begins.

We have been instructed by HUD NOT to submit our Action Plans until after the notice of funding is received. Therefore, the anticipated Public Hearing on May 9th will likely be delayed.

Review and evaluation of all applications by the Council Subcommittee is underway, and agency interviews have been scheduled for April 7th and 21st. The allocations are for the three-year grant cycle of 2017-18, 18-19, and 19-20, with renewal of funding for agencies that are satisfactorily meeting their goals and in compliance with regulations, based on availability of funds.

Housing:

<u>Mobile Home Subsidy</u> - Housing has received calls from Vista Diablo Mobile Home Estates about the rent subsidy ending in September. Currently, 81 lower income senior households receive a subsidy of \$75.32 per month, per a contract with the owners of the property that was initiated before the closure of all Redevelopment agencies statewide. Neither CDBG nor Redevelopment funds are available to continue the subsidy:

 CDBG funds cannot be used to provide long-term rental subsidy as this is not permitted by federal regulations. • The Housing Successor balance will reach near ZERO next year, except for the few housing loan repayments that we sporadically receive.

<u>Fair Housing and Tenant/Landlord Counseling FREE</u> - The City of Antioch contracts with Bay Area Legal Aid (BayLegal) and Echo Housing is their partner with an office in Antioch. If anyone suspects that they have been discriminated against, or has questions about the legality of something that a landlord is doing, they can call Echo Housing toll-free at 855-275-3246.

Drought Updates:

Registration for the Sunday, May 7, 2017 <u>Bringing Back the Natives Garden Tour</u> is now open! This year's tour will fill quickly; <u>register now</u> to reserve your place. Forty one <u>bird and butterfly-friendly</u>, <u>pesticide-free</u>, <u>water conserving</u>, <u>low maintenance gardens</u> that contain 60% or more native plants will be open on Sunday, May 7, 2017, from 10 a.m. to 5 p.m. at various locations throughout Alameda and Contra Costa counties. Twenty-five of these gardens have not been on the Tour before. More than fifty garden talks will be offered throughout the day.

• Park Irrigation: All City Parks remain in rain shutdown at the irrigation controllers.

PUBLIC WORKS UPDATES

Engineering & Development Services

- Aviano, a 533-unit housing development by Aviano Farms, located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff is reviewing Phase 1 (3rd submittal) construction documents and plans. Staff is discussing an offsite sewer improvement with the developer.
- BART Maintenance Facility (MF): A sanitary sewer line connection for the MF is under construction, expected to be completed by the beginning of May. Staff is processing appurtenant public sanitary sewer easements.
- Heidorn Village, a 117-unit housing development by Mission Peak Homes, located on 20.3 acres west of Heidorn Ranch Road and north of the eastern terminus of Prewett Ranch Road: The City's consultant prepared a map check estimate and the developer intends to submit improvement plans for review in March.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The developer is grading the site and installing underground utilities. Staff is reviewing model home plot plans.
- Vineyard Self Storage by Recess Development Co., located at the NW corner of E. 18th Street and Vineyard Drive: A lot merger was recorded at the County Recorder's Office.

Capital Improvements Division

- Downtown Sanitary Sewer Rehabilitation: A-S Pipelines, Inc. is constructing new sanitary sewer manholes and repairing and replacing deteriorated sewer service laterals on West 7th, West 8th and West 9th Streets.
- Zone I Transmission Pipeline Rehabilitation at HWY 4: Staff is reviewing project material submittals. Construction is expected to commence in April.
- Water Treatment Plant Disinfection Improvements: Bids of this work were publicly opened on March 21st. The apparent low bid was submitted by Anderson Pacific Engineering Construction, Inc of Santa Clara in the amount of \$2,598,918. The award of this construction contract is schedule to be considered at the April 11th City Council meeting.
- Community Development Block Grant (CDBG) Downtown Roadway Pavement Rehabilitation: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/ antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for May 2nd at 2:00 p.m. in the City Council Chambers located at 200 'H' Street.
- Northeast Annexation Infrastructure Improvements: BKF Engineering is working on cost estimates for the new infrastructures improvements needed in the Northeast Annexation area.
- Transportation Impact Fee Study: At Council direction, EPS will be providing additional services and circulate a draft study for public and developers' review.
 Staff is preparing a staff report and contract amendment for consideration at the City Council's March 28 meeting.
- Retaining Walls Rehabilitation: The contractor completed the retaining walls project on Contra Loma Boulevard and James Donlon Boulevard. The project is scheduled for final acceptance by the City Council on April 25, 2017.
- Staff presented the draft 2017-2022 Five Year Capital Improvement Program (CIP) to the Planning Commission on March 15th and to the Parks & Recreation Commission on March 16th. The City council will hold a Budget Study Session on April 25, 2017 to review the five year CIP.

Water Treatment Plant

The chloride levels in the San Joaquin River have continued to stay low. We will
continue to pump high quality water from the river until we see a reversal in the
current trend.

Water Distribution

- Responded to 190 stops for water service including disconnections.
- Had a total of 60 USA tickets completed for utility location.
- Replaced a leaking 1" water service on Barmouth Dr and Shaddick Dr.
- Repaired two sections of the 24" water main on D St. as preventative maintenance.
- Repaired a 6" water valve on Mahogany Way.

Public Works Operations - Parks and Landscape

- Playground and Park Safety Inspections: Completed at City, Contra Loma Estates, Country Manor, Dallas Ranch and Deerfield Parks. A follow-up inspection was completed at Knoll Park and the pending punch list items were released.
- Park Irrigation: Incoming irrigation water is back on at Chichibu Park. All other City parks remain in rain shutdown mode at the irrigation controllers.
- Antioch Community Park: A new sink faucet valve was installed in the men's main restroom. The playground slide plugs were replaced to keep our slides safe.
- Recycle Water Chichibu and Fairview Parks: The first quarter inspections were completed.
- Dallas Ranch Park: Repairs were made on the Over-Head Wheel Spinner, a favorite of playground users.
- Park Tree Removals: A Pine tree at Knoll Park was removed for safety reasons.
 The tree had become structurally unsound since a large portion of it fell on the restrooms during a big storm on 2/17/17.
- Tree Failures: Two very large Pine trees fell at two different parks: one at Deerfield Park, on the slope above the park and one at Hillcrest Park along the pathway from Bellflower Dr. Fortunately, no one was hurt and there was only minimal damage to the adjacent trees. Both trees are scheduled for removal soon.
- Trim Crews: Hillcrest Avenue (Wildflower to Wild Horse area), Heidorn Ranch Rd., James Donlon Blvd., Delta Fair Blvd. and O St. lot.
- Spot Spray: Fredrickson Lane, Lone Tree Way medians, James Donlon public rights of way, Lone Tree Way public rights of way and Delta Fair medians.
- Tree Removals: Hillcrest Ave.
- Park Renovation: Prosserville Park City Crews have installed the rock base material and the will begin installing the play structure as soon as we get a break in the weather.

Public Works Operations – Street Maintenance

- Replaced 30 existing signs due to poor reflectivity or line of sight.
- Filled four potholes.
- Picked up four yards of debris in the roadway and at illegal dumping sites.
- Evaluated and repaired tripping hazards on the Marina Trail.

Public Works Utilities - Collections Division

- Calls for Sewer Service: Received and responded to 12 calls for service from the public. Televised 240 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 24,596 linear feet of sewer main lines.
- Repaired two laterals that were severely damaged requiring immediate repairs.
 Crews also televised twenty laterals.

- Manhole Inspection Program: Inspected 125 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. Staff is updating the program and processes for integration in our computerized maintenance management system.
- Closed Caption Televising (CCTV): Televised 6,609 feet of sewer main lines. The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and Sanitary Sewer Overflows (SSOs).
- Lateral Inspection Program: Inspected twenty sewer lateral sites and televised eight laterals, which equates to 280 linear feet of public sewer laterals.
- SMART Manhole Devices: These devices monitor flow/level and alert staff to potential sewer backups or flow problems. We had one alarm system failure that was inspected and repaired.
- National Pollutant Discharge Elimination System (NPDES): Removed one yard of household and green waste in various creeks and channels. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways.

Public Works Operations – Fleet Division

- Preventative Maintenance: 16 services on City vehicles as scheduled.
