The City Clerk's Office received 6 California Public Records Act requests which were forwarded to the appropriate departments for a response.

City Clerk Arne Simonsen attended the League of California Cities' policy committee meetings in Ontario. On Thursday he participated in the Housing, Community & Economic Development Policy Committee; and on Friday the Governance, Transparency & Labor Relations Policy Committee, going over relative legislation in Sacramento which would have an impact on cities. Simonsen made a motion at the GTLR committee to adopt a policy opposing legislation which prevents CalPERS from their fiduciary responsibility to make wise investments that receive the highest returns on investment. The policy was unanimously approved.

RECREATION UPDATES:

- On Saturday, the Antioch Water Park opened for swim lessons and water aerobics. the park was full of excited swimmers. *COME SPLASH WITH US!!*
- On Sunday, the first lifeguard class was completed. A total of nine new lifeguards were certified and will be working at the Water Park beginning with training this spring.
- On Monday, the Antioch Council of Teens met and discussed upcoming April events. ACT is conducting a book drive that started on March 30th and will end April 30th.
- Over the weekend, the Antioch Community Park softball complex hosted the annual Antioch High School Girls softball tournament. 22 teams from the local area including Antioch, Pittsburg, and Brentwood as well as teams from Granada, Livermore, and Castro Valley participated in the 3-day event. In the JV tournament Freedom high beat Heritage High and on the varsity side, Granada High was crowned champions as they defeated Castro Valley High.
- Group ***fitness classes at the Antioch Community Center are on the rise!*** Over 253 participants so far have registered for Recreation Fitness classes with an additional 223 drop-in participants. Some groove to the Latin beats in Zumba fitness, others join the stress relieving relaxation of Yoga, and some use Strength Training classes to increase bone density and control weight. The type of exercise depends on each individual, but the common goal for all participants is the desire to stay fit, connect with community, and enjoy life!
- This week, a targeted interactive e-mail blast went out to residents promoting recreation classes and programs that start the week of May 1st.
- Staff began the editing process for the May/June newsletter and will continue until April 14th when the newsletter will be sent for printing.
- On Tuesday, staff attended the Antioch Senior Citizens Club Board of Directors meeting. Topics of discussion included the upcoming Senior Picnic on May 19th;

Mothers day on May 12th; Fathers day on June 16th; and a variety of scheduled educational seminars designated for mature adults.

- Over the last week, 382 affordable, healthy meals were served through the CoCo Café. This program helps prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the CoCo Café. All supplies are provided by the County for participating cafés.

Grid Alternatives – Staff visited a site installation at a homeowner’s property this week. There are currently 5 low income homeowners in the pipeline to receive free solar through this program.

Own Your Streets oil recycling outreach grant - Staff is working on the progress report that is due on April 20th and the reimbursement requests for this project.

School Eco-Outreach

- 1) On April 5th, staff attended the last Mr Eco assembly to be held in Antioch this school year and met with Mr Eco to discuss plans for next school year.
- 2) Staff is partnering with 511 Contra Costa to hold a school carpool outreach effort at Antioch High School’s open house for incoming freshmen and their parents on April 6th.

Community Development Block Grant (CDBG):

The Council CDBG Subcommittee will conduct the first of two days of agency interviews this Friday, April 7th. Sixteen (16) applicants in the categories of senior services, youth services, and economic development activities will highlight their programs, need, and accomplishments and respond to questions from the Subcommittee and consultant.

Interviews will conclude on April 21st with 14 agency program interviews in the categories of homeless services, housing programs, fair housing and tenant/landlord services, and infrastructure. This grant cycle covers the three year period of 2017-18, 18-19, and 19-20, with renewal of funding for agencies that are satisfactorily meeting their goals and in compliance with regulations, based on availability of funds.

The Subcommittee will not make final recommendations for funding until the City receives confirmation of the allocation from HUD. This remains delayed due to the ongoing federal budget issues, with the current FY 16/17 budget under continuing resolution until the end of April. HUD has instructed subrecipients to NOT submit our Action Plans until after the notice of funding is received, which is likely to be after the start of the fiscal year. Subcommittee recommendations will not be published until final deliberations are held after HUD announces the City's final funding amount. They will then be published for the required 30-day public comment period and brought to Council after that requirement has been fulfilled.

Housing:

Reports - The 2016 (calendar year) Housing Element Report and the FY 2015-16 Housing Successor Annual Report were submitted to HCD by the April 1 deadline and will be brought to Council on consent 4/11/17.

Affirmatively Furthering Fair Housing (AFFH) – The draft Analysis of Impediments to Fair Housing Choice (AI) for 2016-20 will be available for 30-day public review in the next few weeks, and will be brought to Council for review and adoption with the 2017-18 CDBG Action Plan. The AI is a countywide document which will be submitted to HUD after adoption. Each jurisdiction receiving CDBG funds is required to address impediments that impact the ability of households to have choice in their housing free from discrimination. The actions taken by the jurisdiction is reported in their annual performance report to HUD.

HUD changed the scope of this analysis two years ago with the adoption of the new AFFH rule, which is more far-reaching. The new required report, called the AFFH instead of the AI, is due for the Contra Costa Consortium in 2019 for the 2020-2025 timeframe. The cities of Antioch, Concord, Pittsburg, Walnut Creek, and the urban Country (including Richmond) is banding together with the Housing Authorities of Contra Costa, Pittsburg and Richmond to produce the new report. The entities have been meeting, developing the MOU, RFP and scope of work, and a draft timeline. An RFP for a consultant to research data, write the report and conduct public outreach is expected to be issued next week.

Fair Housing and Tenant/Landlord Counseling FREE - The City of Antioch contracts with Bay Area Legal Aid (BayLegal) and Echo Housing is their partner with an office in Antioch. If anyone suspects that they have been discriminated against, or has questions about the legality of something that a landlord is doing, they can call Echo Housing toll-free at 855-275-3246.

Mobile Home Subsidy - Housing continues to receive calls from Vista Diablo Mobile Home Estates about the rent subsidy ending in September. Currently, 81 lower income senior households receive a subsidy of \$75.32 per month, per a contract with the owners of the property that was initiated before the closure of all Redevelopment agencies statewide. Neither CDBG nor Redevelopment funds are available to continue the subsidy:

- CDBG funds **cannot be used to provide long-term rental subsidy** as this is not permitted by federal regulations.
- The Housing Successor balance **will reach near ZERO next year**, except for the few housing loan repayments that we sporadically receive.

Drought Updates:

Registration for the Sunday, May 7, 2017 [Bringing Back the Natives Garden Tour](#) is now open! This year's tour will fill quickly; [register now](#) to reserve your place. Forty one [bird and butterfly-friendly, pesticide-free, water conserving, low maintenance gardens](#) that contain 60% or more native plants will be open on Sunday, May 7, 2017, from 10 a.m. to 5 p.m. at various locations throughout Alameda and Contra Costa counties. Twenty-five of these gardens have not been on the Tour before. More than fifty garden talks will be offered throughout the day.

PUBLIC WORKS UPDATES

Engineering & Development Services

- Aviano, a 533-unit housing development by Aviano Farms, located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff is reviewing Phase 1 (3rd submittal) construction documents and plans. Staff returned comments to offsite sanitary sewer improvement plans.
- Heidorn Village, a 117-unit housing development by Mission Peak Homes, located on 20.3 acres west of Heidorn Ranch Road and north of the eastern terminus of Prewett Ranch Road: The developer submitted final map and improvement plans for review.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The developer is grading the site and installing underground utilities. Staff approved model home plot plans for building permit issuance.

Capital Improvements Division

- Downtown Sanitary Sewer Rehabilitation: A-S Pipelines, Inc. is constructing new sanitary sewer manholes and repairing and replacing deteriorated sewer service laterals on West 5th and West 6th Streets.
- Zone I Transmission Pipeline Rehabilitation at HWY 4 in the D Street area: Staff is reviewing project material submittals. Construction is expected to commence later this month.
- Water Treatment Plant Disinfection Improvements: Bids of this work were publicly opened on March 21st. The apparent low bid was submitted by Anderson Pacific Engineering Construction, Inc. of Santa Clara in the amount of \$2,598,918. The award of this construction contract is scheduled to be considered at the April 11th City Council meeting.
- Community Development Block Grant Downtown Roadway Pavement Rehabilitation: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for May 2nd at 2:00 p.m. in the City Council Chambers located at 200 'H' Street.
- Retaining Walls Rehabilitation: The contractor completed the retaining walls project on Contra Loma Boulevard and James Donlon Boulevard. The project is scheduled for final acceptance by the City Council on April 25, 2017.

Water Treatment Plant

- The chloride levels in the San Joaquin River have continued to stay low. We will continue to pump from the river as long as we continue to experience high water quality.

Water Distribution

- Responded to 163 stops for water service including disconnections.
- Had a total of 69 USA tickets completed for utility location.
- Replaced a leaking 1" water services on Crown Peak Wy, G St. and Iglesia Ct.
- Repaired an 8" water main on Dimaggio Wy.
- Installed two 24" bell joint repair clamps on D St.

Public Works Operations – Parks and Landscape

- Playground and Park Safety Inspections: Completed at Harbor, Hillcrest, Knoll and Marchetti Parks. Follow-up inspections were completed at Mira Vista Hills and Village East Park.
- Park Irrigation: Spring irrigation checks have started and watering has begun at City, Contra Loma Estates, Eagleridge, Fairview, Jacobsen, Mira Vista, Markley Creek and Marchetti Parks.
- Park Tree Removals: Two tree removals were completed at Deerfield and Hillcrest Parks.
- Trim Crews: Country Hills Dr. and Mira Vista Ct.

- Spot Spray: Dallas Ranch Rd., Prewett Ranch Dr., the Police Department and E. 18th St. rights of way.
- Weed Abatement: Lot along the A St. extension, lot next to Hillcrest Ave. pump station and the hillside along Via Dora Dr.

Public Works Operations – Street Maintenance

- Replaced 64 existing signs due to poor reflectivity or line of sight.
- Filled 77 potholes.
- Picked up 20 yards of debris in the roadway and at illegal dumping sites.

Public Works Utilities – Collections Division

- Calls for Sewer Service: Received and responded to 12 calls for service from the public. Televised 420 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Repair/Preventative Maintenance: Daily preventative maintenance performed on over 27,453 linear feet of sewer main lines. Crews also repaired two severely damaged laterals requiring immediate repair.
- National Pollutant Discharge Elimination System (NPDES): Removed 29 yards of household and green waste in various creeks and channels. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways.
