RECREATION UPDATES

- On Saturday, Recreation staff assisted with "Keep Antioch Beautiful Day" by hosting sites and collecting the large bags of trash from various check-in sites.
- Registration is now open for all summer recreation programs including youth camps, swimming lessons, pre-school, dance and gymnastics, arts and sports programs.
- Last week, more than 250 youth registered for the 2016 Jr. Giants summer baseball program. Volunteer coaches are needed, and there is space for more youngsters to participate. Check the Recreation Guide for more information.

- Last week, staff conducted the final Lifeguard Course being offered this spring.
 Class enrollment includes 22 new lifeguards and current swim instructors being cross-trained to streamline staff costs.
- **BE COOL BY THE POOL** this year and purchase your annual water park pass before the fees increase! For only \$50 per person you and your family can beat the heat, keep kids busy, and stay fit and healthy all summer.
- Water Park buyouts are selling fast 19 private buyouts are confirmed! You can rent the water park for your group or business to celebrate a memorable occasion.
- Recreation staff is busy fielding questions about group tickets and birthday parties.
 The Water Park has already received 25 group ticket reservation applications.
- Last week, staff purchased the Water Park season refillable drink cups. The special cups sell for only \$7 at the concession stand and come with free refills on the day of purchase and \$1 refills all summer.
- Last week, staff began working with the webmaster to update the Water Park website. It should up and running with a brand new exciting look by May 1st!
- The Antioch Water Park continues to receive volunteer applications from teens ages 12-15. There are 7 students on track to assist at the Antioch Water Park this summer. The first volunteer program orientation is set for late May.
- On Thursday, staff worked with Contra Costa County Environmental Health to finalize plans for concrete renovations at the Tad Pool.
- Last week, the City contract landscape maintenance company added new landscaping to Prewett Community Park and inside the Water Park.
- Last week, staff assisted the spray park and playground contractor with various tasks needed to help them continue with the construction.

Senior Center Services

- Last week, 438 affordable healthy meals were served through the C.C. Café; an increase of 40 over last week. Lunch and socialization help prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the C.C. Cafe. All supplies are provided by the County for participating cafes. Staff collects the daily nutrition deposits and submits them to finance.
- On Monday, staff met with a new potential Spanish class instructor and continually looks for new classes and experiences for the Senior Center.
- On Wednesday, more than 30 seniors joined the Lions Center for the Visually Impaired to receive free eye screening services. The program provides senior citizens with detection of age related eye disease exams, and provides valuable information about low or no cost eye care services.
- Last week, staff met with Antioch Marina staff to assist them and provide tables and chairs for the Marina Open House scheduled for Saturday, April 30th.
- On Thursday, the May/June edition of the Senior Newsletter was delivered to the post office for mailing to members. It is now available for pick-up at the Senior Center.

 To date the Senior Club has received new and renewal membership applications from 803 seniors. Membership is only \$20 for the year; sign up friends and family who enjoy meeting new friends and staying active and healthy.

- Jeff Gallegos, Code Enforcement Officer, applied for and received a scholarship to attend the Advanced Environmental Crimes Training Program at the California Specialized Training Center at Camp San Luis Obispo, presented by the United States Environmental Protection Agency, Criminal Investigation Division. The scholarship covers the entire cost of the two-week training, including meals and lodging. The City is very proud of Jeff for pro-actively seeking out this opportunity and for his acceptance into the program. This training will surely be another asset to the City of Antioch.

 Code Enforcement Abatement Team has become proactive in cleaning up blight & rubbish on City right of ways and City property.

Environmental Resources:

Environmental Enforcement: April 21-27 – 24 actions were taken this week. Deadlines for the current pending abatements are April 27, and there are roughly 70 properties that we will be either abated for garbage service or close the case this Thursday.

This was a great team effort that included staff and volunteers from Community Development, Public Works, Recreation and the Police Department.

Eco-Happenings:

• The City of Antioch is now hiring 3 summer interns in our Used Oil Recycling Grant program. Do you want to make a difference in your community? The cities of Antioch, Pittsburg and Brentwood are looking for a team of passionate and determined student interns to help run a local campaign to increase used motor oil and filter recycling rates within your community. This internship is an excellent opportunity to develop your leadership, marketing, web design, and communications skills while making a positive impact within your community and the environment at large. Interns will be required to complete a one month training period during the month of May with the internship's official start date of June 1, 2016 through September 1, 2016. This is a part-time internship, with approximately 10 hours of work per week. The total amount of hours worked cannot exceed 300 hours. Compensation will be paid at the hourly rate of \$10/hour. The majority of work will be completed remotely, with regular in-person meetings and occasional

CDBG:

- The 2016-17 Action Plan will go before the City Council May 10th.
- Work is ensuing to input the Action Plan into the IDIS HUD computer system. This
 is the first year that the Action Plans, CAPERS and Consolidated Plans are linked
 and new reports are to be produced from the HUD system.

Housing:

- Satellite "Tabora Gardens" development is heating up as the City reviews draft plans, finalizes all funding and readies documents for loan closing in June or July. Many details, such as compliance with Davis Bacon Wage Rates, State Prevailing Rates, Section 3 compliance, monitoring on all federal requirements and more are being discussed with the developer and County, which is a major funding partner.
- Housing Consultant continues to enter additional information on each loan to complete all fields of new Housing Loan monitoring system by CDS.

Homeless:

- The Antioch Suburban Poverty Task Force met to receive updates on changes experienced by the closing of the East County Multi-Service Center and outreach team, ending of the Contra Costa Homeless Outreach team, and the departure of Ryan Graham. Michael Aguirre and Teri House brought those attending up to speed, and also asked for feedback on the impact of the above changes in the Antioch homeless population and city streets.
- A series of workshops to design the new Coordinated Entry system for all homeless services in Contra Costa County has been occurring. Prevention and Diversion was the first topic, and Crisis Services was the subject of the second meeting. The third

workshop will be around Permanent Housing and Diversion (May 4, 9-12:00 p.m.) and the final workshop is on Implementation (Wed May 11th, 9-12:00 p.m.). Attending are provider agencies in the homeless continuum of care. If you are interested in learning more about these meetings, please call Teri House, Chair of the Homeless Advisory Board, at 925-779-7037.

Drought Updates:

In March, Antioch Water Customers used 35% less than in 2013. Great job everyone! This takes our cumulative total to 30.18% since last summer. Our State mandated reduction goal was reduced from 28% to 27% moving forward, so keep up the great work and remember as we move into spring the following prohibitions:

- a. Watering of outdoor landscapes in a manner that causes excessive runoff such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures
- b. Watering of outdoor landscapes during and up to 48 hours after measurable rainfall.
- c. Watering of outdoor landscapes more than three days per week as follows:
 - Even addresses assigned days to irrigate are Tuesday, Thursday, Saturday
 - Odd addresses assigned days to irrigate are Wednesday, Friday, Sunday
 - Watering of outdoor landscapes during the daylight hours of 9:00 am 5:00 pm.
- d. Washing a vehicle, trailer or boat using a hose without a shut off nozzle.
- e. Washing paved or other hard-surfaced areas, including sidewalks, walkways, driveways, patios, and parking areas.
- f. Use of water for non-recirculating decorative fountains or filling decorative lakes or ponds.
- g. Using a hose without an automatic shutoff nozzle.
- h. Failing to repair a controllable leak.

Hopefully there will be some late spring rain to help us keep our water use down and continue to fill our reservoirs. If you are wondering if we have received "measurable rainfall' in regards to the no irrigation rule above, visit: http://gismap.ccmap.us/FloodControl/gmap/gmap.html.

Spring Irrigation tips:

If you haven't already done it, inspect your irrigation system to make sure nothing has broken over the winter. Early Spring is a good time to plant new plants. Visit contracosta.watersavingplants.com/ to find the right water saving plants for your yard! It will give them time to become established before the heat of summer is upon us.

In May, water lawns 3 days/week, and shrubs 2 days/week.

Last Week's Irrigation Repairs and Service:

• Parks Citywide: All City Parks are now watering.

- Dallas Ranch Park: The drinking fountain did not shut off Saturday, necessitating closure of the men's restroom until repairs could be completed on Monday.
- Delta Diamond: The baseball field turf is in process of renovation. Delta Diamond remains closed to use.
- Community Park: A 6" irrigation main-line was repaired. Irrigation water was off during repairs.
- Markley Creek Park: The dog drinking fountain stuck on last Saturday, repairs to the fountain are now complete.
- Mira Vista Hills Park: 2 broken turf sprinklers were replaced.
- Lone Tree Way: 1 irrigation valve rebuilt and 1 mainline repaired.
- Hillcrest Ave.: 25 sprinklers repaired.

PUBLIC WORKS UPDATES

<u>Administration</u>

- Contra Costa Water District (CCWD) announced that they have signed a settlement agreement with the California Department of Water Resources (DWR), which according to CCWD will "protect its customers, facilities, and operations if the Bay Delta Conservation Plan/WaterFix (CWF), aka the 'twin tunnels', is built." The March 29th CCWD News Release also states, "The agreement is an insurance policy to protect the unique water quality and supply issues raised by CCWD". As a result of this settlement, CCWD has withdrawn its protest of the DWR Petition to Change Diversion locations proposed as part of the CWF. The documents related to this settlement are posted on the CCWD website http://www.ccwater.com/317/Bay-Delta-Conservation-Plan-Comments. The CCWD Board of directors held a meeting on April 6th to explain the details of the agreement and respond to questions from the public. They have also mailed out a letter to each customer explaining the settlement. Antioch residents will receive a copy of the letter as we purchase our raw water from CCWD before treating it and distributing to our customers.
- February 2016 brought us to the end of the initial water conservation mandate issued by the State of California. The City of Antioch was required to conserve 28% based on 2013 usage through the month of February 2016. Thanks to your outstanding efforts, our total cumulative reduction since July 2015 is 29.78%. At the end of January 2016, the State extended its mandatory conservation order through October 2016. Final guidance is still being worked out as the State monitors the snow pack and reservoir levels through this winter. Please continue to conserve this valuable resource and plan on conserving throughout 2016. Outdoor water conservation will be the primary focus of the City's program, as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th, 2015. All Antioch customers were mailed a letter explaining the program and prohibitions, as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 a.m. and 5:00 p.m., shut off nozzles required on

all hoses, and drinking water available only upon request at restaurants. Contra Costa Water District has incentives, such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. More information on water conservation programs and ideas on how to conserve water can be found at www.ccwater.com or www.antiochwater.com. Customers who are not in compliance with drought restrictions can be reported to the Antioch Drought Hotline at (925) 779-6140.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction and provided a punch list for offsite improvements (for bond reduction purposes).
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: CVS and Grocery Outlet stores are open for business and other building pads are in development and planning stages. Environmental clearances and USBR permitting requirements for the Phase 2 development are in progress. Staff is processing a request for reimbursement for Somersville Road widening and bond release for Phase 1 improvements.
- City-owned cell sites, various locations: Staff is performing site visits and review of land leases, 100% construction drawings, consent letters, photo-sims and related technical reports and materials for equipment upgrades and site modifications.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: Staff is reviewing the final development plan and preparing project conditions of approval.
- Nelson Ranch Subdivision 6893, end of Wildhorse Road: Staff performed a site inspection and provided a punch list in response to the developer's request for release of the warranty bond.
- Olive Groves Subdivision, a 263 single-family detached senior housing units with assisted living facility, commercial uses and open space. Residential portion gated with private streets. Staff is preliminarily reviewing the PDP-16-01 application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The subdivision plan and map checks have been completed. A benefit district is being reviewed by staff.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project has been accepted by the State. The eastbound Contra Loma Blvd. onramp is closed temporarily for SR4 mainline construction.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Work continues on the 'A' St./Lone Tree Way interchange and the Cavallo Road overcrossing and the new Sunset Drive from Bryan Avenue to "A" Street extension. Slope paving and sidewalk reconstruction is underway. Staff is working with Caltrans to remove blight from the parcel located at

the end of the A Street westbound off-ramp. The left-hand turn from westbound Bryan Ave. to southbound A St. has been permanently closed to traffic due to construction of a new raised median and signalized intersection at Rossi Avenue and A Street. Lane closures are ongoing in the northbound and southbound directions of A Street between SR4 and Rossi Avenue, from 9:00 a.m. to 3:00 p.m. in the northbound direction and 8:00 a.m. to 2:00 p.m. in the southbound direction. Pedestrians and motorists are advised to exercise caution while travelling through these areas.

- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Work continues on the Hillcrest Avenue Bridge widening, the Pedestrian Overcrossing (POC) and the Maintenance of Works (MOW) Tunnel. The new Slatten Ranch Road westbound (WB) loop on-ramp is open to traffic and the Hillcrest WB on-ramp is temporarily closed for construction. There will be lane closures on Larkspur Drive in the eastbound and westbound directions between Hillcrest Avenue and Wildflower Drive, Monday through Friday, from 9:00 a.m. to 3:00 p.m. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a
 proposed 12" sanitary sewer main from the new Maintenance Facility, north of the
 S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing
 grant deeds for public easement dedications. Staff returned comments to BART's
 Ownership and Maintenance of Utilities Agreement for storm drainage
 improvements.
- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: First phase of construction documents submitted. Returned 2nd plan check comments for revision.
- Working with consultant on finalizing sewer study for FUA 1.
- Working on creating Community Facilities Districts for FUA 1.
- Tabora Gardens: Senior apartment complex on James Donlon Blvd. and Tabora Drive. Returned 2nd plan check comments for revision.
- Child Care Education Building in Williamson Ranch Plaza: Plans submitted for 1st review.

Capital Improvements Division

- Country Hills Drive and Vista Grande Drive Water Main Replacement: A-S
 Pipelines, Inc. has completed exploratory excavation of existing underground
 utilities on Vista Grande Drive between Lone Tree Way and Country Hills Drive.
 Installation of the new water main will begin next week.
- Marina Boat Launch Facility Restroom: This project is scheduled to be considered at the California Department of Parks and Recreation, Division of Boating and Waterways (DBW) Commission meeting on May 11th. Staff conducted an onsite meeting with DBW, Staff and Commission members on April 26th to discuss the project.

- West Antioch Creek Channel Improvements: Purchase agreement documents are being executed between the City and the Twenty-Third District Agricultural Association for right of way and easements within the footprint of the Contra Costa Fairgrounds. Contra Costa Real Property Division continues to negotiate the purchase of property and easements located at 1400 and 1420 West 10th Street. U.S. Fish and Wildlife is continuing to review the project's Biological Assessment.
- Water Treatment Plant Electrical Upgrades: TJC and Associates is finalizing electrical improvement recommendations and proposed project phasing.
 Associated Power Solutions will be adjusting electrical breaker settings in the near future. The arc flash hazard assessment is expected to be finalized next month.
- Brackish Water Desalinization Plant: Carollo Engineers is acquiring and reviewing existing water quality information and evaluating the water intake facility. State Water Resources Control Board is reviewing the City's State Revolving Fund loan application.
- Urban Water Management Plan: West Yost and Associates is updating their draft Urban Water Management Plan to include comments and recommendations provided by Staff.
- North East Annexation Infrastructure Improvements: Staff is reviewing a proposal for consulting services from BKF Engineering to provide engineering services and to prepare preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve the recently annexed Area 1 and 2B.
- 2016 Pavement Management Program: Staff is soliciting bids for a \$2.6 million asphalt pavement roadway rehabilitation project. This project includes major arterial streets, such as Lone Tree Way, James Donlon Blvd., Somersville Road, Buchanan Road, Golf Course Road, Hillcrest Ave. and various residential streets north of HWY 4. Marina boat ramp improvements are being added to the project. The construction is expected to start in June 2016 and be completed by September 2016. Project documents are available for purchase at a cost of \$50 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for May 10th at 2:00 p.m. in the City Council Chambers located at 200 "H" Street.
- 2016 Transportation Development Act (TDA) Grant: The City received \$70,000 of TDA grants from MTC for the Pedestrian and Bicyclist Improvements project, which will include construction of sidewalks, curb and gutter and bike lanes along Carpinteria Drive from Barmouth Drive to Garrow Drive. The project areas are being surveyed and design will begin shortly. Construction of the project is scheduled to start in August 2017.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to finalize the land use forecasts, the transportation improvement list, the network to be used in the traffic model, and proposed fee. The final draft Fee Study will be presented to the City Council for public review and comments in May 2016.

- Prewett Water Park Improvements: The contractor mobilized on site and started the construction work for the spray ground and the playground facility. Both projects are scheduled to be completed in September 2016.
- 2016 Capital Improvement Program: Staff is working on the draft 2016 CIP budget and the five year program. The draft CIP will be reviewed by the City Council on May 10th and by the Parks and Recreation Commission on May 19th.

Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower.
- Completed installation of additional communication panels and wiring at the Hillcrest tank and linked the signal to the water plant.
- Installed cables for the sun covers at "B" plant basin. Waiting on material to complete the work.
- Water quality in the river continues to be good. We will continue to operate the river pump until the quality degrades.
- Water demand within the city is starting to pick up, which will require us to pump from the canal to supplement the city's water needs as the river pump cannot pump enough water for all of the city's water.

Water Distribution

- Water Distribution staff had 203 stops for water service including disconnections.
- Water Distribution staff had a total of 57 USA tickets completed for utility location.
- Water Distribution meter reading has started for the month of April and is now complete.
- Water Distribution staff issued two drought notices issued this week.
- The State Water Board has Extended Emergency Water Conservation Regulations through October 2016.
- Water Distribution staff continues to monitor water meters, conservation and usage at all City buildings and parks.
- Water Distribution staff continues to respond to drought hotline inquiries.
- Water Distribution staff responded to customer calls regarding water maintenance issues city wide.
- Water Distribution staff repaired an 8" water main on Cavallo Rd.
- Water Distribution staff replaced a 3" meter and backflow at the water park.
- Water Distribution staff put a fire hydrant back in service on Third St and one on Putnam St.
- Water Distribution staff replaced a 1" water service on Brookhaven Dr.
- Water Distribution staff continues State mandated annual backflow testing.
- Water Distribution staff performed preventative maintenance on fire hydrants city wide.

- Water Distribution staff hauled off green waste for recycles, as well as cleaned up debris at the city's Fulton yard.
- Central Stores staff cleared debris, graffiti and household items from Fulton Shipyard Rd. boat ramp area.
- Central Stores staff cleared debris and graffiti from Amtrak platform.
- Central Stores Lead and Deputy Director of Public Works completed the review of Public Works purchase orders to renew for Fiscal Year 2016/2017. This has been sent to Finance for issuance.

- Sewer Mains: Daily preventative maintenance performed on over 29,142 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the 'hot spots'.
- Sewer Lateral Maintenance Program (SLMP): Repaired a lateral that was severely damaged requiring immediate repair and televised 11 laterals.
- Manhole Inspection Program: Crews inspected 124 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of "SMART Manholes" in strategic areas will be utilized that will alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 1,520 feet of sewer main lines.
 The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and SSOs.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 5.7 yards of trash and debris, five shopping carts, one mattress, and two couches, from various creeks and channels. Sprayed .2 acres and weed abated 2.4 acres of entry way access to channels. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.
