INCIDENT AT PREWETT WATER PARK

As you know, the Antioch Water Park closed at approximately 2:30 on Thursday, June 18, 2015 in response to a chemical malfunction in one of the five pools. All guests were escorted safely from the facility and individuals that did not feel well were treated on site or transported to local hospitals to err on the side of caution.

Parks & Recreation Director Nancy Kaiser and her staff did a great job handling this incident. They were the first responders. They made decisions quickly. They removed the kids from potential danger and got the help they needed from CC Fire. When I got there, I saw no chaos or confusion. Contra Costa Fire had incident command and they, along with EMTs, CHP and Antioch PD were terrific. When Chief Cantando and I arrived and were briefed by Nancy, CC Fire, etc., it was clear that everyone was communicating, working as one team and had the situation in hand.

Nancy will be advising as to when the Water Park will be open for business. We are shooting for tomorrow; but safety always comes first.

RECREATION UPDATES

- Last week, the Coyote Hills Summer Day Camp program began. The first camp session has 49 elementary age children playing and learning, and making new friends!
- Over 34 students, ages 5-13 years, enrolled in the first session of summer art classes last week. Kids exposed to the arts develop their right brain as much as their left, and both hemispheres work in tandem, thus achieving the full potential of the mind. Art also helps students practice problem-solving skills, critical-thinking skills, language and vocabulary.
- Last week, staff distributed postcard flyers throughout the community for the upcoming Adventures in Fun and Fitness Summer Drop-In Park Program for children 1st -6th grade. This new program will be held at City Park & Contra Loma Estates parks beginning July 14th and is proudly sponsored by Kaiser Permanente and the City of Antioch. Adventures in Fun and Fitness features fun fitness activities, nutrition education and arts & crafts in a supervised environment.
- The first week of Antioch's Junior Lifeguard program was held at the Antioch Water Park this week. Twelve teen participants learned the basics of water safety; they all received certifications in pediatric CPR as part of this week's curriculum.
- On Thursday, the first session of summer swim lessons concluded. The second session starts on Monday and classes are full to capacity.
- Last week, the recreation maintenance team completed various preventive services including monthly fire inspections, periodic chemical feed system services, and monthly AED inspections for the Water Park and Antioch Sports Complex.
- Last week, the Adult Softball program reached the halfway mark in league play. Teams are enjoying a perfect summer of baseball with an abundance of health and fitness time.
- Junior Giants ball players had a successful First Pitch meeting last week. Antioch Prewett Library offered a children's family event – Cascada de Flores, a rhythmic dance and singing group exploding with song, ancient musical instruments, polyrhythms and sweet characters of Mexican music and dance. The amphitheater was filled with families and smiling children!
- On Thursday, the Parks and Recreation Commission held their regular meeting; presentations on the Five Year Capital Improvement Plan and Senior Services were provided by City staff.

Senior Center Services

- Last week, 453 affordable healthy meals were served through the C.C. Café nutrition program. No membership or income requirements are required to eat at the C.C. Cafe.
- Staff administered the ongoing process of enrolling participants into the FY 2015/2016 CC. Café Nutrition Program by assisting with C.C. Café Meal Participant Confidential Form.

- Staff provided front line assessment and direction to participants to appropriate county, regional and local services for senior housing, brown bag services and senior nutrition programs.
- Last week Free Will's program was provided by Contra Costa Senior Legal Services. Five senior participants were provided direction and assistance on establishing a will or trust (a value of \$300 per person).
- Staff acted in their role as first responders for an emergency situation at the senior center until emergency services arrived.
- Last week, staff tracked 18 memberships that renewed last week for the 2015 Antioch Senior Citizen's Club.
- Staff prepared the NRCC multipurpose room in preparation for the Special meeting of the Antioch City Council/Planning Commission/Economic Development Commission Study session on the downtown specific plan.
- Last week, 157 senior participants engaged in exercise classes and programs that
 promote mobility, help lower blood pressure, and reduce the risk of injury and many
 degenerative diseases. This was an increase of 14 participants from the previous
 week.
- Thirty one seniors participated in painting classes and arts & craft classes that help
 to restore and motivate muscle memory, improve cognition and focus attention,
 provide mental stimulation, and leads to self expression and self discovery while
 enriching relationships and socialization for senior members of the community.
- On Friday, the second session of a 4 part nutrition and exercise seminar was held.
 The course is titled Eat Smart, Live Strong and educates participants on smart food
 choices and exercise techniques. Staff coordinated with Meals on Wheels and
 Senior Outreach Services to provide this free seminar to seniors in the Antioch
 community. This 4 part session will continue every Friday in June. Sign up today at

- On Friday, seniors enjoyed the monthly movie mania day, a wonderful gathering for socialization and providing a fun and safe outing for seniors to enjoy a movie and treat with

- Training Code Enforcement Staff attended training in San Ramon for "Multi Agency Response".
- Downtown Continuing to conduct follow up's with homeless camps in the downtown area.
- Wildflower Homeless camp served a 72 hour notice for removal of camp and accumulated trash. The occupant of the encampment removed all belongings and trash.

Environmental Resources

Drought updates:

- Drought FAQs and a few other updates to the website were completed this week.
- Staff has been using the FAQs as a template for responding to the emails received from www.antiochwater.com. This week there were roughly 5 emails.
- Staff met with Public Works staff to address city landscaping issues and drought outreach. Look for our new consolidated drought activities section in these weekly updates soon!

<u>Environmental Enforcement</u>: June 11-17, there were over 122 actions taken. We are working on a new batch of properties without garbage service and have 177 active cases at this time. 20 property owners were mailed courtesy notices reminding them that their abatement period had ended and that service needed to be established. 46 properties were visited to verify occupancy in preparation for abatement notices. 26 abatement notices were mailed out. 6 cases were closed; and 1 citation was issued for a property without garbage service.

Eco-Happenings:

• The Hero Program is available to Antioch residential property owners. This is the final PACE program to go online since the city opted in to PACE programs in December 2014.

CDBG:

- Revision of contract goals and budgets is underway with agencies, now that they
 have been informed of their funding. Contracts are being generated for return in
 July.
- CDBG sub-recipient training for all jurisdictions was conducted June 11th and attended by about 200 agency staff from all over the County. The City of Richmond joined with the Consortium to host the event, for the first time in about four years. Bob (Robert) Calkins, CDBG manager for the County, announced his retirement to occur at the end of June. Gabriel Lemus will be taking his place after working with the CDBG program for over 10 years.

Housing:

- Interviews and product testing are still underway for housing compliance and monitoring software systems for Housing Successor and CDBG loans, both single and multifamily.
- Review and reorganization of all multifamily housing files is underway. Monitoring
 of Housing Successor assets will be conducted July December to verify income
 and/or occupancy for all first time homebuyer loans, homeowner rehabilitation
 loans, and multifamily/rental properties, excluding Vista Diablo, which was
 monitored in October 2014.

Homeless:

- Zero: 2016 core partners and interested community members will have the opportunity to be coached by Nate French, Contra Costa County's assigned Coach from Community Solutions, on Thursday June 25th at the County Homeless Program conference room in Martinez.
- The Contra Costa partnership for Zero: 2016 has been invited to submit a grant proposal to the Long Foundation of \$300-500k to help critical infrastructure to help increase housing placements for extremely low income persons.

PUBLIC WORKS UPDATES

Administration

- In response to the most severe drought in California's 164-year history, Governor Brown has mandated urban water users to reduce water consumption by 25% statewide. The City of Antioch is being required to reduce its 2015 water usage by 28% in 2015 using 2013 as the base year. Outdoor water conservation will be the primary focus of the City's program as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th. All Antioch customers will be mailed a letter explaining the program and prohibitions as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 am and 5:00 pm, shut off nozzles required on all hoses and drinking water available only upon request at restaurants. Contra Costa Water District has incentives such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. Customers who are not in compliance with drought restrictions can be reported to the Antioch Drought Hotline at (925) 779-6140.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Caltrans' full closure of the Lone Tree Way/"A" Street undercrossing to perform bridge demolition work has been rescheduled for Saturday-Sunday, June 27-28. Additional changeable message board signs (CMS) will be placed along northbound Lone Tree Way to alert motorists traveling north on 'A' Street to take alternative routes prior to the road closure. Eastbound bridge foundation work at Cavallo Rd. undercrossing is ongoing. Pedestrians and motorists are advised to exercise caution while travelling through these areas.
- Contracts for several roadway maintenance projects have been awarded recently and detours and lane closures should be expected throughout the City. This work is necessary for the preservation of the road surface and to minimize the number of potholes in the future. A very large cape seal project is starting next week and will conclude in late July. This will impact many arterial streets such as Wilbur Avenue, E 18th Street, Deer Valley Road and Lone Tree Way as well as lower volume streets. The project involves placing a "chip seal" which is aggregate on a rubberized layer of liquid asphalt emulsion that will be rolled into place. Excess aggregate will be swept immediately after rolling to minimize loose gravel on the roads. Within two weeks following the chip seal, a slurry seal will be placed. This will be followed by permanent striping. Country Hills Drive between Deer Valley Road and Hillcrest Avenue and Cavallo Road between E 18th Street and Wilbur Avenue will be receiving an overlay during the same time period. This will have an impact on traffic when the work is being performed but the finished product will be well worth the detours and delays. We apologize for the inconvenience and ask that motorists please drive slowly and safely in the vicinity of the workers.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: Construction of improvements is ongoing. Phase 2 environmental clearance and USBR permit is in process.
- Cellular Providers on City-owned Property: Verizon is investigating new cellular installations at the City's Larkspur Dr. and James Donlon Blvd. water tank sites.
- City Sports Club, located at 5001 Lone Tree Way: Recordation of lot merger and sewer easement quitclaim deed and final plan check is in progress.
- Contra Loma Estates HOA Privatization: Contra Loma Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrances to their subdivision. Planning Commission and City Council approvals are required. Staff met with the applicant to discuss project conditions of approval.
- DeNova Homes Mixed Use Project at Hillcrest Ave./Wildflower Dr.: Application for mixed use project consisting of 9.5 acres commercial, 8 acres multi-family, and 2.2 acres single family development. Staff met with the applicant to discuss project conditions of approval.
- Golden Bow Estates HOA Privatization: Golden Bow Estates HOA has applied for a permit to privatize their interior roads and install security gates and fencing at the entrance to their subdivision. Planning Commission and City Council approvals are required.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: The developer is preparing a final development plan submittal.
- Nelson Ranch Unit 1 Subdivision 6893, a 102-unit housing development by Standard Pacific Housing, located northeasterly of Wild Horse Road and Ridgeline Drive and southwesterly of State Route 4: Release of bonds for garage sales office conversions and model home complexes are in progress.
- Oakley Knolls Subdivision 9353, a 31-lot development by Discovery Builders, located north of Oakley Road 1,300 feet west of Phillips Lane: Staff prepared conditions of approval for a tentative map application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Staff returned second map and plan check comments and prepared conditions of approval for landscaping plans design review approval.
- PG&E Lot Line Adjustment, located at the southwest corner of Somersville Road/Buchanan Road intersection: Staff sent lot line adjustment documents to the recorder's office for recordation.
- Taco Bell, 1706 'A' Street: Staff returned first plan check comments to the design engineer.

- Wilkinson-VanSandt LLA: Staff approved revisions to revised documents for a lot line adjustment between 4316 and 4325 Berryessa Ct.
- Viera Ranch Unit 2 Phase 3: Staff prepared a staff report for tract acceptance and is reviewing a CCWD (USBR) agreement for City-maintenance of two Delta De Anza Trail trailheads on CCWD property for City Council consideration.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project:
 'G' Street Bridge punch list and Contra Loma Blvd./'L' St. undercrossing work
 continues. Pedestrians and motorists are advised to exercise caution while
 travelling through this area.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Caltrans' full closure of the Lone Tree Way/"A" Street undercrossing to perform bridge demolition work has been rescheduled for Saturday-Sunday, June 27-28. Additional changeable message board signs (CMS) will be placed along northbound Lone Tree Way to alert motorists traveling north on 'A' Street to take alternative routes prior to the road closure. Eastbound bridge foundation work at Cavallo Rd. undercrossing is ongoing. Pedestrians and motorists are advised to exercise caution while travelling through these areas.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Slatten Ranch Road curb, gutter, sidewalk and paving is partially complete. Work on the pedestrian overcrossing, Hillcrest Avenue Bridge widening and the westbound offand on-ramp/Slatten Ranch Road signalized intersection is ongoing. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a
 proposed 12" sanitary sewer main from the new Maintenance Facility, north of the
 S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing
 easement documentation. Staff returned comments to BART's Ownership and
 Maintenance of Utilities Agreement for storm drainage improvements.
- Wal-Mart expansion: Processing easements and vacation of existing easements.
- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: Processing abandonment of existing easement.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The tentative map has been submitted and staff is creating conditions of approval.
- Aviano, a proposed 533 unit housing development located on Sand Creek Road west of future Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The revised tentative map has been submitted for review and staff is updating conditions of approval.
- The Ranch, a proposed 1,667 unit housing development located between Deer Valley Road and Empire Mine Road: Staff is preparing comments for preliminary development plan.

- Heidorn Village, a proposed 117 unit housing development located northwest corner of Prewett Ranch Drive and Heidorn Ranch Road: The tentative map has been submitted and staff is creating conditions of approval.
- Quail Cove, a proposed 32 unit housing, located south side of Prewett Ranch Drive west of Heidorn Ranch Road: The tentative map has been submitted and staff is creating conditions of approval.
- Lakeview Center, development of a new 11,598 square foot medical office building located at the corner of Lone Tree Way and Golf Course Road: Plans have been submitted for first review and have been returned with comments. Waiting for plans to be resubmitted for second review.
- Somersville Road, reconstruction of Somersville Road from the James Donlon Boulevard to Contra Costa Canal Bridge: Submitting staff report and resolution recommending the acceptance of Somersville Road at the June 23rd Council meeting.

Capital Improvements Division

- Williamson Ranch Plaza Water Main Replacement: D.R. Lemings is completing punch list items at Williamson Ranch Plaza.
- Community Development Block Grant Downtown Roadway Pavement Rehabilitation: MCK Services is adjusting utility frames and lids to street grade and installed pavement markings and roadway striping on West Second Street from 'J' to 'L' Streets, West Third Street, between 'I' and 'J' Streets, West Fifth Street from 'J' to 'L' Streets and 'K' Street from West Second and West Tenth Streets.
- Ninth Street Roadway Improvements: MCK Services is adjusting utility frames and lids to street grade and installed pavement markings and roadway striping on West Ninth Street between A and H Streets.
- Curb, Gutter and Sidewalk Repair Program: Anchor Concrete continued to remove and replace deteriorating, damaged and uneven concrete throughout the city. Over the past week a total of 297 square feet of sidewalk, 100 square feet of driveway approach and nine lineal feet of curb and gutter were repaired.
- Marina Boat Launch Facility, Third Boarding Float: Valentine Corporation is expected to provide material submittals and shop drawings. Work is expected to commence in early August in conformance with the required State of California construction permits.
- West Antioch Creek Channel Improvements: A Draft Lake and Streambed Alteration Agreement pertaining to the upper reach of the project is under review. A revised Routine Maintenance Agreement associated with the portion of the creek between West 10th Street and the river is expected next month. The U.S. Army Corps of Engineers has commenced the Section 106 consultation with the State Historic Preservation Officer.
- Sunset Booster Pump Station Replacement: City Staff has provided Kimley-Horn with a reviewed set of draft project Special Provisions. A revised document is expected later this month.

- Water Treatment Plant Disinfection Improvements: CDM Smith will be commencing feasibility studies and alternative analysis on various replacement disinfection processes at the City's Water Treatment Plant in the near future.
- 2015 Transportation Development Act (TDA) Grant: The City was awarded \$50,000 of TDA grant funding to install 35 new curb ramp locations along 'A' Street, Blue Rock Drive and West Tregallas Road. The project bid opening was held on May 19th and will be recommended for award at the June 23rd City Council meeting.
- Safe Routes to School Grant (Cavallo/Garrow/E. Tregallas curb ramps): J.J.R.
 Construction is under contract for the installation of 85 curb ramps and sidewalk
 improvements along Cavallo Road, Garrow Drive, East Tregallas Road and Drake
 Street. Construction began on June 15th and will be completed by August 15th.
- Transportation Impact Fee Study: Staff is working with the EPS consultant to update anticipated land uses and the transportation network to be used in the model. EPS is working on updating the City traffic model.
- Preventative Pavement Maintenance Program: MCK Services completed construction of the project. The City Council will consider the final acceptance of the project at the July 28th meeting.
- Cavallo Road and Country Hills Drive Pavement Rehabilitation: MCK Services is under contract to resurface Cavallo Road and Country Hills Drive. The contractor will be posting traffic detour or roadway closure signs during construction. Construction of the project started on May 26th and is expected to be completed by July 30th.
- Prewett Park Improvements: RHAA is under contract for the design of the final improvements at Prewett Park. The design process will incorporate new features into the Water Park, as well as new areas of play in the community park. At the June 9th Council meeting, RHAA presented the City Council the proposed improvement options and received council direction for the proposed options. Construction is anticipated to start in January 2016.
- 2016 Active Transportation Program (ATP Grant): MTC issued a call for projects for Bicycle and Pedestrian improvements projects. Staff submitted three grant applications for potential projects: Rivertown mobility improvements, Fitzuren Road pedestrian and bike improvements, and De Anza Trail Gap Closure.
- Capital Improvement Program (CIP): Staff completed the draft five year CIP document and it was presented to the City Council on May 12th during the budget study session along with the proposed CIP budget. The final document and public hearing will be presented to Council for adoption of the Five Year CIP at the June 23rd Council meeting. On June 18, staff will provide a presentation of the Five Year CIP to the Parks and Recreation Commission.

Traffic Engineering

 Staff has received several requests for information related to procedures to have speed tables installed on City streets. The requirements include but are not limited to: receiving 75% agreement from property owners affected by the proposed speed tables, speed tables complete with related signing and striping installed at no cost to the City, excessive speeding on the street to receive the speed table(s), written concurrence from the Antioch Police, Contra Costa Fire, Tri-Delta Transit and the Antioch Unified School District, and agreement that the speed tables will be removed with a 51% petition of affected property owners and removal of the speed tables at no cost to the City.  Staff is collecting traffic count data in the W. 11th Street/W. 14th Street neighborhood and will be working with the neighbors to investigate possible traffic calming measures.

Water Treatment Plant

- Cleaned solar bees out on the reservoir. Also cleaned the staff gage on the tower.
 This is reoccurring and ongoing.
- Changed out all HVAC filters in all the WTP buildings.
- Installed new lights over "A" plants' north and south entrances.
- Tested the chlorine sniffer in the storage and chlorinator rooms.
- Installed a new sample pump at "A" plant clear well.
- Performed monthly calibrations on all the turbidity meters at "A" plant.

Water Distribution

- There were 227 stops for water service including disconnections.
- There were a total of 89 USA tickets completed for utility location.
- Meter reading for the month of June is on schedule.
- Annual backflow test program continues and is on schedule.
- Water crews continue to monitor water meters, conservation and usage at all City buildings and parks.
- Water crews issued nine drought violation tags.
- Water crews continue issuing "water served upon request" notices and table flyers to all restaurants within City limits.
- Water Distribution personnel has returned 373 drought related voicemails.
- Water crews installed a new six inch compound meter and backflow device at the Baywood Condominium complex.
- Water crews continue to respond to customer calls and underground service alerts city wide.
- Water crews replaced the water meter and backflow device at Mission Elementary School to help track water usage.
- Water staff second shift continues city wide fire hydrant preventative maintenance program.
- Water crews replaced the meter, register head and transponder that were stolen from the city landscaped area on Ledgewood Ct.
- Water crews installed a new meter on Shady Ln.

- Water crews replaced two damaged fire hydrants due to auto accidents on Sunset Ln. and Evergreen Ave.
- Water crews repaired a section of the parking lot at Antioch Middle School where a fire hydrant was relocated.
- Water crews replaced a water service and repaired a section of water main on Silva St.
- Water, Parks and Delta Diablo Water District staff completed the quarterly inspections of the recycled water irrigation systems at Chichibu, Mountaire, Fairview and City Parks.
- Stores staff continues removing graffiti and debris from the Amtrak station and Fulton boat ramp.
- Stores staff continues to monitor stock levels and adjust inventory for upcoming fiscal year end count.
- Stores staff filled 12 non-stock orders from various departments/divisions.

Public Works Maintenance Operations - Parks and Landscape

- Irrigation leaks were attended to and repaired.
- Weed Spraying: Buchanan Dr., Lone Tree Way medians, Delta Fair Blvd. and Contra Loma Blvd.
- Rights of Way: Trimmed Delta Fair Blvd., Eagleridge Dr., James Donlon medians, west side of Hillcrest Ave., Vista Grande Dr., City's Water Treatment Plant and Carpinteria Dr.
- Irrigation Controllers: Assist the Public Works GIS Division with mapping the City's cul-de-sacs' irrigation controllers in the areas of Contra Loma to Somersville and Williamson Ranch.
- Assist GIS Division with mapping of Irrigation Controllers: Court controllers Cul-De-Sacs: Trimmed Hillcrest to Deer Valley area zone (4542).
- Cul-De-Sacs: Reprogram irrigation controllers south of Lone Tree Way from Hillcrest Ave. to Deer Valley Rd.

Public Works Maintenance Operations – Street Maintenance

- Graffiti Abatement: Graffiti removed from City property in numerous areas.
- Potholes: 57 potholes filled.
- Signs: 65 signs replaced due to poor reflectivity and installed 24 new signs in City parks.
- Debris: 28 yards of illegally dumped debris removed from City roads.
- Cape Seal Project Prep Work: Skin patched 1,150 square feet of roadway; ground down raised returns on ADA ramps and medians.

Public Works Maintenance Operations – Collections Division

 Calls for Sewer Service: Received and responded to four calls for service from the public. Responding crews televised public sewer laterals connecting to the City's sewer system.

- Sewer Mains: Daily preventative maintenance performed on over 28,655 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the hot spots.
- Sewer Lateral Maintenance Program (SLMP): Repaired two laterals that were severely damaged requiring immediate repairs. Crews also televised 15 laterals.
- Manhole Inspection Program: Crews inspected 46 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Closed Caption Televising (CCTV): The CCTV Preventative Maintenance inspects sewer mains to identify the condition and causes of blockages and Sanitary Sewer Overflows (SSOs). Crews televised 4,652 feet of sewer main lines.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 43 yards of debris and trash out of various creeks and channels. Crew also cleared 4.1 acres of weed abatement. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

Public Works Maintenance Operations – Fleet Maintenance

- Preventative Maintenance: 15 services on City vehicles as scheduled.
- Unscheduled Repairs: 38 unscheduled necessary repairs to City vehicles.

Public Works Maintenance Operations – Facility Division

- Council Chambers: We continue to work with the Information Systems Department to audit the lighting system for conversion to high efficiency, improved LED lighting.
- Lynn House: We replaced the aged, nonfunctioning air conditioning with a high efficiency unit.
- Lynn House: We installed a six-foot tall fence on the west side of the building and a
 gate at the driveway entrance.
- Humphrey's: We repaired a large hole in the kitchen area flooring and expanded the alarm system.
- Corporation Yard: Installed roll up doors in a storage unit to improve access.

Marina

- Approved one application for permanent berthing, one application is pending, responded to three berthing inquiries, and gave one facility tour.
- Repaired and replaced bolts in launch ramp float.
- Replaced lettering on power pedestals and replaced pedestal lights.
- Hyacinth, primrose, and debris removed from the marina basin.
- Electric meter reads for July billing complete.

- Advertising campaign of our competitive fuel prices continues.
- Advertising and outreach: Craigslist weekly ads posted in Sacramento, Bay Area, Stockton, Santa Cruz, and Monterey.

POLICE DEPARTMENT UPDATES
