ECONOMIC DEVELOPMENT UPDATES

- Staff is finalizing a Request for Qualifications and Proposals (RFQ/P) to solicit interest from established and well financed restaurateurs to re-invent the "Humphrey's" restaurant facility into a thriving new restaurant venue. The RFQ/P will be released next week.
- On Tuesday, June 24th, The City Council will consider authorizing a request for qualifications and proposals for certain City-owned sites on the east end of Downtown. We are seeking a highly qualified development team to build marketrate for-sale transit oriented residential units and to build a new 10,000 square foot senior center at a yet to be determined City-owned site, which would replace the Nick Rodriguez Community Center.

Environmental Resources:

- Environmental Enforcement We are working on another batch of enforcement for lack of garbage service. There were 131 actions on cases this week. Over 80 inspections to verify occupancy were conducted. 33 Abatement notices were mailed out. Five cases were closed.
- EcoEvents:

Youth outreach-We had one winner in our first social media photo contest. Alexandra Villa received a TriDelta Transit Summer Youth Pass. She has a total of 48 likes on the picture of her family's recycling system. At the end of the contest, the number of followers to EcoAntich on Facebook increased by 17 to 173 likes. Instagram followers increased by 8 to 28. Overall, the increase in presence on both was significant with the traffic to our Facebook page increasing to almost 2,000 daily views for the week of June 9th. We are hoping to do another contest in August for Back to School and give away a September Youth Transit Pass.

Relay for Life- We have the 'Be Classy, not Trashy' Photo booth out with a Purple Carpet background at the Relay for Life event at Deer Valley High School this weekend. The booth will be up from noon to 7pm on Saturday and from 8-9am on Sunday. We hope to get the pictures posted by Sunday night on our Facebook page. We will also be teaching bracelet making with yarn made out of old Relay shirts throughout the event!

 Staff also facilitated the outreach effort to alert the community that the signal at James Donlon and Gentrytown would be off due to a planned power interrupt on Thursday, June 19 from 8:30 to 11:30 am. A notification went out to all the emails on the APD Beat Notification list and was posted on the EcoAntioch Facebook page.

PARKS & RECREATION UPDATES

- Updated False Fire Alarm protocol for the Antioch Community Center
- Created new advertisement material for marketing facility rentals at the Antioch Community Center, Prewett Park and Nick Rodriguez Community Center.
- The Antioch Community Center hosted the Busy Bee Dog Show on Wednesday, June 18 in the Grand Plaza. This crowd favorite performed over 45 tricks and stunts! Educational focus was on pet ownership, time commitment, monetary responsibilities, adoption vs. buying, safety and spay/neuter.

 Summer Program kick off started the week of June 16th with great enrollments in Coyote Hills Summer Day Camp, Creative Explorer Preschool Camp, Youth Guitar program, Taekwondo, Adult Fitness and more. Art Camps have experienced large growth this summer with a current waiting list.

Senior Center

- Serviced six senior participants with Free Will/Trust information (a value of \$300 per participant).
- Have 50 members signed up to attend our Sips at Sundown evening event Friday June 20, 2014.
- Had 38 new participants sign up for membership to the Antioch Senior Citizens Club.
- Had 14 new participants sign up for the CC Café Nutrition program.
- Serviced two members with Spanish Peer Counseling (a value of \$50 per participant).
- Our monthly summary provided by the County for meals served for the month of May came in at 1,752 which made us to highest provider out of the 18 cafés around the county for the entire month of May.
- Logged 520 hours of senior volunteer hours for the Month of May for the County Nutrition Program.
- Had 17 members participate in Afternoon Tea Dance.
- Have nine members signed up for June beginning computer class.

PUBLIC WORKS UPDATES

Administration

- Caltrans began ramp metering at the Loveridge and Somersville interchanges on Tuesday, June 10th for both morning and afternoon commutes. Motorists who want to obtain more information can call the Ramp Metering Information line number at 510-286-4531.
- The City conducted a Neighborhood Meeting for the West Antioch Creek Storm Drain and Channel Improvement Project on Tuesday June 17th at 6:30 at the City's Maintenance Services Center 1201 West 4th Street. A representative from the Charter School, motel and County Fairgrounds attended to hear about the project and ask questions or voice concerns. Project construction is scheduled to begin in Spring 2015.

Engineering and Development Services

Almondridge East Subdivision 8880 (81-unit single family home development by KB Homes), located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160 – Staff is reviewing revised model home complex plans and an amended garage sales office conversion agreement. Contractor is installing curb, gutter and sidewalk along Phillips Lane and preparing to pave Phase 2 streets within the subdivision.

- Delta De Anza Trail repairs (Viera Ranch Subdivision 7220, between Ridgeline Drive and Neroly Rd.) – Construction began June 9th and to be completed August 8th.
- William Lyon Homes is building homes on 130 lots within Hidden Glen Subdivisions 6909, 7505, 8387 & 8388. The project is located east of Hillcrest Avenue and generally north and south of Hidden Glen Drive between Donegal Way and Braemar Street – Staff is reviewing 20 new home plot plans.
- Nelson Ranch Unit 1 Subdivision 6893 (102-unit single family home development by Standard Pacific Housing) located northeasterly of Wild Horse Road and Ridgeline Drive and southwesterly of State Route 4 – Staff is reviewing Wild Horse Road extension improvement plans. Staff expects to take park acceptance to the City Council for approval on June 24th and Unit 1 tract improvements with a deferred improvement agreement to the City Council on July 22nd.
- Nelson Ranch Unit 3 Subdivision 8851 (130-unit single family home development by Standard Pacific Housing) located northeasterly of Wild Horse Road and Ridgeline Drive and southwesterly of State Route 4 – Staff is reviewing new model home complex plans.
- PG&E Line 114 Gas Line Replacement Project, Easement Grant Deed to Pacific Gas & Electric Company for a portion of City-owned property to relocate a 24" gas line – Staff agendized a staff report and resolution for Council consideration at the June 24th meeting.
- The SR4 (Segment 2) Contra Loma Blvd./L St. Interchange & G St. Overcrossing Project proceeds with construction of retaining wall 13 (RW13) west of Contra Loma Blvd. between Buchanan Road and St. Francis Drive. Southbound Contra Loma Blvd. traffic between Buchanan Road and St. Francis Dr. will closed approximately one day a week between the hours of 8 a.m. to 2 p.m. to complete the construction of Retaining Wall #13. Staff is awaiting the contractor's estimate for sewer line modifications at Contra Loma Blvd. and Fitzuren Road.
- The eBART Parking Lot (99% complete) and Maintenance Facility (80% complete) project, located east of Hillcrest Avenue at the eastern terminus of Slatten Ranch Road Permanent fencing has been installed at the Maintenance Facility entrance.
- The SR4 (Segment 3B) Hillcrest Avenue Interchange Project will widen State Route 4 (04-CC-4-28.6/30.5) from 4 to 8 Lanes and modify the Hillcrest Avenue Interchange. Grading for westbound on-/off-ramps and Slatten Ranch Road widening and signalized intersection is ongoing. Rail delivery has been completed and permanent fencing installed along the access road.
- SR4 Lone Tree Way Widening/Sand Creek Road Interchange Project Staff is awaiting revisions to technical specifications and revised landscaping plans.
- Davidon Homes Park Ridge Phase I consisting of 123 residential units located west of Canada Valley Road and east of Highway 4 final map and improvement plans have been returned to developer. Expecting resubmitted map, plans and conditioned items returned to the City for review.
- Processing a parcel map at the Lowe's on Auto Center Drive to create two parcels.
 The additional parcel is for a new Panda Express. Civil plans for the project are approved.

- Processing lot merger, lot line adjustment and civil plan review for new commercial project at Deer Valley Business Park fronting Country Hills Drive between Lone Tree Way and Deer Valley Road.
- Processing plan revisions for Somersville Road reconstruction between CCWD canal and 700 feet south of James Donlon Blvd. Construction started May 15th.
- Returned civil plans and easements documents for Wal-Mart expansion.

Capital Improvements

- Deer Valley Road and Lone Tree Way turn pocket widening. Construction is complete. Contractor continues to work on punch list items.
- Cambridge Booster Pumping Station Upgrades Koch and Koch, Inc. has completed all major aspects of the project. Minor deficiencies in the work are being rectified. Equipment training sessions have been scheduled over the next few weeks.
- Curb, Gutter and Sidewalk Repair (2014-2015) Project bids are to be considered at the City Council meeting on June 24th.
- Sanitary Sewer Main Replacement at Various Locations Project bids are to be considered at the City Council meeting on June 24th.
- Country Hills Drive Sanitary Sewer Rehabilitation Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for July 1, 2014, at 2:00 P.M. in the City Council Chambers, located at 200 "H" Street.
- West Antioch Creek Channel Improvements A neighborhood meeting was held on June 17th to discuss the project and possible design alternatives.
- Maintenance Service Center Fueling System Improvements Project plans and specifications for the re-bid of this project are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. A mandatory pre-bid meeting is scheduled for July 1, 2014 at 1:00 P.M. at the City's Maintenance Service Center located at 1201 West 4th Street. The public bid opening for this project is scheduled for July 8, 2014 at 2:00 P.M. at the City Council Chambers, located at 200 "H" Street.
- Fishing Pier Shade Structure Project bids are to be considered at the City Council meeting on June 24th. Construction to start in August 2014.
- 2014 Rubberized Cape Seal Contractor completed the final layer of slurry seal and is working on the striping. Construction is expected to be completed on June 26th.
- Wilbur Avenue Bridge Widening The contractor is working on the final punch list items. The City Council is scheduled to accept the project at the July 22nd meeting.
- Safe Routes To School Grant The City expects to receive the notice to proceed with construction from Caltrans by July 1st. Construction of the project is expected to start in September 2014.

 Surface Transportation Program Grant – Caltrans has completed processing the grant documents. The City expects to receive the notice to proceed with construction from Caltrans by July 1st.

Water Distribution

- Cross-Connection Control staff continues to test and repair backflow devices on schedule.
- Water Meter staff is anticipating about 240 total stops for service during this week.
 This includes establishing water service and water service disconnects.
- Meter reading is on time for the week. We are experiencing a higher than usual failure rate of meter transmitters. This is normally due to the summer heat. The failures will be replaced and sent out for warranty replacement.
- Water staff has completed a total of 31 requests for utility marking.
- Mapping water distribution utilities through private properties that have City right of ways and entering the data on our maps for the GIS system at Deer Valley and Lone Tree Way.
- Exchanged and updated backflow prevention device shut off valve at San Jose Drive and Delta Fair Blvd.
- Water crews have repaired water leaks at Silvercrest Way, D Street and Barmouth Drive.
- Water staff has completed improvements for safety features in our Pipe Shop and Meter Room.
- Staff has been painting over undesirable colors applied to City owned fire hydrants back to City-mandatory white.
- Exchange curb stops in the Belle Drive area for more efficient operation of water service operation valves.
- Stores posted 150 stock line items and issued 425 line items to various accounts in the city.

Water Treatment Plant

- Rebuilt three chlorinator Check units. These units control the amount of chlorine being fed from each cylinder.
- Repaired electrical conduit throughout the WTP and removed electrical control boxes that run along the drying beds.
- Repaired sample water lines in the laboratory.
- Cleaned up WTP grounds by hauling off old piping and concrete.

Public Works Maintenance Operations

Landscape Maintenance

- Fire Abatement GIS mapping continued with South Royal Links Circle, G St. and Longview Road (Zone 4565), Putnam St. to Gentrytown Dr. (Zone 4566), Cambridge Dr., Reseda Way and Osprey Drive to Mallard Court (Zone 4568). With these zones completed the mapping stands at 87% complete.
- A playground and park safety inspection was completed at Country Manor Park.

- The Firebreak Abatement Program continues this week. Work is almost complete
 with disking crews finishing all maintenance zone work. The mowing crews are
 working on Trembath St., PG&E tower open space, Greystone Dr. and Deerfield Dr.
 pathways. Approximately 90% of the work Citywide is complete.
- Fire Abatement GIS mapping continues, with completion of the Markley Creek area (Zone 4572), Harbour Park area open space and towers (Zone 4564) and Trembath St. open space (Zone 4563). Citywide mapping now stands at 94% complete with 105 mowing areas plotted and mapped, and only 9 of 49 disking areas remaining to map before project is complete.
- The summer park irrigation schedule programming is 100% complete at the City's 32 neighborhood parks. Irrigation upgrades and repairs continue to be made in order to conserve water.
- A playground and park safety inspection was completed at Deerfield Park.
- Playground surfacing repairs were completed at Meadowbrook Park (1700 Yellowstone Dr.).
- A main-line water break was repaired at Diablo West Park (2000 Prewett Ranch Dr.).
- Inoperative turf valves 3 and 4 were repaired at Knoll Park, sprinkler repairs made at Country Manor and Gentrytown Parks.
- Landscape crews continue spraying of post emergent weeds on Deer Valley Rd.,
 4th, 10th, & 18th St. medians.
- Numerous other irrigation leaks were attended to and repaired.
- The growing season is in full swing and the 5 person contract trimming crew continues the trimming of the center medians of Deer Valley Rd. north of Lone Tree Way. The 4 person contract trimming crew is currently trimming the westside of Hillcrest Ave. heading north towards Prewett Ranch Rd. The 3 person trim crew finished trimming the south side of Williamson Ranch Rd. and has begun the trimming of Sagebrush Way.
- Landscape staff continues to re-program the irrigation controllers from their winter programs to their summer programs. They are approximately 92% complete with this task.
- Contract crews (Pacheco Brothers) are currently trimming the courts in the Bluerock Dr./Eagleridge Dr. area (Zone 4569).
- Contract crews (Pacheco Brothers) have begun the trimming of Dallas Ranch Rd.
 They are currently working on the center medians of the road heading north towards Lone Tree Way.
- Landscape Maintenance Staff along with the "Work Alternative" participants trimmed Delta Fair Blvd. from Somersville Rd. to Kendree St.
- Landscape crews installed a new solar irrigation controller at the corner of 3rd & G
 Streets.

Street Maintenance

- Staff inspected the contract work on the Cape Seal project that is taking place on various City Streets.
- Staff removed graffiti from numerous areas around the City.

- Crews continue to repaint stencils (Cross walks and Legends). Staff has repainted 107 stencils and repainted 1,620 linear ft. of 12" (cross walks and STOP bars). This work is moving to areas around schools because of less traffic, due to school being out.
- Crews replaced 14 existing signs due to poor condition and installed 1 new sign.
- Crews filled 2 potholes.

Collections Division

- The Collections team cleaned over 28,417 linear feet of sewer lines.
- Staff hydro flushed and cleared 8 potential blockages on various sanitary sewer main lines and found 7 locations that needed immediate repairs.
- 4,915 linear feet of sanitary sewer lines were televised by an outside contractor.
 Staff is working with the contractor for quality control and making sure the lines are clean for them to review.
- Staff continues to make progress on the revisions/self audit of the city's Sanitary Sewer Management Plan, which is required by the state.
- Approximately 2.4 acres were weed abated in various creeks and channels.
- 302 cubic yards of vegetation/material and 4 bags of trash were cleaned out of the creeks running through the City.
- Management staff is designing and receiving quotes for new utility beds to go on replacement trucks.

Facility Maintenance

- Several burned out lights and lighting repairs were made at the P.D. jail.
- A water leak at the P.D. jail was repaired.
- Additional bracing was installed on the water heater at the Public Works yard.
- Repairs were made to the air conditioning unit at the Marina office.
- Various repairs were made in Animal Services.
- Repairs were made to vandalized areas at the Lynn House.

Fleet

- Performed 16 preventative maintenance on vehicles, as scheduled.
- Staff made 21 miscellaneous repairs to City vehicles.
- Staff took delivery of a new asphalt roller that will replace the existing roller, which is now beyond its useful life.

Marina

- The Smithsonian Environmental Research Center is conducting research on invasive species affecting the Delta Region. The Antioch Marina is a crucial location for access and research. This research is a passive collection using small containers collecting samples lasting 3 months from several locations within the marina.
- Marina Staff made requested repairs to the B dock corner pier.
- Marina Staff is working to rectify several past deposit accounts in order to recoup any applicable funds and clear the marina records.

- Marina Staff has addressed the public restroom break-in; locks are now operational with help from Facilities Maintenance.
- Meter reads for July billing are complete.
- The Marina had 4 inquiries for new berthing, of which 1 of the 4 applicants has been approved for berthing.
- The marina had 3 overnight boating stays.

POLICE DEPARTMENT UPDATES

- On 6/13/14, Officer Gonzalez attempted to stop a vehicle for code violations. The
 driver stopped the vehicle and fled on foot. Gonzalez chased the fleeing driver
 north from East 6th Street to the railroad tracks and then west along the tracks to the
 field area near the A Street extension, where Officer Gonzalez was able to
 apprehend him. The driver had outstanding warrants for his arrest as well as stolen
 license plates on his truck.
- On 6/13/14, while on routine patrol, an Acura caught the attention of Officer McDonald. He ran the plate while quickly turning around to get back to the vehicle. As he did, he saw the vehicle pull to the curb and the four occupants casually get out. The vehicle was confirmed to be stolen. Officer McDonald detained the above listed subjects at gun point until his cover could arrive to assist him. All four were detained without incident. One suspect was arrested and transported to County Jail for stolen vehicle charges as well as narcotics charges.
- On 6/14/14, a victim observed a man climbing on his roof and entering his
 residence through an upstairs window. When Officers arrived and cleared the
 residence, the suspect was found hiding in the bedroom closet of the victim's 16
 year old daughter. The suspect was arrested and sent to County Jail.
- On 06/15/14 at approximately 1014hrs, the Antioch Police Department received a 911 call regarding a possible drowning victim near the Antioch Marina. Upon arrival, it was discovered that a group of men from Oakland were fishing along the waterfront for Father's Day. One of the members of the group entered the water in order to untangle his fishing line and slipped on a rock. During the fall, the male is believed to have struck his head on a rock and subsequently drowned before other members of the group could pull him out of the water. The victim in this case is a 52 year old male from Oakland.
