NEIGHBORHOOD CLEAN-UP

The Antioch Police Department is excited to announce the 73rd installment of the Neighborhood Cleanup Program. This is a collaborative community effort which involves active participation from The Antioch Police Department Crime Prevention Commission; Neighborhood Watch Program; Volunteers in Police Service; community volunteers and the Public Works Department. Collectively, **“We”**, everyone who works and lives in the City Antioch, can make a difference and improve the quality of life. It’s our community and it’s our chance to make a difference. The City of Antioch Neighborhood Cleanup program is not just for residential neighborhoods. It is a program that will change venues on a monthly basis and it will include business and commercial areas as well. Neighborhoods that are free of trash and refuse are inviting, and a clean community instills a sense of community pride.

The 73rd Neighborhood Cleanup event will occur on **Saturday, August 6th from 9:00 a.m. to 11:00 a.m. Volunteers will meet at Gentrytown Park (Monterey Side)**. We will be cleaning the neighborhoods between Monterey Dr. and Mission Dr. down to Rio Grande Drive and Gentrytown Park. Volunteers will receive instructions and the equipment necessary to accomplish the goal. The targeted area is within walking distance. Excluding inclement weather, future Neighborhood Cleanup events are scheduled for the first Saturday of every month and the locations will be announced in advance.

If an incumbent does not file for re-election, the Filing Period for that office will be extended to 5 p.m. Wednesday, August 17 for non-incumbents. RECREATION UPDATES

- **On Thursday, The Antioch Community Center and Prewett Library presented *Hawks, Honkers & Hoots*, a wildlife organization whose mission is to educate communities about local wildlife and conservation through interesting presentations with raptors (birds of prey) and water birds. Families had an opportunity to meet these awesome bird ambassadors up close and feel the amazing wings, feathers and talons at the discovery tables.**
- Last week, 41 campers enrolled in Coyote Hills Summer Day Camp for “Super Hero” week. They did agility training obstacle courses, crazy spider web battles, kryptonite treasure hunts and Hero water challenges while saving the Community Center from villains and more.
- Last week, staff met with a representative from Skyhawks Sports to plan programming for First Five's regional group fall classes at Contra Loma Estate Park. Young children will be participating in a variety of multi-sport activities and gaining skills, passion and the confidence needed to live an active and healthy lifestyle!

- Last week, 45 school-age youth participated in “Adventures in Fun and Fitness” the mobile recreation program at City Park and Contra Loma Estates Park. Sponsored by Kaiser Permanente, the program promotes healthy eating and exercise through fun recreational activities during the summer months. This program engages the families living north of Highway 4 and promotes activities in their neighborhood parks.
- The Summer Adult Softball League has concluded – 51 teams equaling 765 players played in the regular season that began on April 8th. A total of 36 teams made it to the playoffs and six teams were crowned 2016 Summer Champions for their respected divisions as they went undefeated in the playoffs.
- Last week, registration got underway for teams wanting to participate in the 2016 Fall League that begins on August 4th.
- On Tuesday, 26 young teens dropped in for some open-gym time. This weekly open gym is for middle-school aged teens and is sponsored by the Leo Fontana Family Foundation.
- The Fiscal Year 2016-2017 CDBG Scholarship program has started. \$15,000.00 was awarded for qualifying youth to participate in recreation programs and healthy activities. The Recreation Department has awarded 47 children \$100.00 each; applications are still available for qualifying families.
- The Antioch Council of Teens (ACT) continues to meet and work on fundraising ideas for their summer project. They are still accepting donations from the public and plan to distribute their donation bags on August 7th to organizations that work with homeless teens and adults.
- A new teen kayaking program is in the planning phases with a tentative day trip planned for the last weekend in September.
- Last week, staff continued planning the *Family Sports Day* program in collaboration with the Antioch Sports Legends – mark your calendar for August 13th and bring your family to the museum and learn about sports and sports history in Antioch.
- Water Park group ticket packages continue to be successful with 21 birthday party and group tickets booked this week.
- On Tuesday, 20 toddlers and their parents joined the Antioch Water Park staff at the Tad Pool for Toddler Tuesday, which continues to be a hit with families who want to introduce water play to their very young children.
- On Thursday, session four week-day swimming lessons wrapped up the eight days of class instruction. A new two week session begins on August 1st for pre-schoolers, school-age kids, and parent/child water introduction. Swimming is an important life skill – sign up today!
- On Monday, Water Park Maintenance Staff repaired an underwater light for the Lap Pool
- On Tuesday, Water Park Maintenance Staff completed modifications to the flow meter configuration for the Boulder Cove and Sport Pools. These modifications were necessary to integrate the flow meters with the new PLC’s previously installed.

- On Wednesday, Water Park Maintenance Staff completed various preventive maintenance tasks on the pool systems. Regular preventative maintenance keeps our attractions ready for the public's enjoyment!
- Throughout the week, Recreation Maintenance Staff worked with Republic Services to address various service issues at Recreation Facilities.
- It will be another hot weekend in Antioch and the Antioch Water Park is ready to serve you; there is plenty of space for your family, friends, group, or organization. Group parties and private park buyouts continue to be very popular; some booked well into September. Make the most of your summer and **BE COOL BY THE POOL!!**

Senior Center Services

- Last week, 442 affordable healthy meals were served through the C.C. Café; an increase of more than 70 meals over the previous week. The daily lunch and socialization help prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the C.C. Cafe. The nutrition program is a partnership with Contra Costa County and the City of Antioch.
- Last week, staff continued planning the *Senior Resource Fair* and began processing applications from vendors and resource organizations. Mark your calendars for September 30, 2016! The Resource Fair will include information from businesses, health organizations, non-profits, and medical practitioners within Antioch and throughout Contra Costa County.
- On Thursday, Interested seniors attended Edward Jones "Fraud Prevention" presentation. Incidents of fraud are on the rise and scammers' tactics are becoming more complex. The program focuses on education about fraud and the steps you can take to outsmart the scammers.
- Last week, the Senior Center hosted regular weekly classes and programs ranging from live music for dancing to potluck dinners, and exercise and self-defense. Health insurance counseling and care manager rotary services were also available.
- To date the Senior Club has received new and renewal membership applications from 904 Seniors.
- Mark your calendars for August 26th and purchase your tickets now! The Antioch Senior Citizen's Club is hosting a "Hot Summer Night" classic car show and live entertainment at the Senior Center. A summer evening of fun will support the programs organized by the Club for Antioch seniors.

CDBG:

- Preparation of the Performance Evaluation Report (CAPER) for FY 2015-16 will commence soon and is due to HUD no later than September 30th.

Homeless Outreach – Contra Costa will once again have homeless outreach services in the County. Daytime outreach will start in September and consist of two two-person teams, one dedicated to East County and the other to serve Central and West County. Evening outreach will likely begin by early December with one team, and may be enhanced to two teams. All teams will report to a single Coordinator to ensure seamless collaboration and transition between day and night. All teams will receive the same training, utilize the same protocols, and be based on the same model of service delivery. This new outreach model was the winning design in the State ESG competition, held recently. Day teams and the Coordinator will be County-run, and the night services are presently being sought in the Coordinated Entry RFP which is due in early August. If no other viable candidates are found for evening outreach, the County will likely contract for that function as well.

Project Homeless Connect will be held at the County Fairgrounds in Antioch on Thursday, October 13th, from 9 am to 3 pm. Homeless Connect is a one-day, one-stop event that provides on-site healthcare, social services and housing resources to persons experiencing homelessness. While this winter brought us enough rainfall and snow pack to make it through the dry season, conservation is still vital and many prohibited uses are still being enforced. PUBLIC WORKS UPDATES

Administration

- 2016 Pavement Management Program is continuing throughout the City. In addition to various residential streets, the \$2.6 million asphalt pavement roadway rehabilitation project will include major arterial streets, such as Lone Tree Way, James Donlon Blvd., Somersville Road, Buchanan Road, Golf Course Road, Hillcrest Avenue, and is slated for completion in September 2016.

- Contra Costa County Public Works Department will perform road work on Marsh Creek Road from the Brentwood city limits at the Marsh Creek Reservoir to the Clayton city limits at Pine Lane, starting July 25, 2016 to August 12, 2016. The work will occur Monday through Friday between the hours of 8:00 a.m. and 6:00 p.m. to resurface the road.

Engineering & Development Services

- City-owned cell sites, various locations: Staff is performing site visits and review of land leases, 100% construction drawings, consent letters, photo-simulations and related technical reports and materials in response to various applications for equipment upgrades and site modifications.
- The Habit Burger, 2424 Mahogany Way, a new restaurant development: The project was approved at the July 20th Planning Commission meeting. Staff is reviewing construction drawings for building permit issuance.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: The project was recommended to the City Council for approval at the July 20th Planning Commission meeting.
- Olive Groves Subdivision, 263 single-family detached senior housing units with assisted living facility, commercial uses and open space. Residential portion gated with private streets. Staff is preliminarily reviewing the PDP-16-01 application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The subdivision plan and map checks have been completed and staff is working with the developer to form a district to fund offsite improvements. Staff is reviewing proposed Slatten Ranch Road infrastructure improvements.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project has been accepted by the State. The City is working with Caltrans to complete the punch list.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Staff prepared a punch list for Caltrans' contractor to complete. There will be lane closures in the northbound and southbound directions of A Street / Lone Tree Way between Rossi Avenue and E. Tregallas Road from 6:00 am to 3:00 pm. Pedestrians and motorists are advised to exercise caution while travelling through these areas.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Staff prepared a punch list for Caltrans' contractor to complete. There will be lane closures in both directions on Hillcrest Avenue between Larkspur Drive and Sunset Drive from 9:00 am to 3:00 pm. Pedestrians and motorists are advised to exercise caution while travelling through this area. On July 20th, the Contra Costa Transportation Authority held a ribbon-cutting ceremony to commemorate completion of the Highway 4 Widening project, which added two travel lanes in each direction and includes construction of a BART station at Hillcrest Avenue and extension of BART to Antioch.

- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff is working with developer on park extension. First phase of construction documents submitted. Reviewing plans for 3rd plan check.
- Working on creating Community Facilities Districts for FUA 1.
- Tabora Gardens, a senior apartment complex on James Donlon and Tabora Drive: Returned 3rd plan check comments for revision.
- Child Care Education Building in Williamson Ranch Plaza: Returned 3rd plan check comments.

Capital Improvements Division

- Country Hills Drive and Vista Grande Drive Water Main Replacement: A-S Pipelines, Inc. is completing the connections of the new water facilities to the existing system on Country Hills Drive and Vista Grande Drive. Surface restoration and pavement striping will be performed next week.
- Sunset Booster Pump Station Replacement: JMB Construction has installed new valves on the existing pipeline adjacent the pump station location. Piping for the temporary pump station will be constructed next week.
- Water Treatment Plant Disinfection Improvements: Staff is reviewing a draft technical memorandum prepared by CDM Smith pertaining to the use of aqua ammonia or ammonium sulfate at the Water Treatment Plant.
- Marina Boat Launch Facility Restroom: Staff has submitted proposed design, construction and maintenance schedules to the California Department of Parks and Recreation, Division of Boating and Waterways for their review.
- Brackish Water Desalinization Plant: Carollo Engineers is preparing studies related to various river water quality scenarios and the City water intake facility. A meeting has been scheduled with the State Water Resources Control Board for mid-August to discuss the City's application for a State Revolving Fund loan.
- Downtown Sanitary Sewer Rehabilitation: Staff has completed preliminary design work.
- North East Annexation Infrastructure Improvements: Staff is reviewing a revised proposal for consulting services from BKF Engineering to provide engineering services and to prepare preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve the newly annexed Area 1 and 2B. City Council is to consider award of the consultant service contract with BKF Engineering at the August 9, 2016 meeting.
- 2016 Pavement Management Program: MCK Services, Inc. continues to work on pavement rehabilitation activities throughout the City. This project includes improvements to major arterial streets such as Lone Tree Way, James Donlon Blvd., Somersville Road, Buchanan Road, Golf Course Road, Hillcrest Ave. and various residential streets north of Highway 4.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to finalize the land use forecasts, the transportation improvement list, the network to

be used in the traffic model, and proposed fee. The final draft Fee Study will be presented to the City Council for public review and comments.

- Prewett Water Park Improvements: Sierra Valley Construction is continuing work on the playground and the spray ground facilities. Both projects are scheduled to be completed in September 2016.

Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation.

- Water Distribution staff repaired a 2” water device on James Donlon.
- Water Distribution staff replaced a water service on 9th Street.
- Water Distribution staff continues State mandated annual backflow testing.
- Water Distribution staff performed city wide preventative maintenance on fire hydrants and water quality flushing.
- Water Distribution staff hauled off green waste for recycling as well as cleaned up debris at the city’s Fulton yard.

- Pavement Markers: Replaced 1,500 raised pavement markers.

Public Works Utilities – Collections Division

- Calls for Sewer Service: Received and responded to seven calls for service from the public. Responding crews televised 70 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 25,375 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the 'hot spots'.
- Sewer Lateral Maintenance Program (SLMP): Repaired two laterals that were severely damaged requiring immediate repairs and televised two laterals.
- Manhole Inspection Program: Crews inspected 81 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of "SMART Manholes" in strategic areas will be utilized that will alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 2,268 feet of sewer main lines this past week. The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and SSOs.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 32 yards of trash and green waste from the Lindsay Detention Basin Drainage Creek. Weed abated 2.68 acres of low water line access to channels. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

Public Works Operations – Fleet Division

It was occupied by 20 year old Robert Wickham and 20 year old Savaughna Heneby. Both were taken into custody without incident. Heneby was later released and Wickham was booked into county jail. The vehicle was returned to the owner.
- On 7/28/16 at 3:00 am a 40 year old female called to report she was being followed by a subject. When officers arrived, they contacted a 17 year old male walking away from her. He was detained and found to be in possession a loaded stolen pistol. He was taken into custody and later booked into Juvenile Hall. The gun was stolen out of a Reno.
