KUDOS TO CONTRA COSTA COUNTY FIRE AND OTHER FRIENDS

On Wednesday, there was a serious three alarm fire at 2310 Sycamore, threatening life and property. Contra Costa Fire Battalion 8 responded and had incident command. Assisting Agencies included the Antioch Police Department, Building Officials and Code Enforcement. Here is CC Fire's information on the incident released yesterday.

Contra Costa County Fire- Engine 81 (Antioch), Quint 83 (Antioch), Quint 84 (Pittsburg), Engine 85 (Pittsburg), Engine 82 (Antioch), Battalion 8 (Pittsburg). Battalion 5, (ECCFPD), Engine 88 (Antioch), Engine 86 (Bay Point), E93 (Oakley), Engine 52 (Brentwood), Truck 6 and Engine 6(Concord), Breathing Support 7 (Walnut Creek), Quint 1 (Walnut Creek), Training Captain 10 (Concord), Battalion 7 (West County), Battalion 2 (Central County), Battalion 1 (Central County), Overhead of the Fire Chief (1100), Assistant Chief (1101), Fire Marshal (1120), Inspector/PIO (1144), Communication Technician (1153), Amr Supervisor (S9), Transport Ambulance, Antioch PD, Red Cross, and PG&E responded to a reported Commercial Structure Fire. Engine 81 reported en route that they observed smoke in the area. Upon arrival Engine 81 reported "On scene of a 2 story apartment complex with Heavy fire from the first floor extending into the second floor and attic. Engine 81 attacking with 2 1/2 " line and has their own water supply. Engine 81 established Delta Pines IC." Additional fire units were requested for a total of 3 alarms. Two apartments were affected and 30 citizens were displaced. Crews were assigned fire ground missions and the fire was extinguished. It was later confirmed that the fire started outside. There were no injuries to citizens or firefighters during this incident. The property was turned over to the apartment management company. No firefighter injuries or deaths were reported. 6 residents were transported to area hospitals for minor smoke inhalation. The Red Cross assisted with resident displacements.

In addition, the Red Cross called me this morning to praise our staff, the community and the local churches that helped out in the aftermath of this incident. They said the effort was impressive. That was nice to hear.

ECONOMIC DEVELOPMENT UPDATES

AAA to move to Slatten Ranch Shopping Center – The California Automobile Association, also known as AAA, will soon be relocating their Auto Center Drive offices to Slatten Ranch Shopping Center. They will totally renovate the Johnny Carino's building, which closed some months ago. In recent years, AAA has been locating their retail facilities in shopping centers with mayor anchors to get better public visibility and higher traffic counts. Slatten Ranch accomplishes this objective for AAA and provides a destination use that will compliment the adjacent retail and restaurant uses. They plan on opening the new facility by year's end.

Freshest Cargo Mobile Farmers' Market: Staff has been working to bring a farmers market to Rivertown. The City now has an agreement in place with The Mobile Farmers Market, also known as Freshest Cargo, for a "pilot" program to bring fresh fruits and vegetables via mobile truck to our downtown and water park sites. RECREATION UPDATES:

- The Fall & Winter Recreation Guide is headed to the post office. Check your mailboxes the week of August 10th for *W.O.W... Wonderful Opportunities Waiting!* Online registration begins August 17th for fitness classes, swimming programs, sports, and lifelong enrichment activities for all ages.
- Last week, the Water Park completed daily operations but August usually brings some of the hottest weather! The Water Park will be open Friday evenings, weekends, and holidays through Labor Day for fun in the sun, *Everyone Into The Water!*
- On Monday, staff coordinated with Delta Diablo Sanitation District for the disposal of potentially hazardous materials through the District's Conditionally Exempt Small Quantity Generator Program. The City's ongoing partnership with Delta Diablo is an example of good community stewardship.
- On Wednesday, staff completed the latest review of the Safety Data Sheets (SDS) as part of the transition to the new Globally Harmonized System (GHS) used for Hazard Communication. New binders are in place for staff at all recreation facilities.
- On Thursday, staff completed semi-annual curb striping at Prewett Community Park in time for the new school year. Moving traffic through the parking lot safely (through striped red zones) ensures safe access for everyone at the Prewett Community Park Facilities.
- On Tuesday, the City's four person contract tree trimming crew completed selective pruning at Prewett Community Park to optimize the view in the new video surveillance cameras throughout the parking lot and Plaza.
- Throughout the week, staff worked with the City's Park Maintenance Landscape contractor to address several irrigation concerns at Prewett Community Park. This work strengthens the City's commitment to water conservation.
- On Friday, the Jr. Lifeguards completed their final week of camp for the summer. Camp participants became official American Red Cross certified Jr. Lifeguards. Staff hopes they will return next season as volunteers and employees.
- More than 20 youth continue dropping in to City Park and Contra Loma Estates Park for "Adventures in Fun and Fitness." There is more to come next week, thanks to the grant from Kaiser Permanente which expands health and recreation access for Antioch families.
- Last week was the final week of the new drop-in program at City Park and Contra Loma Estates Park – "Adventures in Fun and Fitness." Nearly 60 children enjoyed healthy activities and nutritious snacks this summer thanks to the grant from Kaiser Permanente.
- Swimming lessons for all ages, and Toddler Tuesday continue to be popular for

parents with small children. Families can still participate in these programs in August, sign up now!

 Last week, ten dance classes wrapped up their summer season. More than 100 young dancers learned coordination skills, rhythm, and movement through the fun of dance!

Senior Center Services

- Last week, 412 affordable healthy meals were served through the C.C. Café. In addition, 8 participants signed up for the Senior Nutrition program. This program helps prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the C.C. Cafe.
- A Contra Costa HICAP representative provided health insurance counseling at the Antioch Senior Center to 4 community participants who were in need of guidance and direction regarding their health coverage.
- Staff continued addressing maintenance concerns at NRCC and Antioch Senior Center. Staff is working with public works to purchase needed items and resolve issues.
- Last week, staff tracked 11 memberships that renewed last week for the 2015 Antioch Senior Citizen's Club.
- On Tuesday, staff attended the Antioch Senior Citizen's Club Board of Directors meeting. Staff provided input and direction on various topics such as the upcoming Club Fundraiser *Sizzling Summer Night* and National Senior Center Month in September 2015.
- Tickets became available last week for the Sizzling Summer Night Fundraiser set for Friday August 14, 2015. This event will be co-sponsored with the Antioch Lion's Club. Live music, Car show and Hot dog meal will be provided for \$10. Pick up your tickets at the Antioch Senior Center!
- Staff completed the program for the digital display screen located in the Antioch Senior Center Lobby. The presentation markets activities and services provided to the aging community in Antioch. More training will be provided next week to staff to explore additional features.
- Staff continued research and planning for upcoming Resource Fair that will take place Friday, September 25, 2015 from 9:00am-11:00am located at the Antioch Senior Center.
- On Tuesday, staff collaborated with the Contra Costa Senior Peer Counseling-Chinese Program to offer a Chinese a Tai Chi Class. Cultural enrichment was provided to 18 senior participants who were able to learn new exciting Tai Chi techniques while socializing with senior peers of multiple ethnic backgrounds.

Environmental Resources:

Environmental Enforcement: July 30-Aug 5 there were over 106 actions taken. We currently have 168 active cases. 1 notice of violation, 22 courtesy notices for abatements that have ended and 24 abatement notices were mailed out. 22 cases were closed.

- Annual reports for our waste diversion requirements and Oil Payment Program were submitted to the State this week.
- On Thursday, July 30, staff shadowed a team of Energy Specialist with CYES on a Green House Call. This is the last week of this wonder summer youth employment and energy conservation program. A report from the program is on the Council agenda for September 8, 2015.

CDBG:

- Contracts for 2015-16 are almost completed
- All agencies have submitted final reports and reimbursement requests and staff has begun working on Consolidated Annual Performance Evaluation Report (CAPER) due to HUD 9/30/15.

Housing:

- Satellite was not awarded 9% tax credits. However, it has identified and applied for several other potential sources of subsidy, and is very hopeful that the project will be able to continue with 4% tax credits, which are not competitive.
- Review and reorganization of all multifamily housing files is underway. Monitoring of Housing Successor assets will be conducted July December to verify income and/or occupancy for all first time homebuyer loans, homeowner rehabilitation loans, and multifamily/rental properties, excluding Vista Diablo, which was monitored in October 2014.

Homeless:

 Teri House, Antioch Housing Consultant, attended the Saturday meeting of the faith-based efforts to establish a homeless shelter for women and children in Antioch. Pastors from New Life (Brentwood) and Golden Hills churches were there, as well as Gary Kingsbury from Bay Area Rescue Mission, representatives from the Multifaith Action Team, and several women who gave testimony about their experiences of being homeless in Antioch and having turned their lives around at the New Life Center. Cheryl O'Connor from HomeAid Northern California was the key speaker, and she told how HomeAid partners with community groups to build shelters and other facilities, and highlighted some of their efforts. Teri House has been involved in funding or participating in several of these high-quality projects over the past 15 years.

If HomeAid selected this as a project, they would contribute about ½ of the total cost of materials and construction. They are often involved in maintaining and remodeling projects they have built. Cheryl emphasized that they are looking for strong local leadership that is in the project for the long haul. Mr. Kingsbury requested that HomeAid work with an architect on a design, and help the group come up with a cost estimate, and this seemed to be the next step.

- Teri House presented information about the Council on Homelessness at a meeting of the Contra Costa County Leadership Academy, Homeless Project Team. The group convened representatives from several cities to hear what is happening in the County on homelessness, and invited them to join in groups to work on specific issues. A number of PD from various jurisdictions were present, which shaped some of the discussions. Many agreed to attend the next quarterly General Membership meeting of the Council on Homelessness, which will be October 16, 10-12 p.m. at the ZA Meeting Room, 30 Muir Road, Martinez.
- Please encourage people to volunteer and donate to Delta Veteran's Group to support the 3-day Stand Down On The Delta event for homeless and very lowincome Veterans. The Stand Down will be held September 11-14 at the Contra Costa Fairgrounds in Antioch, and about 250 Veterans are expected to attend. DROUGHT UPDATES:

Way To Go Antioch Water Customers! Your conservation efforts are paying off. Through the end of July, the reduction in water usage is 36.8%! This is a cumulative total beginning in June of 2015.

Irrigation repairs:

- Almondridge Park: The Men's Restroom underwent complete change outs to the toilet and urinal flush valves, and is now completely re-opened. We apologize to one and all for the lengthy closure time awaiting repair parts to be fabricated.
- Antioch Community Park: 2 sprinklers were repaired.
- City Park: 2 sprinklers were replaced.
- Deerfield Park: 2 sprinklers were replaced at the park, and 1 plugged nozzle was cleared allowing for water to get to the tree in need.
- Diablo West Park: An inoperative turf valve was rebuilt, and is now operating.
- Gentrytown Park: 6 additional sprinklers were replaced this past week, due to continued vandalism.
- Heidorn Park: 6 sprinkler repairs were made to eliminate all wasted watering.
- Hillcrest Park: A total of 8 sprinklers were replaced this past week, as well as a new turf valve solenoid install to repair the inoperative valve. More repairs at this park will be ongoing this week.
- Meadow Creek Park: A 2" Main-line was repaired and is now operating with no wasted water, as well as full pressure to the operating turf valves.
- Mountaire Park: The inoperative women's restroom toilet was repaired, and is now open for public use.
- Mira Vista Hills Park: Turf valve #6 had a new solenoid installed, and is now operating correctly.
- Nelson Ranch Park: The City's newest park, off Wildflower Drive, had 4 broken sprinklers replaced.
- Prosserville Park: 1 replacement 2" turf valve was installed for zone station #11. 2 additional sprinklers were replaced.
- Williamson Ranch: 5 vandalized sprinkler, by the west gazebo structure were repaired again.

- James Donlon Blvd: 55 repairs

PUBLIC WORKS UPDATES

Administration

- The City of Antioch is being required to reduce its 2015 water usage by 28% in 2015 using 2013 as the base year. Outdoor water conservation will be the primary focus of the City's program as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th. All Antioch customers will be mailed a letter explaining the program and prohibitions as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 am and 5:00 pm, shut off nozzles required on all hoses and drinking water available only upon request at restaurants. Contra Costa Water District has incentives such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. More information on water conservation programs and ideas on how to conserve water can be found at www.ccwater.com or www.antiochwater.com. Customers who are not in compliance with drought restrictions can be reported to the Antioch Drought Hotline at (925) 779-6140.
- Residents of Antioch, Bay Point and Pittsburg can now get free recycled water to use for irrigation of their yards and gardens at home. The Residential Recycled Water Fill Station located at 2500 Pittsburg-Antioch Highway will be open to residents on Saturdays and Sundays from 9 a.m. – 3 p.m. through the end of October. There is a 300 gallon maximum per visit with no limit to the number of visits. For more information, please see http://ddsd.org/home/showdocument?id=1218.
- A full closure of Contra Loma Blvd undercrossing will occur Wed., Aug. 5, 10 pm 5 am. A full closure of 'A' Street/Lone Tree Way undercrossing will occur Mon. Fri., Aug. 10-14, 10 pm 5 am. This work is part of the program to complete the highway and BART projects as quickly as possible. Pedestrians and motorists are advised to exercise caution while travelling through these areas.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: Construction of improvements is ongoing. Phase 2 environmental clearance and USBR permit is in process.

- Cellular Providers on City-owned Property: Verizon is investigating new cellular installations at the City's Larkspur Dr. and James Donlon Blvd. water tank sites. Zayo is investigating installation of Dark Fiber at selected locations under a City encroachment permit.
- City Sports Club, located at 5001 Lone Tree Way: Recordation of lot merger and sewer easement quitclaim deed in progress. Final plan check has been completed.
- DeNova Homes Mixed Use Project at Hillcrest Ave./Wildflower Dr.: Application for mixed use project consisting of 9.5 acres commercial, 8 acres multi-family, and 2.2 acres single family development. Staff met with the applicant to discuss project conditions of approval.

- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Staff returned 2nd map and plan check comments and prepared conditions of approval for landscaping plans design review approval.
- PG&E Lot Line Adjustment, located at the southwest corner of Somersville Road/ Buchanan Road intersection: Staff sent lot line adjustment documents to the County Recorder's office for recordation.
- Taco Bell, 1706 'A' Street: Staff returned first plan check comments to the design engineer.
- Wilkinson-VanSandt LLA: Staff sent documents for a lot line adjustment between 4316 and 4325 Berryessa Ct. to the County Recorder's office for recordation.
- Viera Ranch Unit 2 Phase 3: Following tract improvements acceptance by Council, staff processed utility bill transfers and a CCWD (USBR) agreement for City-maintenance of two Delta De Anza Trail trailheads on CCWD property.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/ 'G' Street Overcrossing Project: 'G' Street bridge punch list and Contra Loma Blvd./ 'L' St. undercrossing work continues. A full closure of Contra Loma Blvd undercrossing will occur Wed., Aug. 5, 10 pm – 5 am. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Bridgework continues at 'A' St/Lone Tree Way and Cavallo Road undercrossings. A full closure of 'A' Street/Lone Tree Way undercrossing will occur Mon. - Fri., Aug. 10-14, 10 pm – 5 am. Pedestrians and motorists are advised to exercise caution while travelling through these areas.

- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Work continues on Slatten Ranch Road, the Hillcrest Avenue Bridge widening, westbound off- and on-ramps, Slatten Ranch Road signalized intersection, Pedestrian Overcrossing (POC) and Maintenance of Works (MOW) Tunnel. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a proposed 12" sanitary sewer main from the new Maintenance Facility, north of the S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing easement documentation. Staff returned comments to BART's Ownership and Maintenance of Utilities Agreement for storm drainage improvements.
- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: Staff is processing abandonment of existing easement.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The tentative map has been submitted and staff is creating conditions of approval.
- The Ranch, a proposed 1,667 unit housing development located between Deer Valley Road and Empire Mine Road: Staff is preparing comments for preliminary development plan.
- Heidorn Village, a proposed 117 unit housing development located at the northwest corner of Prewett Ranch Drive and Heidorn Ranch Road: The tentative map has been submitted and staff is creating conditions of approval.
- Quail Cove, a proposed 32 unit housing located on the south side of Prewett Ranch Drive west of Heidorn Ranch Road: The tentative map has been submitted and staff is creating conditions of approval.
- Lakeview Center, development of a new 11,598 square foot medical office building located at the corner of Lone Tree Way and Golf Course Road: Plans have been approve and we are ready to issue permits.

Capital Improvements Division

- Marina Boat Launch Facility, Third Boarding Float: Topper Industries has commenced off-site construction of the boarding float. Valentine Corporation is scheduled to install the facility in mid-August.
- Curb, Gutter and Sidewalk Repair Program: Anchor Concrete continued to remove and replace deteriorating, damaged and uneven concrete throughout the city. Over the past week, a total of 398 square feet of sidewalk, 290 square feet of driveway approach and 93 lineal feet of curb and gutter were replaced.
- West Antioch Creek Channel Improvements: California Department of Fish and Wildlife is drafting a revised Routine Maintenance Agreement. The State Historical Preservation Office is reviewing the updated Cultural Resource Inventory report. U.S. Army Corps of Engineers is preparing a public notice to parcels in the vicinity

of the project. The Contra Costa County Public Works Real Property Division is continuing work associated with easement and property acquisitions.

- Water Treatment Plant Disinfection Improvements: Alternative Analysis Technical Memorandum submitted by CDM Smith has been reviewed internally. City Staff is scheduled to meet with the consultant next week to discuss the document.
- Sunset Booster Pump Station Replacement: Construction bids for this work were publically opened on August 4th. The lowest responsive bid was received from JMB Construction, Inc., in the amount of \$716,750. The award of this project is scheduled to be considered at the August 25th City Council meeting.
- Water Treatment Plant Electrical Upgrades: Requests for Proposals have been sent to CDM Smith, Eaton Corporation, GHD, TJC and Associates and YEI Engineers to conduct an extensive evaluation of the existing electrical systems at the City's Water Treatment Plant and develop plans and specifications for required facility upgrades. Consultant proposals are due August 6th.
- Urban Water Management Plan: Requests for Proposals have been sent to Brown & Caldwell, Carollo Engineers, CDM Smith, Risk Management Professionals and West Yost Associates to develop the 2015 Urban Water Management Plan, which addresses the City's long-term water demand, supply and resource management. Consultant proposals are due August 14th.
- Cathodic Protection Assessment: Requests for Proposals have been sent to Corrpro Companies, Inc., Farwest Corrosion Control Company, JDH Corrosion Consultants, Inc. and V&A Engineering Consultants, Inc. to conduct a thorough assessment of all pipeline cathodic protection systems within the City and draft a comprehensive report summarizing the findings and providing remediation recommendations for any deficiencies observed. Consultant proposals are due September 10th.
- 2015 Transportation Development Act (TDA) Grant: JD Partners is under contract to install 27 new curb ramps along Blue Rock Drive and West Tregallas Road. Construction is expected to begin on August 17th and completed by August 30th.
- Safe Routes to School Grant (Cavallo/Garrow/E. Tregallas curb ramps): J.J.R. Construction completed the installation of 85 curb ramps and sidewalk improvements along Cavallo Road, Garrow Drive, and East Tregallas Road and sidewalk improvements along Drake Street. The City Council will consider the final acceptance of the project at the August 25th meeting.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to update anticipated land uses and the transportation network to be used in the model. EPS will provide a public presentation and provide a study update at the August 11th City Council Meeting.
- Preventative Pavement Maintenance Program: MCK Services completed all the work on the "dig out" contract. The City Council will consider the final acceptance of the project at the August 11th meeting.
- Cavallo Road and Country Hills Drive Pavement Rehabilitation: MCK completed the paving work on Country Hills Drive and Cavallo Road and is in the process of

completing the striping work. Construction of the project is expected to be completed by August 17th.

- Prewett Water Park Improvements: RHAA is under contract for the design of the final improvements at Prewett Water Park. RHAA have completed the 50% design of the Spray ground and staff is in the process of reviewing the design. Construction is anticipated to start in January 2016 and be completed by June 2016.
- 2015 Rubberized Cape Seal: American Pavement Systems completed placing the rubberized chip rock and the final slurry seal layer. The contractor is in the process of replacing the striping. The City Council will consider the final acceptance of the project at the August 25th meeting.

- Sewer Mains: Daily preventative maintenance performed on over 30,858 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the hot spots.
- Sewer Lateral Maintenance Program (SLMP): Repaired one lateral that was severely damaged requiring immediate repairs. Crews also televised 18 laterals.
- Manhole Inspection Program: Crews inspected 46 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Closed Caption Televising (CCTV): The CCTV Preventative Maintenance inspects sewer mains to identify the condition and causes of blockages and Sanitary Sewer Overflows (SSOs). Crews televised 2,842 feet of sewer main lines.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 80 yards of debris and trash out of various creeks and channels. Crews also cleared 0.4 acres of weed abatement. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

She was issued a citation and released from the scene on her promise to appear for the charge of possessing under one ounce of marijuana.
