# **RECREATION UPDATES**

- The Antioch Water Park is in its final week of open hours for the 2016 summer season. Labor Day Weekend is the last chance to come out and enjoy the slides! Park hours will run from 11am-6pm Saturday, Sunday, and Monday. **BE COOL BY THE POOL!!** while it is still hot outside.
- Last week, staff began turning their attention to the 2017 Water Park season –
  evaluating programs and adjusting services, as well as planning for the new Spray
  Park! Marketing, promotions, group use, and new features will be the focus during
  the winter months.

- Last week, the Prewett Park construction projects made progress: the playground started installing play equipment and the spray park poured the concrete.
   Recreation staff continues to assist the CIP staff where needed to keep these projects moving forward in a timely manner.
- On Monday, The Antioch Community Center received a new refrigerator for its commercial kitchen (after the original one abruptly stopped working!).
- On Tuesday and Wednesday, The Aquatic Maintenance Worker attended the first section of Building Operator Certification Training. This month's topic was Energy Efficient Operation of building HVAC systems. This training was provided free of charge to the City through a partnership with East Bay Energy Watch.
- Over the summer, more than 3,000 people participated in classes and activities and enjoyed recreation experiences that inspires lifelong learning, builds relationships, and strengthens community connectedness. Registration is underway for all fall programs and classes.
- Last week, Preschool Staff held their quarterly training meeting in preparation for the new season of preschool classes. Staff discussed healthier snack foods for children, staffing needs, supplies and updating technology in the classrooms. Training was provided on helping young children adjust successfully to preschool and the effects of Separation Anxiety on families. Staff discussed new and creative ways to ease the apprehension parents and children experience when starting school including better ways to meet and greet families, reassurance, how to create a visual schedule for children to help them forecast when their parent is returning and more. Preschool classes begin the week of September 12<sup>th</sup> and registration is more than 50% full.
- Program registration began for the fall season of First Five Physical Education classes for children under 5. This partnership with First Five and the City of Antioch provides services to help children 0-5 reach their greatest potential.
- On average, 45 people are dropping in weekly for some active volleyball and basketball playing time. Tuesday night is volleyball from 7-9:30pm and Sunday is basketball from 12:30-2:30pm both taking place at the Antioch Community Center Gymnasium. Players must be 17 years of age or older and they enjoy a fast-paced well rounded fitness work out.
- City staff from several Departments Recreation, Environmental Resources, and Public Works spent last week getting the word out about the annual Coastal Clean Up Day on September 17, 2016 from 9:00am to Noon. Banners are in several places temporarily promoting the event. Staff is also planning and preparing three sites in Antioch for volunteers to collect garbage from the shoreline and creek channels. Come out to the Water Park, the Marina, or Fulton Shipyard Road to help clean our environment.

# Senior Center Services

• The power outage on Wednesday in the Historic District, along Second Street, affected the Senior Center and it closed for the day. As a result, 89 meals were redirected back to the County and could not be served in Antioch.

- Last week, only 325 meals were served through the C.C. Café because of the
  power outage. The daily lunch and socialization help prevent heart attacks,
  depression, asthma and congestive heart failure. No membership or income
  requirements are required to eat at the C.C. Cafe. Thursday's lunch was an exciting
  day as visitors re-told the story of the power outage.
- On Monday, one senior celebrated her 94<sup>th</sup> birthday at the Senior Center; pizza was shared among all interested members and family members joined the celebration.
- Last week, staff completed the PowerPoint video presentation of the September/October Newsletter for the big screen TV over the Nutrition desk.
- On Tuesday, Newsletter distribution was finalized:
  - 433 newsletters were mailed
  - 93 newsletters were emailed
  - 624 newsletters are at the center ready for pick-up
- Last week, Staff received Spanish books for the new Spanish class starting on Tuesdays and Thursdays between 10-11 am.
- There are 30 vendors registered for the Resource Fair including businesses, health organizations, non-profits, and medical practitioners within Antioch and throughout Contra Costa County. The Resource Fair is scheduled on September 30<sup>th</sup>. Mark your calendars!
- The Senior Citizen's Club raised more than \$1,000 at last week's *Hot August Nights* car show and dinner. The cars were nifty, the music hoppin' and the friendship excellent.
- To date the Senior Club has received new and renewal membership applications from 950 seniors.

# **Community Development Block Grant (CDBG):**

- The Consolidated Performance Evaluation Report (CAPER) for FY 2015-16 must be submitted to HUD by September 30th and preparation is underway.
- Preparation of the draft 2017-20 Analysis of Impediments to Fair Housing Choice for the entire county by the City of Richmond consultant has been slightly delayed, and will be considered by Council in late September or October.
- The Public Hearing to finalize the priorities will be held September 27th, and the 2017-20 Grant Cycle Kickoff will be held October 6th from 2-4 p.m. at the Concord Senior Center. New applications WILL be accepted at this time.

### Homeless:

The results of the Homeless Continuum of Care HUD Funding Round 2016 and Coordinated Entry project funding is expected to be made available next week.

Project Homeless Connect will be held at the County Fairgrounds in Antioch on Thursday, October 13th, from 9 am to 3 pm. Homeless Connect is a one-day, one-stop event that provides on-site healthcare, social services and housing resources to persons experiencing homelessness. ### Housing:

Over the past six months, the CDBG/Housing Consultant has been working with the Bay Area Affordable Homeownership Alliance (BAAHA) to design a First Time Homebuyer program for residents of the City of Antioch. This program would bring together existing subsidies from CalHFA, County Mortgage Credit Certificates, Federal Home Loan Bank (Wish Program), National Homebuyers Fund (NHF), GSFA Platinum Program, and possibly others. The goal is to create a package of subsidies which will allow existing Antioch renters to become first time homebuyers, which does NOT require an investment of City funds in each mortgage. Development of program components and securing of partners is nearing completion and the program is expected to be proposed to staff and Council within the next month.

# **Drought Updates:**

While this winter brought us enough rainfall and snow pack to make it through the dry season, conservation is still vital and many prohibited uses are still being enforced. Visit <a href="https://www.antiochwater.com">www.antiochwater.com</a> for the list of prohibited water uses.

# <u>Last Week's Irrigation Repairs and Service:</u>

- Parks Citywide: Water restrictions have been relaxed for your City Parks, however, reduced water use continues except at the Recycled Water Parks.
- City Park: The Rose Garden irrigation was repaired.
- Diablo West Park: A turf valve was repaired and 2 sprinklers replaced.
- Eagleridge Park: A leaking irrigation lateral was repaired.
- Jacobsen Park: 5 sprinklers were replaced.
- Prewett Water Park: A loaner irrigation controller was temporarily installed while the main board undergoes repairs.
- Williamson Ranch Park: 12 irrigation box covers were replaced.
- Contra Loma Blvd. 3 sprinklers repaired and 1 valve rebuilt.
- Deer Valley Rd. 3 sprinklers repaired, 2 valves rebuilt, 1 lateral line repaired and 2 bubbler stations removed from controller.
- Prewett Ranch Rd. 19 sprinklers repaired, 2 valves rebuilt, 1 molded cap replaced, 2 nozzles replaced and 1 valve replaced.
- Hillcrest Ave. 8 sprinklers repaired, 1 lateral line repaired and 1 valve replaced.
- Squaw Ct. 3 sprinklers repaired.
- Wildhorse Rd. 2 sprinklers repaired.
- Isabella Ct. 14 sprinklers repaired.
- James Donlon Blvd. 3 sprinklers repaired.
- Westridge Ct. 1 valve rebuilt.

### **PUBLIC WORKS UPDATES**

### Administration

• Tiered water rates are still in effect and were calculated to reflect the cost of service to treat and deliver water to the community. These rates were developed independent of the drought status and will remain in effect. The State has officially declared the drought is over and removed the 25% statewide water conservation goal. Beginning in June of this year, the City of Antioch is mandated to conserve water based on a three year projected "stress test" formula provided by the State. This will remain in effect until January 2017. Based on our results, we have a sufficient water supply for our water production rates and will not have a conservation target. The City of Antioch is no longer requiring restricted watering days. We still encourage all conservation efforts where possible to protect our valuable resource. All of the "prohibited water activities" as outlined by the State are

still in effect. This includes: washing off driveways and walkways, irrigating 48 hours after a measurable rainfall and irrigating in such a way that causes runoff to non landscaped areas. To see a complete list, search saveourwater.com or other similar websites on the California drought. Water customers did a fantastic job with their water conservation efforts. We were able to meet our State mandated goal of 28%. Thank you all for the conservation efforts and success we achieved. Please continue to protect this precious and limited resource.

# **Engineering & Development Services**

- City-owned cell sites, various locations: Staff is performing site visits and review of land leases, 100% construction drawings, consent letters, photo-sims and related technical reports and materials in response to various applications for equipment upgrades and site modifications.
- Delta Courtyard Apartments, located at 701 and 810 Wilbur Avenue, a proposed 126-unit multi-family apartment complex: Staff is preparing conditions of approval for Pacific West Communities' application. A Planning Commission hearing is scheduled for September 7<sup>th</sup>.
- The Habit Burger, a new restaurant development, located at 2424 Mahogany Way: The project was approved at the July 20<sup>th</sup> Planning Commission meeting. Staff is reviewing construction drawings for building permit issuance.
- Laurel Ranch, a 180-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: The project was recommended to the City Council for approval at the July 20<sup>th</sup> Planning Commission meeting.
- Olive Groves Subdivision, 263 single-family detached senior housing units with assisted living facility, commercial uses and open space, south of Sand Creek, east of Deer Valley Road: Residential portion gated with private streets. Staff is preliminarily reviewing the PDP-16-01 application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The subdivision plan and map checks have been completed and staff is working with the developer to form a district to fund offsite improvements. Staff is reviewing proposed Slatten Ranch Road infrastructure improvements.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project has been accepted by the State. City staff is working with Caltrans to complete the City punch list.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow
  Drive Undercrossing Project: City staff is working with Caltrans to complete the
  punch list. There will be lane closures in both directions on A Street/Lone Tree Way
  between Rossi Ave. and E. Tregallas Rd. from 9 am to 3 pm. The signal at
  Sunset/A Street/Rossi is now working and the Sunset Dr. Extension between A
  Street and Bryan Ave. is open. Pedestrians and motorists are advised to exercise
  caution while travelling through these areas.

- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Staff
  prepared a punch list for Caltrans' contractor to complete. There will be lane
  closures in both directions on Hillcrest Avenue between Larkspur Drive and Sunset
  Drive from 9:00 am to 3:00 pm. Pedestrians and motorists are advised to exercise
  caution while travelling through the construction area.
- Vineyard Self-Storage, located at E. 18<sup>th</sup> Street/Vineyard Drive: Staff is preparing conditions of approval for American Recess' application. A Planning Commission hearing is scheduled for September 7<sup>th</sup>.
- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff has reviewed the 3<sup>rd</sup> submittal for the first phase of construction documents and returned the plans and other documents for revisions.
- Staff is working with the developers to create Community Facilities Districts for Sand Creek Focus Area landscape maintenance.
- Tabora Gardens, a senior apartment complex on James Donlon and Tabora Drive: Staff has completed our review of the plans, reports and other documents and will be issuing an encroachment permit.
- Child Care Education Building in Williamson Ranch Plaza: Staff has returned the plans with comments. We are waiting for quitclaim of easement from Contra Costa County Flood Control District.
- 326 Nash Avenue: The owner/applicant is requesting to merge parcels. We are working with the applicant to take the merger to the Planning Commission for approval.

# Capital Improvements Division

- Country Hills Drive and Vista Grande Drive Water Main Replacement: A-S
  Pipelines, Inc. has completed construction of the project. As-built drawings and
  cathodic protection reports are being finalized.
- Sunset Booster Pump Station Replacement: JMB Construction has installed the underground piping and electrical facilities. The concrete floor slab and adjacent flatwork has been placed.
- Zone I Transmission Pipeline Rehabilitation at HWY 4: RMC Water and Environment is incorporating the City's comments into the contract documents. A final design workshop will be conducted in early September.
- Downtown Sanitary Sewer Rehabilitation: Staff is developing draft project plans and specifications.
- Water Treatment Plant Disinfection Improvements: CDM Smith is preparing design documents that include the use of non-diluted sodium hypochlorite and ammonia sulfate.
- Brackish Water Desalinization Plant: Carollo Engineers is developing a revised facility layout. State Water Resources Control Board continues to review the City's State Revolving Fund loan application.
- North East Annexation Infrastructure Improvements: BKF Engineering is now under contract to provide engineering services and preliminary plans, estimates and

- studies for the planning and the design of infrastructure improvements needed to serve Annexation Areas 1 and 2B.
- 2016 Pavement Management Program: MCK Services, Inc. completed the pavement rehabilitation activities throughout the City and is working on replacing the traffic signal loops. The project included improvements to major arterial streets such as Lone Tree Way, James Donlon Blvd., Somersville Road, Buchanan Road, Golf Course Road, and Hillcrest Ave., and various residential streets north of Highway 4. The project is expected to be completed by the end of August and accepted by the City Council at the September 27, 2016, meeting.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to
  finalize the land use forecasts, the transportation improvement list, the network to
  be used in the traffic model, and proposed fee. EPS is developing several
  scenarios for the fees; the final draft Fee Study is scheduled to be presented to the
  City Council for public review and comments before the end of the year.
- Prewett Water Park Improvements: Sierra Valley Construction continues to work on the playground and the spray ground facilities. Both projects are scheduled to be completed in September 2016.
- Rubberized Cape Seal Program: The Department of Resources Recycling and Recovery (CalRecycle) issued a Notice of Grant Funds available for Rubberized Cape Seal projects for FY 16-17 for the maximum grant amount of \$350,000. The grant application due date is October 26, 2016.

# Water Treatment Plant

- Repaired the filter to waste valve on #5 filter. Cleaned all components and replaced O-rings and gaskets.
- Cleaned out the sludge drying beds at the holding pond.
- Installed a new motor to the basin drive equipment on "A" plant basin.
- Treated the municipal reservoir for algae control. Algae blooms contribute to taste and odor problems in the treated water.

### Water Distribution

- Water Distribution staff had 207 stops for water service including disconnections.
- Water Distribution staff had a total of 104 USA tickets completed for utility location.
- Water Distribution meter reading is now complete for the month of August.
- The City of Antioch now has a 0% water conservation goal through January of 2017 based on the State of California's "stress test". However the following prohibitions will remain in place:
  - Watering outdoor landscapes in a manner that causes excessive runoff, such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures.
  - Using a hose without a shut off nozzle.
  - Washing paved or other hard-surfaced areas, including sidewalks, walkways, driveways, patios and parking areas.

- Use of City furnished water for non-recalculating decorative fountains or filling decorative lakes or ponds.
- Failing to repair a controllable water leak.
- Staff continues to monitor water meters and usage at all City buildings and parks for water conservation.
- Staff continues to respond to drought hotline inquiries.
- Staff responded to customer calls regarding water maintenance issues city wide.
- Staff replaced two water services on Hillside Road.
- Staff replaced a hydrant on Gentrytown Drive.
- Staff replaced a water service on Buckeye Court.
- Staff replaced a water service on Crestwood Drive.
- Staff is now performing a proactive leak detection program.
- State mandated annual backflow testing program is on schedule.
- Staff performed city wide preventative maintenance on fire hydrants and water quality flushing.
- Staff hauled off green waste, asphalt and concrete for recycling, as well as cleaned up debris at the city's Fulton yard.
- Central Stores staff removed several bags of household debris and furniture from Fulton Shipyard Road boat launch ramp area.
- Staff ordered two new specialty locks for PD/Facilities Maintenance.

# Public Works Operations – Parks and Landscape

- Playground and Park Safety Inspections: Completed at City, Country Manor, Deerfield, Fairview, Jacobsen, Knoll and Meadow Creek Parks. Park follow up inspections performed at Dallas Ranch and Prewett Water Park.
- Restroom Locks: Repaired at Almondridge, Harbour and Mira Vista Parks.
- Almondridge Park: The men's restroom was repaired and reopened.
- City Park: The rose garden irrigation was repaired.
- Diablo West Park: A turf valve was repaired and two sprinklers replaced.
- Eagleridge Park: A leaking irrigation lateral was repaired.
- Jacobsen Park: Five sprinklers were replaced.
- Prewett Water Park: A loaner irrigation controller was temporarily installed while the main board undergoes repair.
- Williamson Ranch Park: Twelve irrigation box covers were replaced.
- Tree Removal Permits: Approved at 1935 Birch Ave. and 18 West Madill Street.
- Irrigation: Repaired 60 irrigation leaks on City property as needed.
- Trim Crews: Worked in the areas of Hillcrest Ave., Mt. Hamilton Dr., Deer Valley Dr. right of way, E. 18<sup>th</sup> St., Lexington Trail, Country Hills Dr., Police Department, and Davison Dr. Medians.
- Spot Spray: Empire Rd., Golf Course Rd., Wilbur Ave., Slatten Ranch Rd., and Cañada Valley Rd.
- Tree Removal: Country Hills Dr.

# Public Works Operations - Street Maintenance

- Graffiti: Crews removed graffiti from numerous areas around the City.
- Signs: Crews replaced 21 existing signs due to poor reflectivity or line of sight issues.
- Red Curb: Crews continue to prep red curb for painting on Verne Roberts Circle.
- Crews painted three miles of red curb in other areas citywide.
- Buttons: Crew replaced 2,675 raised markers on Lone Tree Way and Golf Course Road.
- Potholes: Filled four potholes.
- Road Stencils: Crews restriped intersections at Davison Drive at Lone Tree Way and James Donlon Boulevard at Lone Tree Way. 1,850 pounds of thermo were used to complete this work.

# Public Works Utilities - Collections Division

- Calls for Sewer Service: Received and responded to two calls for service from the public. Responding crews televised 70 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 21,215 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified priority locations and integrate a proactive preventative cleaning schedule for these pipelines.
- Sewer Lateral Maintenance Program (SLMP): Crews televised two sewer laterals.
- Manhole Inspection Program: Crews inspected 105 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are continually updating the program and processes for integration in our computerized maintenance management system.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of "SMART Manholes" in strategic areas will be utilized that will alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 314 yards of trash and green waste. Assisted Code Enforcement with 72 yards of debris from homeless encampments. Abated 1.1 acres of weeds from bank to low water line in channels. Inspected 16 storm catch basins. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

# Public Works Operations - Fleet Division

- Preventative Maintenance: 14 services on City vehicles as scheduled.
- Unscheduled Repairs: 66 unscheduled necessary repairs to City vehicles.

# Public Works Operations – Municipal Marina

- The Marina received two applications for permanent berthing, responded to four berthing inquiries and provided one facility tour.
- Maintenance: Continued to paint several kneeboards on B dock. Removed graffiti, and trimmed bushes and trees on trail by sails structure.
- Filming of "Forgotten Evil" is scheduled for this week to take place in and around the Antioch Marina.
- Marina self-automated fuel dock is now open from 6 am-10 pm daily, offering boaters greater fueling flexibility and service.
- Staff arranged with Westar Marine Services to provide fuel for workboats while
  working in the west Delta. Several workboats will be purchasing fuel using the selfpay kiosk over the next several weeks. Staff also arranged to provide fuel and
  overnight stay once per month for the USGS workboat collecting samples in the
  bay.
- Advertising and Outreach: Approved advertisements placed in Yachtsman magazine reaching over 40,000 boaters. Craigslist advertisements placed in Bay Area, Stockton, Sacramento, Monterey, and Santa Cruz listings. Advertising Annual Boat Launch Ramp Passes for \$100 and our new automated self fueling station on Craigslist.

- Public Works: Assembled shed for the Distribution division.
- City Hall: Fabricated a metal panel for exterior outlets to protect against vandalism.

### POLICE DEPARTMENT UPDATES

During the search of Ward's person a .22 Caliber revolver was located in his right front short pocket. The gun was loaded with 5 live and 1

- spent rounds. Ward was found to have a prior felony arrest with time served in prison. Ward was arrested and sent to county jail.
- On 8/26/2016 at 10:54 am, 26 year old Nathan Watson was contacted during a pedestrian stop near 20 W 18<sup>th</sup> St. and found to have two warrants for his arrest. Both were misdemeanor warrants. Watson was arrested and transported to county jail.

The same vehicle was seen leaving the scene. Both cases are still under investigation.

Later in the shift, an officer spotted the motorcycle and a traffic stop was made. 27 year old Moises Sanchez yielded and was taken into custody without incident. Sanchez admitted to taking the motorcycle thinking it was okay since he had just met the victim at church tonight and now they know one another. The victim disagreed did not see it that way and wanted Sanchez prosecuted. Sanchez was booked into county jail for auto theft.

Upon arrival, the 28 year old victim was up and walking around in a great deal of pain. The only information we got from him was a black SUV struck him in the roadway. He was extremely uncooperative with the investigation and his friends insisted on taking him to the hospital themselves. At the end of the shift, the victim was in fair condition and expected to make a full recovery. Area witnesses reported seeing the vehicle swerving all over the road just prior to the accident.
- On 8/25/2016 at 5:31 pm, officers were working a proactive detail in the area of W 9<sup>th</sup> St. and G St. and observed 41 year old Jesus Bustamante's vehicle go through a stop sign. A license plate check showed the car to be expired, however the vehicle showed current registration. The officers made an enforcement stop and when they tried to approach, the vehicle fled. The officers lost sight on the vehicle but in doing

an area check they relocated the vehicle which had rolled in the intersection of W 11th St. and E St. The male driver fled the scene leaving a passenger in the car. The passenger received minor injuries in the crash. A perimeter was set up in the surrounding area. Eventually, Bustamante was seen coming out from a backyard and taken into custody without incident. He stated the reason he fled was due to a warrant he knew he had. Luckily no other vehicles or pedestrians were involved. Bustamante was sent to county jail for reckless driving, hit and run as well as the warrant.
