#### **RECREATION UPDATES:**

- On Saturday, nearly 250 people participated in Coastal Clean Up Day! The Antioch Water Park hosted 59 community members who helped clean the trail and creek behind the Water Park. Trash collected at this site alone filled one three-yard dumpster and weighed 300 pounds!
- Last week, all levels of Water Park staff collaborated to begin planning for 2017, including hiring and rehiring, marketing and promotions, training and operations, and improving customer retention and increasing revenue.
- Archiving the 2016 season continued by adding new folders, binders and files for registration forms, swim lessons, group use and more. To improve customer service, staff will retain sign-in sheets and Red Cross swim lesson cards for two seasons so that participants can advance in swim skills correctly, and sustain their learn-to-swim skills.
- On Monday, 27 new students began the final session of weekday swim lessons for 2016. Classes will run through mid October on Mon/Wed/Fri. The 83 students enrolled in Saturday classes will continue to run through mid October.
- On Tuesday, staff announced a new Water Safety Instructor course for lifeguards interested in teaching swim lessons. The course will run during October and train new swim instructors for the spring swim lesson program.
- Throughout the week, Water Park staff continued program planning for 2017 lifeguard training classes, CPR classes, swim lessons, and drop-in classes. Due to the popular demand for private swim lessons, semi-private lessons will be offered when swim lessons return next April.
- Last week, staff created program descriptions for the 2017 Winter/Spring recreation guide. A new series of teen night events will be introduced in the guide; these events will focus on safe and fun evening activities for middle and high school students!

- On Wednesday, staff designed and submitted a new Antioch Council of Teens
  (ACT) section for the City website. This addition to the recreation page is slated to
  be up and running by the end of the month.
- On Wednesday, the Aquatic Maintenance Worker attended the third day of the Building Operator Certification training series. Skills learned in this seminar will help the Department better utilize free resources to reduce the department's impact on the environment.
- On Thursday, Recreation Maintenance Staff completed periodic filter maintenance for the Lap Pool and continued work on Water Park winterization.
- Throughout the week, the City's M&O team worked on issues surrounding the opening of the new projects at Prewett Community Park. An irrigation clock was repaired, plans were discussed for various landscape revitalization projects, and various suppliers were contacted for necessary materials.
- On Sunday, 17 individuals participated in the first Pickleball drop-in hour at the Antioch Community Center gymnasium. There is one more free drop-in day this Sunday for anyone interested in learning about Pickleball.

## Senior Center Services

- Over the last week, 433 affordable, healthy meals were served through the C.C. Café. This program helps prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the C.C. Cafe. Staff collected daily nutrition deposits and submitted them to finance. All supplies are provided by the County for participating cafes.
- Last week, more than 60 seniors participated in one of the three group exercise classes. These classes work to promote movement and activity for seniors. The exercise programs take place on Mondays, Wednesdays and Fridays.
- On Monday, Matthew Hart, a Wills Attorney, made his monthly visit to the Senior Center. Matthew met with clients to discuss future planning.
- On Tuesday, 12 seniors joined the Computer class which resumed after a one week break. Class topics focused on computer basics and becoming familiar with the computer.
- On Wednesday, 18 seniors enjoyed the movie 'Hail Caesar' with George Clooney and Josh Brolin. Popcorn and drinks were enjoyed by all.
- The Senior Resource Fair is the talk of the Senior Center! The Fair is sold out; more than 40 vendors including businesses, health organizations, non-profits, and medical practitioners within Antioch and throughout Contra Costa County. The Resource Fair is scheduled for next Friday, September 30th.
- To date the Senior Club has received a total of 964 applications from seniors for both new and renewal memberships.

removed close to 2,000 pounds of debris, including two large pontoons weighing several hundred pounds each! A special thanks to the Dow Wetlands crew and Delta Kayak Adventures for partnering with us in this effort. Thank you to RC Ferris from Republic Services for leading the land activities, including transporting 250 pounds of miscellaneous debris from the boat launch to the dumpster.

## **Community Development Block Grant (CDBG):**

- The Consolidated Performance Evaluation Report (CAPER) for FY 2015-16 is available for public review, and will be submitted to HUD by September 30<sup>th</sup>.
- The Public Hearing to finalize the priorities will be held September 27<sup>th</sup>, and the 2017-20 Grant Cycle Kickoff will be held October 6<sup>th</sup> from 2-4 p.m. at the Concord Senior Center. New applications WILL be accepted at this time.

## **Homeless - Transforming the Homeless System of Care:**

With planning completed, funding secured, and the "Coordinated Entry" grants awarded (see last week's report), agencies and the County are entering into contract and posting for new positions that will help transform the homeless system of care. Following are some highlights:

- The Contra Costa Crisis Center will provide 24/7 telephone access for homeless persons seeking shelter and/or services. They will make referrals to the new CARE and CARE-capable centers, referrals to safety net and other social services, and administer the new Housing Security Fund to assist homeless people with expenses related to obtaining housing. The Crisis Center will also be screening callers and attempt to prevent persons from becoming homeless, and divert them from the Contra Costa homeless system if possible, as well as triaging calls.
- CORE (Coordinated Outreach, Referral & Engagement) Homeless Outreach teams will begin to operate on the streets in the next two months. The system is starting with two daytime outreach teams and one night team, but this is scalable to meet each city's need and budget if they wish to contribute to fund additional coverage. The day teams will be hitting the streets Monday through Friday from 7:00 a.m. until 6:00 p.m., while the one evening outreach team will pick up from 5:00 p.m. to 1:00 a.m. All teams will have one coordinator and standards of engagement. They will link homeless persons to healthcare services, screen them for eligibility for benefits and enroll them, take them to any open shelter beds and to the new warming centers, and provide linkage to mental health and substance abuse services. They will also conduct a standard assessment to prioritize persons for permanent housing.
- The CARE Center sites will provide critical supportive services, such as showers, food, mail services, laundry, and act as warming centers during the evenings. Case managers will also connect clients to primary and behavioral health services, enroll them into benefits, and provide housing navigation services. Care Centers will be open from 8:00 a.m. until 5:00 p.m., and are situated in Concord, Walnut Creek, and Richmond. A site is being sought for East County, with a target for operation within the year.
- Warming Center Pilot A pilot Warming Center will open in Concord with hours from Monday through Saturday, 7:00 p.m. to 7:00 a.m. There, homeless clients will receive screening and intake, housing assessment, food and showers, as well as a safe environment and chairs in which to rest.

Areas of future growth include expansion of CORE teams, additional CARE Centers, especially in East County, enhancement of all CARE Centers with warming centers, seven day per week operation, a "Moving On" program, and more affordable housing units.

<u>Project Homeless Connect</u> - Project Homeless Connect will be held at the County Fairgrounds in Antioch on Thursday, October 13<sup>th</sup>, from 9 am to 3 pm. Homeless Connect is a one-day, one-stop event that provides on-site healthcare, social services and housing

## Last Week's Irrigation Repairs and Service:

- Contra Costa County Public Works Department will perform roadwork on Vasco Road from the Alameda County line north to Camino Diablo Road on September 28 and 29, 2016. The work will occur between the hours of 9:00 a.m. and 4:00 p.m. to

replace roadway delineators. The purpose of the delineators and rumble strips is to increase driver awareness and safety when travelling through this commute corridor. The work may be rescheduled based on weather conditions. Electronic message boards will alert drivers of the scheduled work. There will be traffic control through the work area and motorists can expect delays.

- City-owned cell sites, various locations: Staff is performing site visits and review of land leases, 100% construction drawings, consent letters, photo-sims and related technical reports and materials in response to various applications for equipment upgrades and site modifications.
- Delta Courtyard Apartments, located at 701 and 810 Wilbur Avenue, a 126-unit multi-family apartment complex: The project was approved at the September 7<sup>th</sup> Planning Commission meeting.
- The Habit Burger, 2424 Mahogany Way: New restaurant development. The project was approved at the July 20<sup>th</sup> Planning Commission meeting. Staff is reviewing construction drawings for building permit.
- Nelson Ranch Subdivision 6893, end of Wildhorse Road: Staff performed a site inspection and provided a punchlist in response to the developer's request for release of the warranty bond.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The subdivision plan and map checks have been completed and staff is working with the developer to form a district to fund offsite improvements. The developer has applied for an "at-risk" grading permit. Staff is reviewing proposed Slatten Ranch Road infrastructure improvements.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project:
  The project has been accepted by the State. City staff is working with Caltrans to
  complete the punchlist.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow
  Drive Undercrossing Project: City staff is working with Caltrans to complete the
  punchlist. There will be lane closures in both directions on A Street/Lone Tree Way
  between Rossi Ave. and E. Tregallas Rd. from 9 am to 3 pm. Pedestrians and
  motorists are advised to exercise caution while travelling through these areas.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Staff
  prepared a punchlist for Caltrans' contractor to complete. City staff is working with
  the CCTA to complete the punchlist. There will be lane closures in both directions
  on Hillcrest Avenue between Larkspur Drive and Sunset Drive from 9:00 am to 3:00
  pm. Pedestrians and motorists are advised to exercise caution while travelling
  through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a proposed 12" sanitary sewer main from the new Maintenance Facility, north of the S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing grant deeds for public easement dedications. Staff returned comments to BART's

- Ownership and Maintenance of Utilities Agreement for storm drainage improvements.
- Vineyard Self-Storage, located at E. 18<sup>th</sup> Street/Vineyard Drive: The project was continued at the September 7<sup>th</sup> Planning Commission meeting.
- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff has reviewed the 3<sup>rd</sup> submittal for the first phase of construction documents and returned the plans and other documents for revisions.
- Staff is working with the developers to create Community Facilities Districts for Sand Creek Focus Area landscape maintenance.
- Tabora Gardens, a senior apartment complex on James Donlon and Tabora Drive: Staff has completed our review of the plans, reports and other documents and issued an encroachment permit for the project.
- Child Care Education Building in Williamson Ranch Plaza: Staff has returned the plans with comments. We are waiting for quitclaim of easement from Contra Costa County Flood Control District.
- 326 Nash Avenue: The owner/applicant is requesting to merge parcels. The merger was approved by the Planning Commission at their Wednesday September 21<sup>st</sup> meeting.

## Capital Improvements Division

- Country Hills Drive and Vista Grande Drive Water Main Replacement: A-S
  Pipelines, Inc. has completed all work associated with this project. Acceptance of
  this work is scheduled to be considered at the September 27<sup>th</sup> City Council meeting.
- Sunset Booster Pump Station Replacement: The pump station building and equipment is scheduled to be installed next week.
- Zone I Transmission Pipeline Rehabilitation at HWY 4: RMC Water and Environment is incorporating the City's recent comments into the contract documents.
- Downtown Sanitary Sewer Rehabilitation: Staff is developing 90% draft project plans and specifications.
- Water Treatment Plant Disinfection Improvements: CDM Smith is preparing design documents that include the use of non-diluted sodium hypochlorite and ammonia sulfate
- West Antioch Creek Channel Improvements: Condemnation negotiations are proceeding regarding acquisition of property and easements located at 1400 and 1420 West 10<sup>th</sup> Street. U.S. Fish and Wildlife Services' review of this project's Biological Assessment continues to be delayed by the agencies current focus on the CA WaterFix project.
- Water Treatment Plant 'A' Electrical Improvements: TJC and Associates is developing the 90% draft project plans and specifications for electrical modifications to Plant A of the Water Treatment Plant.

- Brackish Water Desalinization Plant: Carollo Engineers is developing a revised facility layout. State Water Resources Control Board continues to review the City's State Revolving Fund loan application.
- Northeast Annexation Infrastructure Improvements: BKF Engineering is now under contract to provide engineering services and preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve Annexation Areas 1 and 2B. BKF will set up a Kick Off meeting with staff in October.
- 2016 Pavement Management Program: MCK Services, Inc. completed the
  pavement rehabilitation activities throughout the City. The project included
  improvements to major arterial streets such as Lone Tree Way, James Donlon
  Blvd., Somersville Road, Buchanan Road, Golf Course Road, and Hillcrest Ave.,
  and various residential streets north of Highway 4. The project is expected to be
  accepted by the City Council at the September 27, 2016, meeting.
- Transportation Impact Fee Study: EPS is developing several scenarios for the fees; the final draft Fee Study is scheduled to be presented to the City Council for public review and comments before the end of the year.
- Prewett Water Park Improvements: Sierra Valley Construction continues to work on the playground and the spray ground facilities. Both projects are scheduled to be completed this month.
- Antioch Pavement Management Street Survey: AMS Consulting Services will
  perform a comprehensive City wide pavement condition survey of all city streets.
  Inspection of the pavement condition will be done using Mobil Mapping System
  equipment. The mobile mapping vehicle will start the citywide pavement inspection
  in September and completed by November 2016.

## Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower.
- Completed installing scaffolding at the river pump pier. Welder will come in to make repairs on the river pump discharge pipe line.
- Pulled 500 feet of electrical wire to install a switch that will provide the option to run SCADA receiving power from Plant 'A' or Plant 'B'.
- For security we have removed several trees that run along the plant entrance. This will allow better camera surveillance along the plant perimeter.

### Water Distribution

- Water Distribution staff had 176 stops for water service including disconnections.
- Water Distribution staff had a total of 37 USA tickets completed for utility location.
- Water Distribution meter reading is now complete for the month of September.
- Water Distribution issued three drought notices this week.

- The City of Antioch now has a 0% water conservation goal through January of 2017 based on the State of California's "stress test". However the following prohibitions will remain in place:
  - Watering outdoor landscapes in a manner that causes excessive runoff such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures.
  - Using a hose without a shut off nozzle.
  - Washing paved or other hard-surfaced areas, including sidewalks, walkways, driveways, patios and parking areas.
  - Use of City furnished water for non-recalculating decorative fountains or filling decorative lakes or ponds.
  - Failing to repair a controllable water leak.
- Staff continues to monitor water meters and usage at all City buildings and parks for water conservation.
- Staff continues to respond to drought hotline inquiries.
- Staff responded to customer calls regarding water maintenance issues city wide.
- Staff replaced damaged hydrant on 2<sup>nd</sup> St. and Hillcrest Ave.
- Staff and contractor repaired a 16' water main on Hillcrest Ave.
- Staff replaced section of water main on Roosevelt Way.
- Staff replaced a water service on Danberry Ct.
- Staff repaired a water service on Felicia Ct.
- Staff replaced a water service on Madrone Street and Gatter Dr.
- Staff now performing proactive leak detection program.
- State mandated annual backflow testing program is on schedule.
- Staff performed city wide preventative maintenance on fire hydrants and water quality flushing.
- Staff hauled off green waste, asphalt and concrete for recycling, as well as cleaned up debris at the city's Fulton yard.
- Central Stores staff removed debris and graffiti from Amtrak platform.
- Central Stores staff removed several bags of household debris and furniture from Fulton Shipyard Rd. boat launch area.
- Central Stores staff replaced door hardware on storage area at Community Park.

- Graffiti: Crews removed graffiti from numerous areas around the City.
- Signs: Crews replaced nine existing signs due to poor reflectivity or line of sight issues.
- Red Curb: Crews continue to prepare for red curb painting on G St. and Sunset Dr. Crews painted 27,720 feet (5.25 miles) of red curb.
- Lane Delineators: Crews replaced 650 raised pavement markers.
- Potholes: Filled three potholes.
- Debris: Crews removed 1.5 yards of debris in roadway.

### Public Works Utilities – Collections Division

- Calls for Sewer Service: Received and responded to ten calls for service from the public. Responding crews televised 105 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 5,714 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified priority locations and integrate a proactive preventative cleaning schedule for these pipelines.
- Sewer Lateral Maintenance Program (SLMP): Repaired one lateral that was severely damaged requiring immediate repair and televised three laterals.
- Manhole Inspection Program: Crews inspected 52 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Closed Caption Televising (CCTV): Crews televised 5,714 feet of sewer main lines this past week. The CCTV Preventative Maintenance inspects sewer mains to identify the condition and causes of blockages and SSOs.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff has located strategic areas within the collections system manholes to place SMART Manhole Monitoring

- Devices and staff is currently installing them. The tentative start date for live system monitoring is October 11, 2016. The use of "SMART Manholes" in strategic areas will be utilized to alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 284 yards of trash and green waste from the Vineyard Basin. Assisted Code Enforcement with removal of 40 yards of debris from homeless encampments. Coastal Cleanup crews removed 40 yards of trash and debris. Abated one acre of weeds from bank to low water lines in channels. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

### Public Works Operations – Fleet Division

- Preventative Maintenance: 15 services on City vehicles as scheduled.
- Unscheduled Repairs: 66 unscheduled necessary repairs to City vehicles.

Officers arrived in the area and located one subject, 20 year old Tevin Herron, who appeared to be acting as a look-out on Country Hills Dr. and Chism Way. As officers attempted to get into position to contact him, they lost sight of Herron. Officers found Herron again

walking on Country Hills Dr. and Hillcrest Ave. but now he was with three other males. Officers attempted to contact the males, but three took off running. Herron stopped and was detained. Officers chased one of the males on foot from Country Hills Dr., through Wal-Mart, around several other businesses and then up the hill behind the skate park where he was caught. The other two males were not located. Herron admitted the other three males were getting ready to break into a house. A homeowner in the 4800 block of Chism Way approached officers at the scene and advised the officers their house had been burglarized. The resident showed officers a photo saved from their Ring.com doorbell system and it was a picture of Herron. Herron was questioned about the crime and he admitted to it. Herron was ultimately booked into county jail. Herron and the second subject that was detained are from the same neighborhood in San Francisco, however, they claimed not to know each other. Officers are still looking into the possibility they committed other burglaries in the area. The second subject was released pending further investigation.

- 9/18/2016 at 6:08 am, a vehicle travelling on Davison Dr. near Harris Dr. left the roadway and struck a PG&E power box which caused a fire. PG&E had to respond and cut the power before Contra Costa County Fire could extinguish the fire. There were no injuries in the collision.

The male suspect demanded money and brandished a pistol. When the clerk said he did not have any money, the male suspect put the gun away and ran out of the store. Smith was positively identified as committing the Las Brumas robbery also. The investigation is ongoing. Both males were booked into county jail.

- 9/15/2016 at 10:59 pm, 35 year old Curtis Jones was observed riding his bike on the sidewalk in the area of Hillcrest Ave. and Lone Tree Way in violation of Antioch municipal codes. An officer made an enforcement stop and discovered Jones was wanted out of San Francisco for theft related violations. Jones was taken into custody without incident. Jones was transported to county jail on the warrant and while at county jail, was found to be in possession of suspected methamphetamine. Jones was booked on the additional charges.

He was crossing at Gentrytown Dr. and Lopez Dr. when a vehicle driving northbound on Gentrytown Dr, struck them in the crosswalk. The driver stated a bus pulled from the nearby bus stop and its headlights had temporarily blinded him. He saw the grandfather pushing the stroller at the last minute and

- slowed to a couple miles an hour. He broadsided the stroller, just knocking it over. The infant was restrained in an attached car carrier that sits on the stroller. This was knocked loose and onto the ground. The baby was uninjured, but transported to the hospital as a precaution. The baby was released later in the shift with no notable injuries. Alcohol and speed were not factors.
- 9/15/2016 at 7:00 am, a US Postal Inspector requested we assist his unit with a search at a house in the 3200 block of Ashley Way. 54 year old Daniel Hard lives at the residence and is on parole. He is also a known criminal street gang member. We sent two units to be on the outside perimeter and for radio communications. During the search Postal Inspectors found over 1,000 stolen identities, a pistol, a stolen vehicle and methamphetamine. We agreed to book Hard into county jail for the Inspectors, so he can be held until he is indicted federally.
