RECREATION UPDATES

- On Saturday and Sunday, 18 teams from such cities as Napa, Vacaville, Petaluma and Elk Grove, participated in the annual “Swing for the Cure” baseball tournament as boys from the ages of 9 to 12 years competed against their rivals to be crowned the 2016 champions. All World Sports from Roseville, CA hosted this special event choosing the Antioch Community Park as its venue of choice.
- Last week, First Five of Contra Costa and the Antioch Recreation Department sports class program started. Mommy/Daddy Soccer and Tot Soccer Classes are being held at Contra Loma Estate Park. This successful ongoing partnership provides and supports local programs and services to help children 0-5 reach their greatest potential.
- Staff met to discuss the addition of new programs in the upcoming winter and spring quarter, ads for employee recruitment, and spring break opportunities for youth.
- Staff updated general liability insurance and endorsement forms for recreation contractors that share their expertise and teach classes and programs for residents of all ages.
- Last week, 14 residents participated in a Wills, Trusts and Estate Planning class at the Antioch Community Center. They learned the differences between Living Trusts & Wills, Durable Powers of Attorney, how to name guardians, joint tenancies, avoiding estate taxes, probate and more.
- On Wednesday, three Youth Scholarship applications were processed and two new applications were received.
- On Monday, the Antioch Council of Teens (ACT) held their monthly meeting. ACT discussed how to continue distributing teen friendly business nomination forms, winter event ideas, and welcomed 14 new interested members.
- On Tuesday, the new points system for the ACT was introduced; points will support teen participation in events and activities. Spreadsheets were made for easy tracking of points earned by members. A new structure was formulated that will create more leadership opportunities for teens.
- Last week, Recreation staff supported logistics planning for the upcoming teen hike and teen blanket drive.
- Last week, Water Park staff created a tracking system for all required information for HR and all American Red Cross certifications for part time staff. The new system will ensure that all records are regularly updated and that seasonal employees are aware of what is required for returning to employment.
- Last week, Water Park staff ordered hats for 2017 seasonal marketing and promotions.

- Through the week, the Aquatic Maintenance Worker collaborated as needed in the final stages of the spray ground construction project and on Wednesday, recreation staff witnessed the first spray of water when the spray grounds turned on! The water features are currently being adjusted for pressure, but all the features look great!
- On Tuesday, the Recreation Maintenance team collaborated with The City's Park Maintenance Landscape contractor to repair irrigation throughout Prewett Community Park with an emphasis on the areas surrounding the new all accessible playground.
- On Wednesday, Water Park Maintenance staff replaced a failed acid feeder for the Lap Pool. The previous unit provided a good service to the City for several years and was due to be replaced in the near future.
- On Wednesday, Recreation Maintenance staff removed illegal dumping and debris from Prewett Community Park.
- On Wednesday, Maintenance staff completed several winterization and clean up tasks at the Water Park complex.
- Last week, The City's slide repair vendor conducted repair work on the Humphreys slide surface. This work is part of our ongoing slide maintenance program.
- Last week, Recreation Maintenance staff installed new recycling bins in the parking lot at Prewett Community Park. This enhancement to the City's recycling program is a joint effort between Recreation and Environmental Resources.
- Last week, staff retained the services of a piano tuner for the piano in the Nick Rodriguez Community Center Theater.
- Last week, the Director of Parks and Recreation attended the National Recreation and Park Association Annual Conference in St. Louis, Missouri; attending several education sessions and visiting many parks.

Senior Center Services

- Last week, 388 affordable, healthy meals were served through the C.C. Café. This program helps prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the C.C. Cafe. All supplies are provided by the County for participating cafes.
- On Friday, the Annual Senior Resource Fair took place. More than 40 vendors and approximately 250 community members attended the Resource Fair. This was a positive event for our Senior Community.
- On Tuesday, Staff met with employees from Costco to inquire about a product donation for Monday, October 10th. The County nutrition program will be closed in observance of Columbus Day. The Antioch Senior Center and Senior Citizen's Club will be purchasing pizza and working with Costco for a donation of fruit and cookies to complete the meal.
- On Tuesday, the Antioch Senior Citizens Club Board of Directors met. Much of the conversation was centered around the current by-laws and the upcoming election. It was determined that any proposed amendments to the by-laws would need to be submitted by Monday, October 31st and that the election would take place following the general meeting on Tuesday, December 6.

- On Wednesday, 17 seniors enjoyed the movie “Saving Mr. Banks” with Tom Hanks for Movie Mania Day! Popcorn and drinks were enjoyed by all!
- On Thursday, Staff assisted with updating the Club’s by-laws. Once completed, they will be made available for the membership to review for the upcoming general meeting.
- To date the Senior Club has received a total of new and renewal membership applications from 970 seniors. For the months of October through December membership dues are dropped to half price (\$10.00). On January 1st they will be raised back to \$20.00 for the 2017 year.
- On Monday, staff reached out to CHP and inquired about a course that may reduce insurance cost for those 50 years and older.
- On Tuesday, staff participated in the Club’s Board of Directors meeting and suggested applying for a grant through the Antioch Community Foundation in order to offset the cost of transportation related with our upcoming outdoors group trips.
- On Wednesday, the club’s 3 musical classes (Ukulele, Hula and Line Dancers) provided the Antioch Senior Center with an hour long, Hawaiian themed performance. The event was enjoyed by more than 100 seniors and is clearly a reflection of an active, social and culturally diverse senior club.

Refreshments will be served.

Homeless:

- **Project Homeless Connect** – You still have time to volunteer at Project Homeless Connect, which will be held at the County Fairgrounds in Antioch on Thursday, October 13th, from 9 am to 3 pm. Homeless Connect is a one-day, one-stop event that provides on-site healthcare, social services and housing resources to persons experiencing homelessness. - **November is Homeless Awareness Month** – To educate and inform the public about homelessness in our County, the City's CDBG/Housing Consultant, Teri House, will be making presentations at City of Antioch, Pittsburg, Brentwood, and Oakley Council meetings in November.
- **Housing Security Fund Accepting Donations** - In partnership with the Richmond Community Foundation, Contra Costa is building a fund to help address many of the barriers people transitioning out of homelessness face, including deposits, credit check and other startup costs. Once active, the Contra Costa Housing Security

Fund will be able to cover those costs and also offer financial benefits to landlords who offer our clients an opportunity. The fund will be managed by a well-established community nonprofit and all participants will be pre-screened. **This fund will directly help get hard-to-place homeless persons off the streets and into housing with the services they need!**

Drought Updates:

This is a friendly reminder to reduce your watering days for fall (recommended maximum of 2 days/week-lawn, 1 day-shrubs).

Last Week's Irrigation Repairs and Service:

- Parks Citywide: Water use at our City Parks is in the process of being reduced to 50%, with water days also eliminated for our fall water programming reductions.
- Antioch Community Park: A leaking turf valve was replaced and at Baseball Field #3, a turf valve was repaired. A drinking fountain was also repaired.
- Antioch Water Park: A total of eight irrigation valves were repaired. An irrigation audit was completed for Controller 'A'.
- Contra Loma Estates Park: A leaking valve in the ivy was shut down pending repairs.
- Nelson Ranch Park: Two tree bubbler breaks were repaired and two drinking fountains unplugged.
- Deer Valley Rd.: 35 sprinklers repaired and two lateral lines repaired.
- Dallas Ranch Rd.: 22 sprinklers repaired, three molded caps replaced, four sprinklers adjusted and one valve rebuilt.
- 4th St.: One sprinkler repaired and five molded caps replaced.
- L St.: Seven sprinklers adjusted.
- Hillcrest Ave.: One valve rebuilt.
- Mokelumne Dr.: One nozzle replaced and one RP turned on.
- Davison Dr.: One new controller installed.
- Maintenance Service Center: Irrigation repeater put back on line.
- Police Department: Weather station serviced.
- Prewett Water Park: Weather station serviced, part on order.
- Golf Course Rd.: One sprinkler repaired, one nozzle replaced and one valve rebuilt.
- Laurel Rd.: Five sprinklers repaired, three nozzles replaced and one valve rebuilt.

- I St. Parking Lot: Four sprinklers repaired, three nozzles replaced, five sprinklers adjusted and three valves rebuilt.
- Lone Tree Way: One valve rebuilt.
- Comanche Ct.: One mainline repaired and one lateral line repaired.

PUBLIC WORKS UPDATES

Engineering & Development Services

- The Habit Burger, 2424 Mahogany Way: New restaurant development. The project was approved at the July 20th Planning Commission meeting. Staff is reviewing construction drawings for building permit.
- Nelson Ranch Subdivision 6893, end of Wildhorse Road: Staff performed a site inspection and provided a punchlist in response to the developer's request for release of the warranty bond.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The subdivision plan and map checks have been completed and staff is working with the developer to form a district to fund offsite improvements. The developer has applied for an "at-risk" grading permit. Staff is reviewing proposed Slatten Ranch Road infrastructure improvements.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project has been accepted by the State. City staff is working with Caltrans to complete the punchlist.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: City staff is working with Caltrans to complete the punchlist. There may be lane closures in both directions on A Street/Lone Tree Way between Rossi Ave. and E. Tregallas Rd. from 9 am to 3 pm. Pedestrians and motorists are advised to exercise caution while travelling through these areas.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Staff prepared a punchlist for Caltrans' contractor to complete. City staff is working with the CCTA to complete the punchlist. There may be lane closures in both directions on Hillcrest Avenue between Larkspur Drive and Sunset Drive from 9:00 am to 3:00 pm. Staff is working with Caltrans to improve the signal timings at the eastbound ramps and Larkspur/Tregallas. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a proposed 12" sanitary sewer main from the new Maintenance Facility, north of the railroad line to the southerly extension of Willow Avenue and is reviewing grant deeds for public easement dedications. Staff returned comments to BART's Ownership and Maintenance of Utilities Agreement for storm drainage improvements.
- Vineyard Self-Storage, located at E. 18th Street/Vineyard Drive: The project was continued at the September 7th Planning Commission meeting.

- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff has reviewed the 3rd submittal for the first phase of construction documents and returned the plans and other documents for revisions.
- Staff is working with the developers to create Community Facilities Districts for Sand Creek Focus Area landscape maintenance.
- Tabora Gardens, a senior apartment complex on James Donlon and Tabora Drive: Staff has issued an encroachment permit for the project.
- Child Care Education Building in Williamson Ranch Plaza: Staff has returned the plans with comments. We are waiting for quitclaim of easement from Contra Costa County Flood Control District. Staff has the approval to issue site work permit only before quitclaim of easements.
- 326 Nash Avenue: The owner/applicant is requesting to merge parcels. The merger has been approved by the Planning Commission. Staff is waiting for submittal of documents for review and recording.

Capital Improvements Division

- Sunset Booster Pump Station Replacement: JMB Construction has installed electrical and communication wiring. The new pumps and piping is being prepared for bacteriological testing.
- Zone I Transmission Pipeline Rehabilitation at HWY 4: City crews have performed additional exploratory excavations at the intersection of Drake and 'D' Streets.
- Downtown Sanitary Sewer Rehabilitation: Staff is developing 100% draft project plans and specifications.
- Water Treatment Plant Disinfection Improvements: CDM Smith is developing the 99% draft project plans and specifications.
- West Antioch Creek Channel Improvements: Condemnation negotiations are proceeding regarding acquisition of property and easements located at 1400 and 1420 West 10th Street. U.S. Fish and Wildlife Services' review of this project's Biological Assessment continues to be delayed by the agencies current focus on the CA WaterFix project.
- Water Treatment Plant 'A' Electrical Improvements: TJC and Associates are developing 90% draft project plans and specifications.
- North East Annexation Infrastructure Improvements: BKF Engineering is now under contract to provide engineering services and preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve Annexation Areas 1 and 2B. BKF will set up a Kick Off meeting with staff in October.
- Transportation Impact Fee Study: EPS is developing several scenarios for the fees; the final draft Fee Study is scheduled to be presented to the City Council for public review and comments before the end of the year.
- Prewett Water Park Improvements: Sierra Valley Construction is working on the fencing and finalizing the construction for the playground and the spray ground facilities. Both projects are expected to be completed by October 14, 2016.

- Rubberized Cape Seal Program: The Department of Resources Recycling and Recovery (CalRecycle) issued a Notice of Grant Funds available for Rubberized Cape Seal projects for FY 16-17 for the maximum grant amount of \$350,000. The grant application due date is October 26, 2016.
- Antioch Pavement Management Street Survey: AMS Consulting Services will perform a comprehensive City wide pavement condition survey of all city streets. Inspection of the pavement condition will be done using Mobil Mapping System equipment. The mobile mapping vehicle will start the citywide pavement inspection in September and completed by November 2016.
- James Donlon Retaining Wall Rehab: Staff completed the design and the project will be out for bid in October 2016. Construction is expected to start in December 2016 and completed January 2017.

Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower.
- Cleaned the Equalization tank. Removed all the solids and hosed down the walls.
- Lost communication to canal west. Found faulty power supply and installed new power supply.
- Cleaned all the chemical feed pumps on the Acti-Flow and centrifuge systems and replaced chemical feed tubing.
- Rebuilt Zone 2 ASCO valves to pump #2.
- Installed new discharge piping on the Acti-Flow train #2.

Water Distribution

- Water Distribution staff had 166 stops for water service including disconnections.
- Water Distribution staff had a total of 64 USA tickets completed for utility location.
- Water Distribution meter reading has now started for the month of October.
- Water Distribution issued one drought notice this week.
- The City of Antioch now has a 0% water conservation goal through January of 2017 based on the State of California's "stress test". However the following prohibitions will remain in place:
 - Watering outdoor landscapes in a manner that causes excessive runoff such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures.
 - Using a hose without a shut off nozzle.
 - Washing paved or other hard-surfaced areas, including sidewalks, walkways, driveways, patios and parking areas.
 - Use of City furnished water for non-recalculating decorative fountains or filling decorative lakes or ponds.
 - Failing to repair a controllable water leak.
- Staff continues to monitor water meters and usage at all City buildings and parks for water conservation.

- Staff continues to respond to drought hotline inquiries.
- Staff responded to customer calls regarding water maintenance issues city wide.
- Staff replaced a water service on Spruce Way.
- Staff repaired a mainline valve on Longview Rd.
- Staff installed a new recycled hydrant at Chichibu Park.
- Staff excavated utilities at Drake & “D” St. for installation of new 18” water main.
- Staff now performing proactive leak detection program.
- State mandated annual backflow testing program is on schedule.
- Staff performed city wide preventative maintenance on fire hydrants and water quality flushing.
- Staff hauled off green waste, asphalt and concrete for recycling, as well as cleaned up debris at the city’s Fulton yard.
- Central Stores staff removed debris and graffiti from Amtrak platform.
- Central Stores staff removed several bags of household debris and furniture from Fulton Shipyard Rd. boat launch area.
- Central Stores received new meter test bench for Water Distribution.
- Central Stores staff received new recycling equipment for the Environmental Services Division.

Public Works Operations – Street Maintenance

- Graffiti: Crews removed graffiti from numerous areas around the City.
- Signs: Crews replaced four existing signs due to poor reflectivity or line of sight issues.
- Red Curb: Crews continued to prepare for red curb painting on Contra Loma Blvd. and Buchanan Rd.
- Skin patch: Crews spent three days skin patching various streets.
- Crew assisted the Parks Department with its annual pre-emergent spray application.

Public Works Utilities – Collections Division

- Calls for Sewer Service: Received and responded to two calls for service from the public. Responding crews televised 70 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 16,799 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified priority locations and integrate a proactive preventative cleaning schedule for these pipelines.
- Sewer Lateral Maintenance Program (SLMP): Repaired two laterals that were severely damaged requiring immediate repair. Crews also televised two laterals.
- Manhole Inspection Program: Crews inspected 91 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Closed Caption Televising (CCTV): Crews televised 7,533 feet of sewer main lines this past week. The CCTV Preventative Maintenance inspects sewer mains to identify the condition and causes of blockages and SSOs.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff has located strategic areas within the collections system manholes to place SMART Manhole Monitoring Devices and staff is currently installing them. The tentative start date for live system monitoring is October 11, 2016. The use of "SMART Manholes" in strategic areas will be utilized to alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 150 yards of trash and green waste from the Vineyard Basin and Markley Creek Trash Hot Spot. Crews abated 1.5 acres of weeds from bank to low water lines in

channels. Sprayed 1 acre of bank to low water line in channels. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

Public Works Operations – Fleet Division

- Preventative Maintenance: 16 services on City vehicles as scheduled.
- Unscheduled Repairs: 50 unscheduled necessary repairs to City vehicles.
