Founder's Day

The **true founding of Antioch** began long before the Smith Brothers arrived. The Ompin and Jalpun, two Bay Miwok speaking tribes, have called these lands home. Their citizens tended the land to increase the health and numbers of plants and wildlife on which they relied. Nearby, **Wolwonja**' (Mount Diablo) continues to be significant for today's Bay Miwok and other native people of the region. Their story and on-going relationship to this place remain an **integral part of Antioch's** past, present, and future.

William Wiggin Smith is considered the founder of Antioch as we know it today. Smith and his family settled in the area of First Street around 1850 and, in 1851, hosted a town picnic to select a name for the settlement. Antioch was the name chosen for the biblical city of Antioch, Turkey. This year marks **170 years since Antioch's founding**; in 2022, the City will commemorate 150 years of cityhood. A months-long observance of these milestones will begin with a video later this year that honors Antioch's forefathers.

SeeClickFix

In response to recent complaints, the City's Public Works and Code Enforcement Department have teamed up to **improve** our <u>SeeClickFix</u> platform. After some Team training on how to get the most out of the platform and provide the best service, **citizens will now receive an Open, Acknowledged, and Closed response** on all submitted requests. Citizens can still **<u>submit requests</u>** just as they always have, but now benefit from these key improvements

Antioch's First California Certified Animal Control Officer

On January 1, 2020, the Animal Control Officer Standards Act (AB1125) went into effect. This new legislation directs the California Animal Welfare Association (CalAnimals) to develop and maintain standards for a voluntary program to **certify animal control officers within the state of California**. On September 21, 2020, CalAnimals launched the Certified Animal Control Officer program to promote and ensure the highest level of professionalism in animal care and control by setting standards, minimum requirements, and ongoing educational requirements for California Animal Control Officers to carry the 'Certified' designation.

COMMUNITY DEVELOPMENT

Fences 101

Most people are not aware of the many standards surrounding the construction or modification of fences in the City of Antioch. Here are a few important points to consider. If you're ever unsure, please check with the Community Development Department <u>here</u>.

Residential

- Fences have a maximum height of 36" in the front yard. It is measured from the finished grade of the ground to the top of the fence.
- Fences may not be installed in the public right-of-way. Many people don't realize that the public right-of-way (the public street/sidewalk) often extends 5' beyond the sidewalk into the front yard's landscaped portion. This area may also contain utility boxes or water meters. Please keep this in mind if you are planning a front yard fence – you cannot necessarily build it at the back of the sidewalk.
- Fences in the back or side yards may not exceed 6' in height. The only exception is the addition of lattice or other open material. In those cases, the fence can be up to 8' tall.

Commercial/Industrial

- Fences may not exceed 6' in height unless specially approved by the Zoning Administrator. In those cases, a fence up to 8' in height may be installed.
- Fences may require a Design Review or Use Permit approval. Before spending a lot of money on a new fence, please check with the Planning Division for any unique requirements

Fences 101 Continued

Citywide

- Barbed wire, razor ribbon, and other similar wire are prohibited unless specifically approved by the Zoning Administrator for special circumstances.
- Fences, walls, or hedges may not obstruct a clear vision zone, which is the portion of a site near an intersection or driveway area that allows vision across the corner.
- If chain link fencing is used, it must vinyl clad.
- Fences over 6' in height likely require a Building Permit. Masonry walls or retaining walls also often require a Building Permit. Please check with the Building Inspection Division to see if your project requires a Building Permit.

Get Informed, get involved and VOTE

<u>Register to vote online or update your current registration</u>

You need to update your voter registration if you:

- Move to a new residence,
- Change your name, or Want to change your political party affiliation.

You are eligible to register to vote if you are:

- A United States citizen, 18 years of age or older on Election Day,
- Not in prison, on parole, serving state prison sentence in a county jail, or serving sentence for a felony, and
- Not found to be mentally incompetent by a court of law.





Capital Improvements

Installation of the new water main has been completed on W. Tregallas Road, and the contractor has moved on to Shaddick Drive and the adjacent residential streets. Residents should expect some **small traffic delays** in this area for the next few weeks while the contractor is installing the new main and services.

Temporary Closure

The **Fulton Shipyard boat launch** and parking lot will be closed to the public on Thursday, October 8th, and Friday, October 9th, for exploratory excavations (soil testing) related to Public Works Capital Improvement Division's Brackish Water Desalination Project. Please be aware that to ensure public safety, the entire **parking lot and boat launch areas** will not be accessible to the public while this work is performed.



PUBLIC WORKS



Operations and Utilities

Please join us in congratulating **Carlos Zepeda**, a long time Public Works employee recently promoted to Deputy Public Works Director. Carlos accepted his first position with us in Public Works **21 years ago**, allowing him an expansive knowledge and experience in our **maintenance and operations**. We have been impressed with Carlos during his time at the City, and have complete confidence that he will continue to be a strong leader and positive example in this new position.

Stormwater Maintenance

Our Collections (Sewer) Line Maintenance Crew is performing essential sewer line cleaning maintenance with our hydro flushing trucks. We have one crew working north of Hwy. 4 and east of Viera Avenue, and a second Maintenance Crew is working south of Hwy. 4 west of Somersville Road. Our Repair Crew is working at various spots on sewer main lines that have been identified as needing repair; this crew completes 1 to 3 repairs daily. In advance of our rainy season, we have a team inspecting and cleaning our storm drain catch basins in various areas north of Hwy. 4.

NPDES (Stormwater)

Our NPDES (Stormwater) Crew is working at West Antioch Creek near the Contra Costa County Fairgrounds on O Street between W 10th and W 4th Streets performing creek maintenance and trash removal to ensure the City is meeting all state, federal, and **Contra Costa Clean Water Program** stormwater pollution prevention regulations. This vital work protects our creeks and rivers that feed into the Bay and Delta waters.

ECONOMIC DEVELOPMENT

Economic Development Department Hours

The Economic Development Department staff will continue to provide service and information remotely during the **Contra Costa County mandated shelter in place order**. Departmental phones are being answered, and email capability is in place. **The hours of operation are 8:30 a.m. - 5:00 p.m.**



Economic Development Strategic Plan

On September 22nd, the City's consultant, the Natelson Dale Group, Inc. (TNDG), led a PowerPoint presentation and update on the **City of Antioch's Economic Development Strategic Plan (EDSP**). The plan will provide a blueprint for attracting targeted new development and business investment, creating jobs, and ensuring the City's long-term fiscal health. The plan will identify key industries that should focus on Antioch's business retention/ expansion/attraction efforts and will also consider closely-related issues such as infrastructure, land use, education, and workforce development.

EC2 Meeting

On September 29th, staff attended EC2 meeting hosted by Donna Van Wert, Executive Director of the Workforce Development Board of Contra Costa County. Gary Craft gave a PowerPoint presentation on **"Aligning Contra Costa's Workforce with the Regional Economy."** This was a study sponsored by the Workforce Development Board. Gary's report will focus on East Contra Costa. We also heard from Derick Lee, CEO of PilotCity programs, who spoke about his efforts to bring work-based learning to local schools. Ed Del Beccaro from TriCommercial Realty gave updates relative to **industrial and commercial/business projects** within the region.

Updated County Order

On September 29th, the County Order allowed indoor restaurants, gyms, movie theaters, massage parlors, and worship places to open with restrictions. Thanks to recent progress being made in the fight against COVID-19 in Contra Costa. The changes come after the county gualified to move into the less restrictive red tier ("substantial") of the state's fourtiered, color-coded reopening system today. Contra Costa had been in the state's purple or "widespread" tier, the most restrictive tier.
