At the October 27<sup>th</sup> Council Meeting, the City Council approved the December 2015 Council Meeting Schedule as follows: "Conduct the December 8<sup>th</sup> meeting only and cancelling the December 22<sup>nd</sup> meeting".

The Board of Administrative Appeals meeting was held on November 5<sup>th</sup> at 3:00 p.m. in the Council Chambers. The Board of Administrative Appeals meets on a monthly basis – the first Thursday of every month, in the Council Chambers beginning at 3:00 p.m.

On Monday, October 26<sup>th</sup>, the City Clerk received the Proof of Publication of the Notice of Intent to Circulate Petition for a possible ballot initiative titled "INITIATIVE LIMITING CARD ROOMS WITHIN THE CITY AND REQUIRING VOTER APPROVAL FOR NEW OR EXPANDED CARD ROOMS" which was published in the Saturday, October 24<sup>th</sup> edition of the East County Times, along with a draft petition. The City Clerk reviewed and approved the petition for circulation which calls for a Special Election if they collect more than 15% valid signatures of the 44,257 registered voters in Antioch. The proponents (Antioch residents Lamar Thorpe, LaTonya Harmon and Patrice L. Guillory) have 180 days from the date they received the City Attorney's Title & Summary (October 14, 2015) to turn in signed petitions. The estimated cost of a Special Election is \$221,285 which would come from the General Fund since it is not currently budgeted. Should a sufficient number of signed petitions be submitted prior to March 1, 2016 to qualify for the June 2016 Primary Election, the estimated costs are between \$132,771 and \$177,028. A Statement of Organization Recipient Committee (FPPC Form 410) has been filed with the Secretary of State and the City Clerk. The name of the committee is "Antioch Coalition Against the Expansion of Gambling, Yes on the Anti-Gambling Measure, a coalition of Antioch businesses, citizens and taxpayers, sponsored by the California Grand Casino".

Our office received 3 California Public Records Act requests this week and forwarded them to the appropriate departments for a response.

**RECREATION UPDATES:**

- On Sunday, youth in grades 1 thru 8 already registered for the Junior Warriors Co-Ed Basketball program had an opportunity to participate in a FREE basic skills training clinic. The clinic gave kids a sense of confidence and boosted their skills for the start of the program.
- There are openings in grades 1 thru 6 for the basketball program, register now! Families can register their players on-line or at the Antioch Community Center.
- Volunteer adult coaches are still needed for Junior Warriors Basketball; time commitment to coaching is only 2 hours per week for a total of 8 weeks, but the memories and health benefits you provide for children is everlasting!
- Last week, fifteen youth started the "World of Nature for Young Artists" program. Budding artists will explore the beauty of nature in the earth, sky, seasons, weather and more through December 8<sup>th</sup>. Local artist, Nancy Roberts, teaches this class and many more for the community.
- On Saturday, swim lesson participants completed their last day of lessons for the Fall 2015 season. Swimmers were awarded certificates for their hard work and check lists with skills they still need to improve to become more proficient swimmers.
- On Sunday, the Antioch Water Park officially closed for the Winter Season.
- On Tuesday, the winter break camp leaders met to plan the course curriculum and schedule for the *Winter Break Aquatic Camps*. Each camp will focus on teaching children and teens about water safety, and improving swimming skills, in a safe and fun program. Winter break camps give parents an opportunity to keep kids busy when they cannot go outside, and will free time for holiday shopping! Registration is open for Jr. Lifeguard Camp (ages 11-14), Aqua Adventures Camp (ages 7-10), and Swim & Play Camp (ages 4-6).
- Last week, staff continued drafting new policies and procedures for water park

operations. The new Emergency Action Plan and Evacuation Procedures for the Water Park will be ready late November.

- Last week, the Request for Proposal (RFP) deadline closed for printing the Recreation Guide & City Newsletter. Staff received four bids to review; a printer will be selected and notified next week.
- Staff met with Melody's Dance Studio to discuss the current classes offered to children; evaluating the fall session for age group levels, dance types/styles, and procedures. Improvements will be implemented for the Spring 2016 program schedule.
- On Monday, staff submitted information to the State of California Amusement Ride and Tramway unit acknowledging the receipt of the inspection they performed in September at the Antioch Water Park. Staff outlined the schedule and type of work to be completed before the amusement rides are placed back in operation next spring.
- Throughout the week, staff worked on the installation of a new Regenerative Media Controller for the Lap Pool. The new controller will add another operational efficiency as the operator will be able to remotely access the filter for offsite diagnostics. Staff is currently working on integrating the controller with the City's network in collaboration with the Information Systems Department.
- On Tuesday, the City's Ansul system vendor completed the last semi-annual service on the City's kitchen hood systems for this period. This service assures that kitchen fire suppression systems are working per design and will protect buildings and building users in the event of a kitchen fire.
- Throughout the week, various staff members completed the necessary pre-placement respirator exams in order to be added to the City of Antioch Recreation Department Respiratory Protection Program. This program is in collaboration with the Community Development Department.
- On Thursday, staff attended a regional conference to learn new trends, tips, and information for improving services and increasing recreation opportunities for residents.

### Senior Center Services

- Last week, 449 affordable healthy meals were served through the C.C. Café. This program helps prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the C.C. Cafe.
- Staff inventoried and submitted the monthly supply order for the senior nutrition program. All supplies are provided by the County for participating cafes.
- Last week, 100+ senior participants had a *spooktacular* time at the Annual Antioch Senior Citizens Club Halloween party. Participants enjoyed a fun filled morning with socializing, dancing, crafts, games and costume contest.
- On Monday, The City of Antioch Recreation Department hosted a Kick-Off Event for Alzheimer's Awareness Month at the Antioch Senior Center. A fun-filled raffle generated \$400 for the Alzheimer's Association. Several community organizations

donated items for this event and senior participants were excited to support a very worthy cause.

- On Tuesday, staff attended the regular meeting of the Antioch Senior Citizen's Club Board of Directors. They provided input and direction on various topics such as the upcoming Holiday activities, events and fundraising opportunities, and planning for 2016.
- Last week, several seniors enjoyed "Trinket Treasures" – a fun activity for seniors to shop vendor tables full of crafts and other goods made by senior members and community vendors.
- Last week, staff provided front line assessment and direction to participants for appropriate county, regional and local services such as Utility Assistance, Home Care, Tri-Delta Dial-a-Ride, and the Co Co Café lunch program.

## **Environmental Resources:**

Environmental Enforcement: Oct 29-Nov 4th: There were over 63 actions taken on existing and new cases. 23 inspections to verify occupancy were completed. 14 abatement notices were mailed out and 12 cases were closed. Staff also mailed out 2 Notice of Violations for no garbage service.

## **Eco-Happened:**

The second floor of City Hall had a new resource conservation tool installed this week. Thanks to the Public Works Department and the Waste Prevention fund, staff and visitors can now easily refill their water bottles. ## **CDBG:**

- Monitoring by Antioch and other Consortium members is underway and will continue through December.

## **Housing:**

- The Delta View Apartments Project Evaluation form was completed and submitted to the Tax Credit Allocation Committee on November 5, 2015, on schedule.
- Construction of a new Housing database and integration of all files is commencing with City Data Services (CDS), and monitoring of Housing Successor assets continues.

## **Homeless:**

- Housing Consultant sat on the Homeless Review and Rank Panel for the annual HUD Homeless McKinney/Vento funding. The application will be submitted to HUD on time. There were many changes to the process this year. Almost all Permanent Supportive Housing projects were ranked in tier 1, meaning that their funding is secure. Also in Tier 1 is a new project to create a coordinated entry system in

Contra Costa. All Transitional Housing projects fell into tier 2, which means they will compete on a national level for funding left over after Tier 1 applications are fulfilled. One appeal was heard by the Appeal Panel, and the original rating and ranking was upheld.

- The Contra Costa Council on Homeless Executive Board meeting was held November 4, 2015, and the Board approved the submission of projects to HUD.

### **DROUGHT UPDATES:**

Antioch water customers did an excellent job conserving in their landscaping over the summer months with a conservation rate of 36% through August.

As our irrigation needs are lower in the fall and moving into the winter, our water reductions have also dropped. October's reduction was just under 27%, bringing our cumulative reduction to 33.65%. Our state mandated reduction is 28%, so to keep us above that, now it is time to move that effort indoors! Check out <http://saveourwater.com/what-you-can-do/tips/> for inspiration.

Mother Nature did our irrigating for us this week with the rain received on Sunday night and Monday! Public Works made sure to turn off the irrigation in city landscaping in compliance with the drought regulations. Don't forget to turn yours off when it rains and for at least 48 hours after the rain stops!

### **Drought regulations Education & Enforcement**

Public Works now has staff trained by Code Enforcement and authorized by the City Manager to issue administrative citations for failure to comply with drought regulations. This will hopefully encourage compliance where education and notification has not been successful. For the month of October, 9 courtesy notices were issued, 6 official violation notices were posted and mailed to the property owners and no citations were issued.

### **Irrigation repairs and updates:**

- Park Water Reductions: ALL City Parks have now reduced water use 50% or more. The water is shut-off during periods of rainfall.
- Contra Loma Estates Park: A new playground has been completed, and will open to the public this week! Many thanks to all involved in its construction. Stop by and check it out!
- Chaparral Park: 1 leaking turf valve was replaced.
- Heidorn Park: Irrigation Controller 'B' was repaired and installed for proper water usage & scheduling, as well as water savings.
- Meadow Creek Park: A leaking turf valve was replaced.
- Mira Vista Hills Park: An inoperative toilet in the men's restroom was repaired.
- Davison Dr. – 6 sprinklers repaired.
- Stewartville Dr. – 1 valve rebuilt.
- Golf Course Rd. – 3 sprinklers repaired.

- James Donlon Blvd. – 13 sprinklers repaired.
- Slatten Ranch Rd. – 1 sprinkler repaired.
- Sandstone Ct. – 1 sprinkler repaired.
- Prewett Water Park – 1 Irrigation controller reprogrammed.
- Bellflower Dr. – 1 valve box replaced.
- Delta Fair Blvd. – 7 sprinklers repaired, 8 sprinklers adjusted, 1 valve rebuilt and 2 irrigation mainlines repaired.

## PUBLIC WORKS UPDATES

### Administration

- The 'A' St./Lone Tree Way Undercrossing will be closed to traffic from 10 p.m. to 5 a.m., Tuesday – Friday, Nov. 3-6, to remove bridge falsework.
- With all the attention the City has had on the drought and water conservation, combined with the beautiful weather we've been experiencing, it can be easy to forget that an El Nino winter has been predicted which may mean very wet weather and the potential for severe flooding. Public Works has been making preparations for these conditions including intensified storm drain cleaning, procurement of extra sand bags and sand, as well as ensuring staff is ready for action 24/7. The City website will have additional information about what the City is doing and how the community can better prepare for the possibility of a severe winter.
- The City of Antioch is being required to reduce its 2015 water usage by 28% in 2015 using 2013 as the base year. Outdoor water conservation will be the primary focus of the City's program as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th. All Antioch customers will be mailed a letter explaining the program and prohibitions as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 am and 5:00 pm, shut off nozzles required on all hoses and drinking water available only upon request at restaurants. Contra Costa Water District has incentives such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. Customers who are not in compliance with drought restrictions can be reported to the Antioch Drought Hotline at (925) 779-6140. **The water customers in Antioch have reduced usage in October by 26.98% compared to October 2013. Our cumulative reduction from June 2015 through October is 33.65%. Great job!!**
- Residents of Antioch, Bay Point and Pittsburg can now get free recycled water to use for irrigation of their yards and gardens at home. The Residential Recycled Water Fill Station located at 2500 Pittsburg-Antioch Highway will be open to residents on Saturdays and Sundays from 9 a.m. – 3 p.m. through the end of October. There is a 300 gallon maximum per visit with no limit to the number of

### Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18<sup>th</sup> Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: A Certificate of Occupancy for CVS and Grocery Outlet has been issued. Phase 2 environmental clearances and USBR permitting requirements are in progress.
- City Sports Club, located at 5001 Lone Tree Way: A lot merger and sewer easement quitclaim has been recorded. Building construction is nearing completion.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: Staff is reviewing the final development plan and preparing project conditions of approval.
- Oakley Knolls Subdivision 9353, a 31-lot development by Discovery Builders, located north of Oakley Road 1,300 feet west of Phillips Lane: Staff prepared conditions of approval for a tentative map application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Staff returned comments to 3<sup>rd</sup> submittal map and plans.
- Taco Bell, 1706 'A' Street: Building and encroachment permits have been issued and construction is nearing completion.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: Contra Loma Blvd./'L' St. Undercrossing median work is nearing completion. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Bridgework continues at 'A' St./Lone Tree Way and Cavallo Road Overcrossings and Sunset Drive extension work is ongoing. The 'A' St./Lone Tree Way Undercrossing will be closed to traffic from 10 p.m. to 5 a.m., Tuesday – Friday, Nov. 3-6, to remove bridge falsework. Pedestrians and motorists are advised to exercise caution while travelling through these areas.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Work continues on the Hillcrest Avenue Bridge widening, the westbound Slatten Ranch Road on-ramp, the Pedestrian Overcrossing (POC) and the Maintenance of Works (MOW) Tunnel. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a proposed 12" sanitary sewer main from the new Maintenance Facility, north of the

S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing grant deeds for public easement dedications. Staff returned comments to BART's Ownership and Maintenance of Utilities Agreement for storm drainage improvements.

- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: Processing abandonment of existing easements and new easements.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The tentative map has been submitted and staff is creating conditions of approval.
- Quail Cove, a proposed 32 unit housing located at the south side of Prewett Ranch Drive west of Heidorn Ranch Road: An updated tentative map has been submitted and staff is updating the conditions of approval.

#### Capital Improvements Division

- Sunset Booster Pump Station Replacement: Kimley Horn and Associates is reviewing shop drawings and material submittals.
- Water Main Replacement at Various Locations: D & D Pipelines, Inc. was awarded this construction project at the October 27<sup>th</sup> City Council meeting.
- West Antioch Creek Channel Improvements: The Contra Costa County Public Works Real Property Division (CCCRPD) is finalizing the purchase of many of the easements and property acquisitions required for this project. U.S. Fish and Wildlife is reviewing the existing California Department of Fish and Wildlife (CDFW) permits and developing the Biological Opinion. The State Historical Preservation Officer is reviewing the updated Cultural Resource Study. U.S. Army Corps of Engineers and CDFW are reviewing the Re-vegetation and Monitoring Plan. CDFW is reviewing City comments to the Routine Maintenance Agreement. RMC Water and Environment continues to work with PG&E, AT&T and Comcast regarding the relocation of existing utility facilities.
- Water Treatment Plant Disinfection Improvements: CDM Smith is developing draft project plans and details.
- Water Treatment Plant Electrical Upgrades: Staff is finalizing a contract with TJC and Associates to evaluate the existing electrical systems at the City's Water Treatment Plant and prepare improvement contract.
- Urban Water Management Plan Treatment: Staff is finalizing a contract with West Yost Associates to develop updates to the Urban Water Management Plan and the Watershed Sanitary Sewer.
- Cathodic Protection Assessment: A proposal from JDH Corrosion Consultants, Inc. to conduct a thorough assessment of all pipeline cathodic protection systems within the City and draft a comprehensive report summarizing the findings and providing remediation recommendations is scheduled to be considered at the November 10<sup>th</sup> City Council meeting.

- 2015 Transportation Development Act (TDA) Grant: JD Partners is under contract to install 27 new curb ramps along Bluerock Drive and West Tregallas Road. Construction started on October 17<sup>th</sup> and is expected to be completed by mid-November.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to update anticipated land uses and the transportation network to be used in the traffic model. The draft Fee Study will be presented to the City Council for comments in December.
- Prewett Water Park Improvements: RHAA is under contract for the design of the final improvements at Prewett Water Park. The 90% design plans and specifications of the spray ground and the play ground facility are completed and under review. The bid package for both projects is expected to be out for bid in January 2016 and construction is expected to be completed by August 2016.
- 2015 Rubberized Cape Seal: American Pavement Systems completed placing the rubberized chip rock and the final slurry seal layer. The contractor is in the process of completing the punch list items. The City Council will consider the final acceptance of the project at the November 10<sup>th</sup> meeting.
- North East Annexation Infrastructure Improvements: Staff is drafting a Request for Proposal for consulting services to provide engineering services and to prepare preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve the newly annexed Area 1 and 2B.
- Pavement Management Technical Assistance Program (P-TAP) Grant: Staff has submitted a \$95,000 grant application to MTC for consulting services to assist the City in implementing and maintaining the annual Pavement Management Program System by inspecting the pavement conditions of arterial, collector and residential streets and provide us with design recommendations for pavement rehabilitation projects.
- 2016 CalRecycle Rubberized Pavement Grant: CalRecycle has issued the Notice of Funding Availability for the Rubberized Pavement Grant Program, staff will submit an application for funding for the 2016 Pavement Management Program, which will include potential streets recommended to receive Rubberized Cape Seal treatments. Grant applications are due December 10, 2015.
- 2016 Transportation Development Act (TDA) Grant: MTC is soliciting applications for the 2016/2017 TDA grant for Pedestrian and Bicyclist improvement projects. Staff is reviewing potential projects to be included in the grant application for funding for curb ramps upgrades to meet ADA requirements, installation of new sidewalks at needed locations and for bicyclist improvements. Grant applications are due January 21, 2016.

#### Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower. This is reoccurring and ongoing.

- Calibrated the turbidity meters at both “A” and “B” plants.
- Cleaned the under drain piping on #1 drying bed.
- Inspected and tested the scrubber ventilation system.
- Installed new wiring for the caustic tank heaters.

#### Water Distribution

- There were 262 stops for water service including disconnections.
- There were a total of 81 Underground Service Alert (USA) tickets completed for utility location.
- Annual backflow test program continues and is on schedule.
- Meter reading for the month of November has started and is on schedule.
- Water crews continue to monitor water meters, conservation and usage at all City buildings and parks.
- Water crews issued 12 drought violation tags.
- Water Distribution personnel continue to respond to drought hotline inquiries.
- Water crews replaced a water service on Brookside Dr.
- Water crews replaced a water service on Colonial Ct.
- Water crews replaced a water service on Carpinteria Dr.
- Water crews repaired a 24” water main on D St.
- Water crews replaced a 3” backflow on Manzanita Way.
- Water crews replaced 2” valves on Aster Dr.
- Central Stores staff continues removing graffiti and debris from the Amtrak station and Fulton boat ramp.
- Central Stores staff continues servicing fire extinguishers at all City facilities and vehicles.
- Central stores staff assisted Water Distribution with the purchase of several items for water main breaks/service breaks/leaks.
- Central Stores staff issued 277 line items of stock and 37 requests for non-stock items.
- Central stores staff received 27 line items of stock items to be placed in to the system.

#### Public Works Operations – Parks and Landscape

- Playground and Park Safety Inspections: Completed at Contra Loma, Marchetti, Markley Creek and Mira Vista Hills Parks.
- Antioch Community Park: Installed a new tot-swing including new chains and swing hangers.
- Chaparral Park: Replaced a leaking turf valve.
- Contra Loma Estates Park: The new playground has been completed and will open to the public this week! Many thanks to all those involved with its construction.
- Heidorn Park: Repaired irrigation controller ‘B’ for improved water conservation efforts.
- Meadowview Park: Replaced a leaking turf valve.

- Mira Vista Hills Park: Repaired an inoperative toilet in the men's restroom.
- Park Water Reductions: City parks have surpassed the State's mandatory 25% water reductions. All City park irrigation programs have been reduced 50% or more. Irrigation is shut-off during extended rainfall. Staff implemented proactive measures to preserve the 'green' areas in our parks by modifying routine scheduled maintenance, such as aeration, fertilization, seeding and pre-emergent.
- Tree Removal Permits: A permit was issued for 3144 Cedar St.
- Irrigation: Repaired 45 irrigation leaks on City property, which completes 2,638 irrigation repairs since June 10, 2015.
- Trim Crews: Hillcrest Ave. rights of way, Larkspur Dr., Almondridge pathway, James Donlon medians, Davison Dr., Ridgeline Dr., Judsonville Dr., and Davison Dr.
- Pre-emergent Spraying: James Donlon Blvd. rights of way, Fredrickson Ln., Lone Tree Way rights of way, Davison Dr., Black Diamond Dr., Dallas Ranch Rd., Muirwood Dr., and Mokelumne Dr.
- Spot Spray: Police Department parking lot.
- A weather monitoring system has been integrated with the City's irrigation controller system to allow automated irrigation shut-off during rainfall providing the City with significant water conservation and cost savings.

#### Public Works Operations – Streets Maintenance

- Graffiti Abatement: Removed graffiti from City property in numerous areas.
- Signs: Installed one new sign and replaced ten existing signs due to poor reflectivity. Installed a new four-way stop at Barmouth Dr. and Carpinteria Dr. per the City Engineer's work order request.
- Striping: Maintained 400 pounds of thermo striping including railroad crossing, bike lane and stacking lanes.
- Debris: Removed one yard of illegally dumped debris from City rights of way.
- Potholes: Filled two potholes.
- Parks Division: Assisted the Parks Division with their annual pre-emergent weed spraying.

#### Public Works Maintenance Operations – Collections Division

- Calls for Sewer Service: Received and responded to four calls for service from the public. Responding crews televised 140 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 24,382 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the hot spots.
- Sewer Lateral Maintenance Program (SLMP): Crews repaired a lateral that was severely damaged requiring immediate repair. Crews also televised four laterals.



- Manhole Inspection Program: Crews inspected 80 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Closed Caption Televising (CCTV): Crews televised 4,945 feet of sewer main lines. The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and Sanitary Sewer Overflows (SSOs).
- SSO Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of “SMART Manholes” in strategic areas will be utilized that will alert leadership staff within the division of potential SSO. This program will also address the need for locking mechanisms.
- National Pollutant Discharge Elimination System (NPDES): Crews removed 114 yards of green waste from pruned trees from various creeks and channels. Cleaned 9,786 and inspected 39,708 linear feet of v-ditches, as well as removed 145 yards of debris from v-ditches. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways. Proactive preventative maintenance is restricted to the months of April through October.

#### Public Works Operations – Fleet Division

- Preventative Maintenance: 15 services on City vehicles as scheduled.
- Unscheduled Repairs: 48 unscheduled, necessary repairs to City vehicles.

#### Public Works Operations – Municipal Marina

- New Occupancy: One application is pending for permanent berthing, responded to six berthing inquiries and gave two facility tours.
- Website: The new Marina website is attracting web traffic with over 144 new views this week and over 1,965 total views. View the new Marina website at: <http://ci.antioch.ca.us/antioch-marina>.
- Maintenance: Removed hyacinth and debris from the Marina basin. Installed mooring wheel in Berth B-06 and replaced rollers along the pylon in Berth A-14. The light timers were set for standard time.
- Storm Preparation: Inspected vessels in preparation for the expected heavy storms this winter. Proactively, customers were contacted to address any concerns or maintenance issues.
- Advertising and Outreach: Approved advertisements placed in Yachtsman magazine reaching over 40,000 boaters. Craigslist advertisements placed in Bay Area, Stockton, Sacramento, Monterey, and Santa Cruz listings.

#### Public Works Operations – Facility Division

- Police Department: Repaired a door in the Community Room.
- Public Works: Installed an electrical box for garage openers and installed reinforcement plywood inside the old barn. Assisted a contractor with replacing 11 windows due to broken seals. Repaired ADA door button.

That vehicle in turn collided with a third vehicle in front of it. Saucedo was still in the driver seat when officers arrived. He was reluctant to get out of the car and kept trying to return to the car after he finally exited. Saucedo ultimately tried to push past officers to get to his car and struggled with officers as they attempted to detain him. Saucedo displayed symptoms of being under the influence of alcohol and marijuana. He was placed under arrest for DUI and later provided a blood sample. Marijuana, paraphernalia, and hash oil residue were located inside Saucedo's vehicle. He was booked at the county jail for DUI and resisting arrest.
