CALENDAR NOTE: Due to the Veteran's Day holiday on November 11th, the first City Council Meeting in November will be on Thursday, November 13<sup>th</sup>.

#### **MEASURE O LEADING**

At last count (12:08 a.m. Wednesday, November 5<sup>th</sup>) Measure O had 50.88% of the vote, the YES vote just 180 votes ahead of the NO vote, with 10,236 votes cast. Statistically, it's very likely that Measure O will pass; but it is not certain. The County is supposed to have a final tally today.

Also at last count, the Measure O proponents, Residents for Fairness, raised \$14,163 in contributions while the opponents, bankrolled by the California Apartment Association, raised a total of \$178,575 in contributions and loans.

If Measure O passes, residential landlords will pay a Business License Tax of \$250 per year for single family dwelling rentals (e.g. houses) and \$150 per year for multi-family rental units (e.g. apartments and condos). Hotel/motel, hospital, convalescent, extended care (nursing) and residential care (assisted living) facilities are exempt from the proposed per unit fee. Non-profits continue to be exempt from the Business License Tax.

The minimum annual Business License Tax will go from \$25, where it was in the 1960's, to \$100. Measure O will not raise the Business License Tax on smaller home-based businesses, which will remain at \$25.

### DOWNTOWN SPECIFIC PLAN AND GENERAL PLAN LAND USE/ZONING UPDATE

The City has officially kicked off preparation of the Downtown Specific Plan and General Plan Land Use/Zoning Update. The first two meetings related to this effort have been scheduled (see calendar below) to receive input from the community. **We need to hear from as many Antioch residents and businesses as possible, so please encourage everyone to attend!**

# OFFICE OF THE CITY CLERK UPDATES

At the October 14<sup>th</sup> City Council meeting, the City Council approved the following changes to scheduled City Council meetings for November 2014, December 2014 and January 6, 2015:

- Confirm the revised regular meeting date of Tuesday, Nov. 11<sup>th</sup> to be held on Thursday, Nov. 13<sup>th</sup> (this was approved at the February 11<sup>th</sup> City Council meeting)
- Confirm the regular meeting date of Tuesday, Nov. 25<sup>th</sup>
- Schedule the meeting to seat the Council as the regular meeting of Tuesday, Dec. 9<sup>th</sup>
- Schedule a special meeting to conduct business on Tuesday, Dec. 16<sup>th</sup>
- Cancel the regular meeting scheduled for Tuesday, Dec. 23<sup>rd</sup>
- Schedule a special meeting to provide land use training followed by a closed session for litigation and other legal matters on Tuesday, January 6, 2015

Election Day was Tuesday, November 4, 2014. The Contra Costa County Elections Division will certify the results within 30 days.

The original "Notice of Intention to Recall Petition" to recall the Mayor was filed in the Clerk's Office on Oct. 16<sup>th</sup>. Mayor Harper filed an answer on Oct. 22<sup>nd</sup>. In checking with the Contra Costa County Elections Division, the number of registered voters for the City of Antioch is 44,221. The estimated cost for an election is between \$2.00 and \$4.50 per registered voter (\$88,442 - \$198,994.50) for a stand-alone election. <a href="UPDATE: The 2 blank copies of the Petition along with the signed Proof of Publication was not filed in the Clerk's Office by the deadline date of Monday, Nov. 3<sup>rd</sup> by 5:00 p.m., per Elections Code 11042(a) and (b). Since the deadline date was missed, the recall is over, per the Secretary of State. A letter was mailed to the proponent by the City Clerk.

FPPC Pre-Election Candidate Campaign Finance statements (2<sup>nd</sup> filing) were due in our office by 5:00 p.m. on 10/23/14 covering the period October 1 through October 18, 2014. We have one candidate who has yet to file these documents. A letter was mailed to the FPPC Enforcement Division.

The City Clerk's office is accepting applications for the Police Crime Prevention Commission (one partial term). The deadline date has been <u>EXTENTED</u> to 5:00 p.m. Thursday November 13<sup>th</sup>. Applications are available on the City's website (<u>www.ci.antioch.ca.us</u>) and at the City Clerk's Counter.

The Board of Administrative Appeals regularly scheduled meeting will be held on November 6<sup>th</sup>. The results will be posted in next week's weekly report.

Our office completed putting the agenda packets together for the regularly scheduled Council Meeting on November 13th. Hard copies of the agenda packets were assembled and delivered to Council and the Antioch Branch Library as well as internal departments. #### RECREATION UPDATES

- Men's and Women's Adult Softball Fall League regular season has ended; playoffs begin next week!
- On Wednesday, November 5<sup>th</sup> the Wednesday night Adult Church basketball league finished up with an exciting playoff tournament.
- Available rental time for the multi-use sports complex is at full capacity this week.
- Registration is still being accepted for the Youth Junior Warriors Basketball League for kids (co-ed). Basketball offers excellent winter exercise, and it is fun too! Youth can register through Friday November 14<sup>th</sup>.
- On Saturday, November 1, over 500 parents, grandparents, family and friends gathered to watch their budding dance stars on stage for the Fall Dance Recital. From the tiniest ballerinas to the hip hop teens, a great time was had by all.
- On Tuesday, November 4, Winter Inter-Session Dance classes began; keeping little ones active and engaged through the holiday season.
- Staff initiated a cross-promotion for upcoming Red Cross CPR/First Aid and Lifeguarding classes by listing all Antioch training classes on the Red Cross website. This opportunity is a new feature provided by the American Red Cross for their Licensed Training Providers.
- Staff finalized the Recreation Activity Guide production schedule for 2015 2017, and met with the Recreation Guide Designer and Print Company to discuss opportunities to change and improve the publication.
- Last week, a new session of Preschool classes began with a 34% increase in enrollments over last Fall.
- Several broken irrigation valves were repaired and/or replaced around the Antioch Community Center.
- Maintenance staff and environmental resource staff completed two of the five outside agency audits required of the green business certification program for the Antioch Community Center.
- Water Park maintenance staff completed annual respirator protection program training and fit testing.

## Senior Center Services

- Last week, 436 affordable, healthy meals were served-approximately 100 more than the week before.
- Senior Peer Counseling assisted 11 seniors (a value of \$25 per person).
- 45 individuals are now members of The Antioch Senior Flappers; an excellent program for health and fitness, learning new skills, and building friendships. The group performs at

local events/activities.

- On Tuesday the Antioch Senior Citizen's Club hosted their Board of Directors meeting. Staff attended and provided input on activities, events, membership, and new ideas. Staff also addressed board/club code of conduct in order to raise the levels of professionalism.
- On Wednesday, 75% of the appointment reservations attended the Health Insurance Counseling and Advisory Program.

# Administration

Public Work's newest employee, Adam Molinar began work this week as our Water
Distribution Superintendent. Adam comes to us from the City of Vallejo and brings
excellent technical abilities along with a strong sense of teamwork and service. He will
be leading the division responsible for all aspects of operating and maintaining our water
distribution system, backflow protection, meter reading, and oversight of our warehouse.

# **Engineering & Development Services**

- Almondridge East Subdivision 8880 (81-unit single family home development by KB Homes), located between East 18<sup>th</sup> Street and Oakley Road, east of Phillips Lane and west of the State Highway 160 The new model home complex has been completed. Loops are in and paving is completed for the new traffic signal. Signal poles are expected to be delivered next week.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road – The County Flood Control District returned comments to the developer's revised drainage study. Staff is reviewing the final construction drawing submittal and revised subdivision agreement with a deferred improvement agreement.
- Cellular Providers on City-owned Property Staff is processing Metro PCS' request to
  decommission two of its cell sites on City-owned parcels at Antioch City Park and 4506
  Via Dora Drive. Staff is working with Sprint and PG&E to remedy graffiti, litter and
  criminal activity at their Lotus Ct. tower and cell site. Staff is working with American
  Tower to process 3 consent letters and one administrative use permit for their cell sites.
  Staff is plan checking Verizon modifications at their Via Dora site.
- Nelson Ranch Unit 1 Subdivision 6893 (102-unit single family home development by Standard Pacific Housing) located northeasterly of Wild Horse Road and Ridgeline Drive and southwesterly of State Route 4 – Staff returned comments to off-site Wild Horse Road plans and will to go Council at the 11/13 meeting to accept tract improvements.
- Nelson Ranch Unit 3 Subdivision 8851 (130-unit single family home development by Standard Pacific Homes, the third and final unit of this development), located on approximately 38.10 acres northeasterly of the intersection of Wild Horse Road and Ridgeline Drive – Staff is processing an 80% bond reduction for completed tract improvements.

- The SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange Cavallo Road/Garrow Drive Undercrossing Project - SR4 Bridges over Cavallo Road were removed by the SR4 Contractor last weekend. Staff expects the Contractor to request a full Cavallo Road Undercrossing closure the weekend of November 22-23, from Saturday 5 a.m. to Monday 5 a.m. Work will be performed mainly during daytime hours.
- Wendy's (1809 "A" Street) Lot Line Adjustment Staff approved lot line adjustment documents for recordation.
- Davidon Homes Park Ridge Phase I consisting of 123 residential units located west of Canada Valley Road and east of Highway 4 – Plans and maps have been resubmitted for second review.
- Laurel Ranch 109 unit housing development at Highway 4 and Laurel Road Comments were submitted to the planning department from engineering for the preliminary development plan review by Planning Commission on November 5<sup>th</sup>.
- Heidorn Village 112 unit housing development at Heidorn Ranch Road and Prewett Ranch Drive – Creating conditions of approval for tentative map.
- Wal-Mart expansion processing easements and vacation of existing easements.
- Deer Valley Business Park Commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road – processing abandonment of existing easement.
- The Vineyards at Sand Creek 641 unit housing development located on Sand Creek Road between Heidorn Ranch Drive and Hillcrest Avenue – Staff is having ongoing meetings with the developer to discuss various site and infrastructure issues.

# Capital Improvement Program (CIP)

- Sanitary Sewer Main Replacement at Various Locations RGW Construction is installing new sanitary sewer facilities on Belshaw Street. Trench resurfacing is being performed on Evergreen Avenue.
- Country Hills Drive Sanitary Sewer Rehabilitation Michels Pipeline Construction has commenced rehabilitation of the sanitary sewer main on Country Hills Drive using the trenchless cured-in-place pipe method. Work has begun on the western portion of the project near Deer Valley Road.
- Curb, Gutter and Sidewalk Repair Program Anchor Concrete continues to remove and replace deteriorating, damaged and uneven concrete throughout the City. Over the past week a total of 146 square feet of sidewalk and 9 lineal feet of curb and gutter were repaired.
- Piping Reconfiguration of Canal Pumps 2 and 4 and Pump 2 Replacement A preconstruction meeting between Con-Quest Contractors, Contra Costa Water District, East Bay Regional Park District, Brown and Caldwell and City Staff was held regarding this work at the canal pump stations. The project is expected to commence in December.
- Fulton Shipyard Road Transfer Station Trash Enclosure A pre-construction meeting between J.D. Partners Concrete and City Staff was held regarding the construction of this facility. The project is expected to commence in November.
- Williamson Ranch Plaza Water Main Replacement Project bids for this work were publically opened on November 4<sup>th</sup>. The apparent low bid was received by D.R. Lemings

- Construction in the amount of \$228,600. The award of this project is scheduled to be considered at the November 13<sup>th</sup> City Council meeting.
- Raw Water Pipeline Inspection & Assessment City Staff interviewed Brown and Caldwell and V & A Consulting Engineers regarding their qualifications to perform comprehensive inspections and provide detailed assessments of the City's raw water pipelines.
- CDBG Downtown Roadway Pavement Rehabilitation, Phase 6 Staff has completed the 100% draft plans, specifications and cost estimates. The project is expected to be advertised for bid in November.
- Ninth Street Roadway Improvements Staff has completed the 100% draft plans, specifications and cost estimates. The project is expected to be advertised for bid in November.
- Rubberized Cape Seal Program Staff has developed the 2015-2017 recommended list
  of streets for the next Cape Seal project. Staff is developing the grant application for the
  state CalRecycle's Rubberized Pavement Grant Program.
- Safe Routes to School Grant (Cavallo Rd./Garrow/E. Tregallas curb ramps) Staff received the grant funding authorization from Caltrans to proceed with construction. PLS Surveys completed the survey work and Staff is working on the design. The construction is scheduled for January 2015.
- Surface Transportation Program Grant (Ninth Street) Staff received the grant funding authorization to proceed with construction for the Ninth Street Improvements Project. PLS Surveys is working on the survey work. Construction is scheduled for May 2015.

# Traffic Engineering

- Transportation Impact Fee Study Staff received two proposals for consultant services
  to provide technical and nexus analyses necessary to develop and implement a
  Transportation Development Impact Fee program. Staff will be reviewing both proposals
  and bringing an item for Council to award a contract in December 2014.
- Crossing Guard Study The City is partnering with the Antioch Unified School District to review the current and potential crossing guard locations and determine if additional or alternative locations would provide the best use of limited crossing guard funds. Staff has made comments on the administrative draft report and the draft document for review by the school district is expected in the next week.
- Engineering and Traffic Surveys Average daily traffic counts (tubes across the roadway) are being conducted on many of the arterial and collector street over the next several weeks. The engineering ant traffic surveys are required on major streets in order for the police department to use radar for speed enforcement.
- Somersville Road –Fencing is being this week. The landscaping is underway and scheduled for completion the next week. Street lights and signing and striping will be installed immediately following. The second southbound Somersville Road to eastbound James Donlon Blvd. left turn lane has been opened. The traffic signal will be completed in December.

### Water Distribution

- There were 237 stops for water service including disconnections.
- Water meter staff issued 13 business license renewal notices.
- There were a total of 26 USA tickets completed for utility location.
- Meter reading for the month has started and is on schedule.
- 13 notices were issued for drought water usage violations.
- Construction Crew is replacing water services at Corp Yard Gas Dock prior to the installation of new pavement.
- Continuing valve exercising and flushing program on Phillips Lane, West 12<sup>th</sup> Street, West 13<sup>th</sup> Street, West 14<sup>th</sup> Street and West 15<sup>th</sup> Street for water quality.
- Water crews are continuing to haul green waste from the Fulton Yard and maintain the backfill material area and dumpster area for Allied Waste.
- Maintaining Fulton Yard ramp site and preparing for Capital Improvement's Trash Enclosure project.
- Water crews are continuing to replace aged or broken curb stops.
- Construction Crew is replacing sewer laterals on West Madill St.
- Water crews are checking fire hydrants for proper operation, missing port caps and painting. Crews are also operating hydrant auxiliary valves for proper operation.
- Processed Return Material Invoice (RMI) for Badger meter warranty items.
- Staff has ordered specialty batteries for the floor cleaning machine at Antioch Community Center.

# Public Works Maintenance Operations - Landscape

- Playground and park safety inspections were completed at Eagleridge and Harbour Parks.
- Antioch Community Park Soccer Fields have a new water-efficient Rainmaster DX-2
  Irrigation Controller. It is up and running and already conserving water on the soccer
  fields turf viewing areas.
- Antioch Community Park had 2 new sink faucets installed to replace the inoperative ones. The easterly park restroom also had the plumbing repaired on the women's toilet. All fixtures are now working properly.
- City Park had a new sink faucet installed in the men's restroom to replace the vandalized one. It is now up and working and set to conserve water.
- Hillcrest Park has a new water efficient drinking fountain that is fully operational.
- Mira Vista Park is set to receive a new community playground. Construction is scheduled to begin soon.
- Park turf aerating has begun, which will increase water and fertilizer uptake in order to improve the vigor of our turf fields citywide. So far this process has been completed at Chaparral, Country Manor, Harbour, Knoll, Mira Vista, Mountaire and Nelson Ranch Parks.
- Landscape crews continued the spraying of post emergent weeds on the Hillcrest Ave. and James Donlon Blvd. medians.
- Numerous irrigation leaks were attended to and repaired.

- The 5-person contract trimming crew continued trimming the right of way on the west side
  of Hillcrest Ave. The 4-person contract trimming crew completed the trimming of the right
  of way on the north side of James Donlon Blvd. and is trimming the right of way on the
  south side. The 3-person trim crew continued the trimming of the landscaped areas of
  Indian Hills Dr.
- Landscape maintenance staff along with the "Work Alternative" participants trimmed the right of ways of Contra Loma Blvd. and a section of the Mesa Ridge Trail east of Sagebrush Dr.
- Landscape staff and street staff have begun the annual Pre-Emergent Spray Program. They are approximately 50% complete with this project.

# Public Works Maintenance Operations - Street Maintenance

- Crews cleaned up the corporation yard prior to the Friday storm in an effort improve storm water runoff.
- Staff removed graffiti from numerous areas around the City.
- Crews replaced 9 signs due to poor reflectivity.
- Picked up 10 yards of debris/household dumping in rights of way.
- Assisting landscape staff with its annual pre-emergent herbicide application program.
- Crews filled 5 potholes.

# Public Works Maintenance Operations – Collections Division

- Staff continues to make progress on the revisions/self audit of the City's Sanitary Sewer Management Plan, which is required by the state.
- 2 channel outlets were cleared.
- Approximately 1.5 acres were weed abated in various creeks and channels.
- The Collections team received 3 calls for service and cleaned over 20,145 linear feet of sewer lines.
- Staff televised 25 sewer laterals for a Capital Improvement project on Belshaw.
- A communications trench was dug to connect the new building to the City's network.
- Staff worked on an improvement program for collections system emergencies.

### Public Works Maintenance Operations – Fleet Maintenance

- Performed 15 preventative maintenance on vehicles, as scheduled.
- Staff made 46 miscellaneous repairs to City vehicles.

#### Marina

- The marina received 1 application for a permanent berther and 1 application for a temporary berther.
- Staff responded to 5 inquiries and gave 3 tours of the facility.
- Marina Staff removed debris that was blocking the main channel from the marina basin.
- Marina Staff repaired the dumpster swing door.
- Marina Staff continues to conduct a records audit on aged accounts and conducted a fuel price comparison for the west delta local region.

#### POLICE DEPARTMENT UPDATES

- On 11/01/14, officers responded to Cruiser's Bar at 1611 A Street for a report of a fight in front of the business and shots being fired. Upon officers' arrival, the fight was over and many of the patrons had already left the area. A 33 year old male victim was located in the restroom of the business suffering from multiple gunshot wounds. He was transported to an area hospital for his injuries and is expected to survive. The victim, thus far, has been uncooperative with the investigation.
- On 11/02/14, officers responded to the intersection of W. 18<sup>th</sup> Street and A Street on a report of shots fired. Officers arrived on scene and located an adult female had been shot. The investigation revealed two groups of subjects were arguing when a subject in one of the groups pulled out a gun and began shooting. The female victim was across the street and not involved with either group, but was struck by one of the bullets fired. Officers located subjects from both groups, and three people were taken into custody. The victim was taken to a local hospital where she was treated for a non-life threatening injury.
- On 11/05/14, officers were dispatched to the area of A Street and W. 18<sup>th</sup> Street on a report of shots fired, with at least one victim shot. The investigation revealed a security guard patrolling the shopping center observed an argument where a subject was armed with a handgun. The security guard drew his own weapon and challenged the subject. Shots were exchanged and the security guard was struck once. Officers quickly obtained a suspect description from several witnesses. The suspect, who still had the firearm in his possession, was found a short distance away and was taken into custody. The security guard was taken to a local hospital and is expected to make a full recovery.
- On 11/06/14, officers were dispatched to the parking lot near 24-hour Fitness at the Somersville Towne Center on a report of a shots fired. Officers arrived on scene to find a 32 year old male had been shot. The investigation revealed the victim was walking through the parking lot with his brother when a vehicle occupied by two males pulled up next to them and began shooting. The victim was pronounced dead at the scene. This case is still currently under investigation.
