RECREATION UPDATES

- The Antioch Council of Teens is still accepting donations of fleece material for their fleece blanket drive. Help the teens achieve their goals! Donations can be dropped off at the Antioch Community Center now through November 23rd.
- Last week, the 2017 Winter/Spring Recreation Guide was submitted for printing and distribution. Look for the Recreation Guide in your mailbox the week of November 28th – it is full of many new and exciting classes and community events!
- Digital Signage located in the Antioch Community Center lobby is in the process of being updated with upcoming programs and activities for the Winter/Spring Quarter. The digital sign program has been an effective way to reach visitors and participants.
- Last Monday, NRCC and ACC staff met with multiple user groups of the NRCC Theatre during an Open House and 2017 calendar planning session.
- On Saturday and Sunday, the final youth baseball tournament of 2016 was held at Antioch Community Park. Ten teams age 9 thru 11 year boys, participated in All World Sports' "Edge of Darkness" tournament. Teams from San Lorenzo, Menlo Park, Daly City, Napa, Oakland and even a home town team from Antioch, just to mention a few, were able to enjoy the beautiful weather, complex, and other amenities that the park has to offer. All World Sports organization has booked 14 youth tournaments for 2017 to be held at the Community Park.
- Fall Gymnastics is in full swing at the Antioch Community Center with 61 participants enrolled. Participation in gymnastics classes provides many benefits including enhanced social interaction and discipline; improved mental focus and concentration; education and an understanding of physics; flexibility, balance and co-ordination; in addition to numerous health benefits.
- On Wednesday, the Antioch Council of Teens section of the City website was updated to reflect upcoming events.
- Throughout the week, staff and teens began planning an Antioch Council of Teens winter retreat. The retreat is intended to strengthen and unify youth relations.
- On Tuesday, the Aquatics team attended the annual awards luncheon for the Bay Area Public Pool Operator Association. Recreation Specialist Tracy Newman was honored with an award for Outstanding Aquatics Program. The City's Toddler Tuesday's drop in program, operated under Tracy's leadership, provides water exposure to the toddlers of our community and helps to build passionate future users and staff for the Water Park.
- Last week, the City's Fire Sprinkler Contractor Conducted quarterly fire sprinkler inspections at all Recreation Facilities.
- On Wednesday, the City's janitorial supply vendor installed a new paper towel

dispenser at the Antioch Community Center. This new dispenser is being piloted as an opportunity to reduce the use of paper towels in the facility and to minimize the staff time needed for keeping the unit stocked. If this strategy works, the department will retrofit five additional units.

- On Wednesday, the Aquatic Maintenance worker assisted with the coordination of punch list items to complete the new Spray Ground. Final inspections are being scheduled.
- Throughout the Week, the City's electrical contractor completed work necessary for the installation of lighting and surveillance of the new Spray Ground.
- On Thursday, the Parks and Recreation Commission held their regular monthly meeting. The Antioch Council of Teens presented the Teen Friendly Business of 2016 to *Tea For U (T4)*. This recognition is given to companies in honor of their commitment to the development of healthy relationships between local shops and the teen community. Congratulations to Tea For U (T4) on winning this award!

Senior Center Services

- Over the last week, 328 affordable, healthy meals were served through the CoCo Café. This program helps prevent heart attacks, depression, asthma and congestive heart failure. No membership or income requirements are required to eat at the C.C. Cafe. All supplies are provided by the County for participating cafes.
- On Monday, Julie Martin, our new Recreation Specialist began her orientation at the Antioch Senior Center. Julie will be working with Mike Heller, our Interim Recreation Specialist over the next few weeks to become acclimated with the Senior Center and the Nick Rodriguez Community Center.
- On Monday, 11 seniors attended the Alzheimer Association presentation titled "Effective Communication". This class provides strategies in communicating with individuals that suffer from either Alzheimer or Dementia related diseases.
- On Tuesday, 15 seniors participated in our "Creating a Dementia Aware Community" seminar presented by Comfort Keepers. The seniors really enjoyed Laura Wayman's presentation, and shared with her that they would love to have her return and give another presentation; this presentation has been tentatively scheduled for the January 10, 2017.
- On Wednesday, staff assisted the various arts and crafts classes with organizing their "Holiday Boutique" event. Six different vendors featured the crafts they have worked on over the year.
- On Wednesday, 15 seniors attended Movie Mania and enjoyed "Dutch," starring Ed O'Neil and Ethan Embry; popcorn and refreshments were served at no cost to all participants.
- On Wednesday, staff coordinated with members of East County Senior Coalition, and began the planning process for the upcoming "Holiday Happenings". This event is scheduled on the 14th of December, between the hours of 9:30-11:30am.
- On Thursday, 20 seniors participated in AARP's Safe Driving Refresher Course.
- On Thursday, 20 seniors came to listen to the Writer's Group, who gave a performance in the Multi-Use room at the NRCC.

- On Thursday, staff attended a Rotary Club of Antioch meeting and accepted a grant on behalf of the Antioch Senior Center, in the amount of \$500 for a new karaoke program which will begin in January 2017.
- On Thursday, staff created an Amazon business account which will allow the Club to benefit from Prime services. Also, a smile.amazon account was created in which .05% of qualified purchases made through smile.amazon.com will be donated to the Antioch Senior Citizens Club on a quarterly basis. For those interested in supporting our seniors please register the organization “Antioch Senior Citizens Club” and always remember to use smile.amazon.com.
- To date the Senior Club has received a total of new and renewal membership applications from 1008 seniors. For the months of October through December membership dues are reduced to \$10.00.

Commercial Organics Rates - Staff is currently discussing rate options/proposals with Republic Services for the collection of commercial organics (food waste and landscape debris) in order to comply with AB 1826.

Community Development Block Grant (CDBG): The City of Antioch is still accepting applications for funding with CDBG and Housing Successor funds for the 2017-20 three-year grant funding cycle. ALL NEW APPLICANTS or applicants not funded in the previous funding cycle are STONGLY advised to discuss their proposed activity with Teri House prior to submitting a grant application. Please call 925-779-7037 to discuss or schedule an appointment.

Applications for **Housing** services must be submitted in City Data Services (CDS) **no later than 5:00 PM on Wednesday, November 22, 2016**. Applications for **Public Services, Fair Housing, Homeless Services, Economic Development and Infrastructure/Public Facilities** are due **no later than 5:00 PM on December 12, 2016**. Housing:

- **Homeowner Housing Rehabilitation Program:** The Consortium members met with the County Neighborhood Preservation Program (NPP), which has run the homeowner housing rehabilitation program for a number of the cities for several decades. Since the recession, the program has struggled with greatly reduced staffing for loan processing and inspection. This has resulted in a substantial decrease in the rehabilitation projects they can handle for the cities, to the point where they are only rehabilitating one home per year in Antioch.

After discussion with the affected cities of Antioch, Pittsburg, and Walnut Creek (Concord contracts with Hello Housing), the County has decided to **end** their rehab program with other jurisdictions and focus on their internal program for urban county residents.

Consortium members then reached out the Hello Housing and Habitat for Humanity, which has developed a residential rehab program. Hello Housing board, they have decided not to take on further clients, but Habitat is working on their application for all jurisdictions (except Concord). Antioch's housing consultant has also reached out to Stockton and Sacramento to see if there are agencies to the east that might be willing to expand into Contra Costa.

- **Vista Diablo Mobile Home Estates:** Letters are ready to send to lower income residents of Vista Diablo who are receiving the City's rental subsidy. The letter informs them, for the second time, of the end of the rent subsidy on **September 30, 2017**. It also includes a list of all subsidized affordable senior housing, as well as information about 211 and the upcoming Tabora Gardens Project.

After reaching out to Kort and Scott (Sierra Management), the company that owns the development, they asked us to delay sending the letters until management has a meeting with the owners on 11/22/16. They did not elaborate as to what would be the subject of that meeting. However, they will be sending their invoice for the next six months of subsidy right away so it appears that the subsidy will continue through September of next year.

The source of funding for this subsidy was the former Antioch Development Agency, and the contract terminates at that time. There have been no new funds provided or identified that can be used for this purpose. In addition to the City subsidy ending, the agreement with Sierra Management, the owner Vista Diablo Mobile Estates to retain the Senior Living nature of this community and limit rent increases **will also end** in September 2017.

Homeless

- **November is Homeless Awareness Month** – To educate and inform the public about homelessness in our County, the City's CDBG/Housing Consultant, Teri House, has made presentations at the cities of Antioch, Concord, Pittsburg, Brentwood, and Oakley Council meetings.
- Members of the Antioch community are invited to participate in Homeless Awareness Month by **collecting and donating items for people who are homeless**. These items will be distributed by the Homeless Outreach Teams and nonprofit agencies. **Please drop off at Opportunity Junction 3102 Delta Fair Blvd. on November 19th only, or at City Hall, 2nd floor box by elevator, or by calling Teri House at 925-779-7037.** Thank you!

- Hygiene kit items such as soap, shampoo, toothpaste, toothbrushes, combs and brushes, deodorant, toilet paper, etc.
 - Feminine hygiene products – much needed
 - Disposable diapers
 - Undergarments – undershirts, underwear and socks for men, women and children.

- Debris: Removed 11 yards of debris in the roadway.

- Pre-emergent Spray: Crews assisted the Parks Department with its annual pre-emergent spray application.
- Street light survey: Crews began their annual night time survey of street lights and sign reflectivity.

Public Works Utilities – Collections Division

- Calls for Sewer Service: Received and responded to 12 calls for service from the public. Responding crews televised 420 linear feet of public sewer laterals connecting to the City’s sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 18,005 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified priority locations and integrate a proactive preventative cleaning schedule for these pipelines.
- Manhole Inspection Program: Crews inspected 82 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff has located strategic areas within the collections system manholes to place SMART Manhole Monitoring Devices and staff is currently installing them. The live system monitoring began October 11, 2016. The use of “SMART Manholes” in strategic areas will be utilized to alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 4,874 feet of sewer main lines. The CCTV Preventative Maintenance inspects sewer mains to identify the condition and causes of blockages and SSOs. The lateral crew inspected 192 sites and televised 43 public sewer laterals consisting of 1,505 linear feet.
- National Pollutant Discharge Elimination System: Crews removed 50 yards, eight bags of trash, two couches, one cooler, and 26 shopping carts of illegal dumping from various creeks and channels. Crews inspected 94 catch basins and cleaned four. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways.

Public Works Operations – Fleet Division

- Preventative Maintenance: 15 services on City vehicles as scheduled.
- Unscheduled Repairs: 45 unscheduled necessary repairs to City vehicles.

Public Works Operations – Municipal Marina

- The Marina received one pending application for permanent berthing and responded to three berthing inquiries.
- Billing: Commenced electric meter reads for the December billing.

- Maintenance: Removed Hyacinth and debris from the Marina basin. Cleaned and maintained the trail pathway. Repairing dock boards along A dock: 60% complete. Removed one dead tree and serviced the pump-out.
- City of Antioch held the Veteran's Day Observance on the Marina grounds, Friday November 11th. This annual event was well attended in tribute to all military service members.
- Filed for a pending lien sale for one vessel.
- The staff report was completed and prepared for review by CIP/City management for the acceptance of the grant funding for the new public kayak launches.
- Advertising and Outreach: Approved advertisements placed in Yachtsman magazine reaching over 40,000 boaters, Craigslist advertisements placed in Bay Area, Stockton, Sacramento, Monterey, and Santa Cruz listings. Advertising Annual Boat Launch Ramp Passes for \$100 on Craigslist. Advertising Automated Self fueling station on Craigslist.

Public Works Operations – Facility Maintenance Division

- City Hall: Replaced a water filter for a drinking fountain on the second floor and manually opened the elevator.
- Gentrytown Park: Assembled a picnic table.
- Police Department: Installed a new garbage disposal in the lunch room and assembled a computer station in the jail area.
- Public Works: Installed new blinds in the Public Works training conference room and replaced a thermocouple for the sign shop furnace.
