RECREATION UPDATES:

- Last week, Water Park staff continued activity planning for the Winter Break Camps that will be held at the end of December. Families can keep their youth ages 4-14 active and engaged during the winter. The water will be warm and it will be *Cool to Be in the Pool* in December, so register your children now!
- On Monday, staff met with the HR Department to finalize the re-hire and application process for staff interested in returning to the Antioch Water Park next season. It's time to begin planning for summer employment, contact the Recreation Department.
- Last week, staff cleaned and reorganized the office and storage spaces at the Water Park in preparation for the summer 2016 season.
- Staff continues to update policies, procedures, and reporting forms for the Water Park to ensure a safe and enjoyable experience by all visitors.
- On November 20, the 2015 Adult Fall Softball League concluded; 43 teams played through the regular 12 week season to see who would qualify to participate in the league playoffs. Five divisions were represented and five teams (2 women's and 3 men's) were crowned champions. Trophies and long sleeve shirts with graphics were awarded to members of these winning teams. Softball is an excellent fitness activity and all participants are eager for the next league to start! Informational packets that provide fees, dates, times and rules available for pick up January 5th, and spring play begins in March.
- On November 22 & 23, the annual two day Preschool Thanksgiving Feast was held at the Community Center. Preschoolers feasted on a variety of traditional Thanksgiving foods and came dressed as the Native Americans and Pilgrims they've been learning about in class.
- On Monday, Recreation Maintenance Staff completed registration with the Department of Toxic Substances Control for the new online reporting system. This system is used to report the disposal for hazardous waste generated by the Prewett Community Park facilities.
- On Tuesday, Recreation Maintenance staff finalized the December maintenance schedule. December is a great time to make sure all of our facilities are in ship-shape for the New Year!
- On Thursday, the Recreation Maintenance team met with one of the City's janitorial supply vendors to demo a new product for the ongoing maintenance of all of the department's tile floor surfaces. Staff will evaluate the new cleaner in the coming weeks and make a decision on the best product to use in our periodic maintenance program in order to provide economical services for all of the Recreation buildings.

- On Thursday and Friday, the City's Park Maintenance Contractor completed turf rehabilitation work at Prewett Community Park.
- Last week, staff drafted new contractor agreements for all instructors teaching classes and programs for the spring 2016 session.
- All hands were on deck last week as staff put on their elf hats to transform the Antioch Community Center into a winter wonderland for the Holiday Season.
- On November 21, the City hosted a playground ribbon-cutting celebration at Contra Loma Estates Neighborhood Park in partnership with First 5 Contra Costa County. Families and children enjoyed a morning of healthy play in the park and growing strong bodies climbing on the new play structures.

Senior Center Services

- Over the last two weeks, 715 affordable healthy meals were served through the C.C. Café. The nutrition program is especially important during the winter and holiday season, ensuring a well balanced meal and nurturing companionship when the days are shorter and the weather is colder. No membership or income requirements are required to eat at the C.C. Cafe.
- Staff inventoried and submitted monthly supply order for the senior nutrition program. All supplies are provided by the County for participating cafes.
- Last week, staff provided front line assessment and direction to participants for appropriate county, regional and local services for, HICAP, Notary Services, Tri-Delta Dial-a-ride, C.C. Café lunch program and Social services.
- Last week, six participants were provided Health Insurance Counseling, which is a free, objective counseling and advocacy service to Medicare beneficiaries and their families who need assistance with Medicare enrollment and issues involving Medicare and associated insurance programs, including prescription drug coverage.
- Last week, staff continued developing the January /February Antioch Senior Citizens Club Newsletter. The Antioch Senior Citizens Club newsletter serves as a key marketing piece to communicate all of the beneficial programs offered to the general public in senior services.
- On Tuesday, staff attended the Antioch Senior Citizens Club Board of Directors meeting. Staff provided input and direction on various topics such as upcoming special activities, events and fundraiser opportunities. In addition, the Board of Directors held a strategy planning session with the Parks and Recreation Director.
- Last week, the Senior Center Holiday Boutique was a hit among visitors! Participants were able to visit 22 different vendors and get some holiday shopping done for friends and family.
- Last week, the "H" returned to the building! Staff collaborated with the Antioch Senior Citizens Club Board of Directors, who in turn worked with the Antioch Rotary Club to purchase an "H" and install it on the building to complete the sign.

Environmental Resources:

Environmental Enforcement: Nov. 19th- Dec 2nd: There were over 111 actions taken on existing and new cases. Inspections to verify occupancy were completed on our current batch. One notice of violation, 21 abatement notices, and 9 abatement notices were mailed out. 29 cases were closed.

Eco-Happenings:

- Marsh Elementary School will be rolling out the school spirit recycling program after the holiday break.
- Curbside Recycling program is now accepting clean plastic bags and film. Place all plastic film in a bag before putting it in your brown recycling cart. Don't forget, it is always better to skip the plastic bag all together and use a reusable bag.
- Courtesy of our Public Works updates: We are in the process of installing "Doggie Waste Dispensers" at 4 additional City Parks, for your convenience. This project is being spearheaded by a young man working on his Eagle Scout project. Be watching for further information and locations.

CDBG:

- The City of Antioch will be joining with the other Consortium members to update the HUD-required 2010-15 Analysis of Impediments to Fair Housing Choice, and will be contracting with a consultant who is preparing the City of Richmond Consolidated Plan. Total cost to each of the jurisdictions is approximately \$4,000, which is considerably less than the preparation of the initial report. This update is being required by our HUD office in advance of a complete redesign of this report which will be effective for the 2020-25 Consolidated Plan.
- Monitoring by Antioch and other Consortium members is underway and will continue through December.

Housing:

- Lower income residents of Lakeshore Apartments, including members of the ALIVE program in Antioch, have contacted the City to request assistance in finding new affordable housing for persons with disabilities when Lakeshore becomes market-rate housing in 11 months. Antioch Housing program will contact all affected residents with information and referrals, invite qualifying individuals to apply for the Tabora Gardens project when completed, and work with the County Housing Authority to help locate housing.
- Construction of a new Housing database and integration of all files is commencing with City Data Services (CDS), and monitoring of Housing Successor assets continues.

Homeless:

- The Council on Homelessness continues to push relentlessly to meet its Zero: 2016 goals to house homeless Veterans, it has identified 40 homeless Vets who have different types of vouchers but who are unable to find housing. All agencies are pitching in to work with the Vets and landlords to bring them home for the holidays.

DROUGHT UPDATES:**It is now time to just turn those irrigation controllers off for the winter!**

Great job falling back into water conservation! For October, the monthly conservation total was 31.126%. Our cumulative total for the entire city that as a water agency, we must report to the state dropped slightly to 33.367%. Our state mandated reduction is 28%, so to keep us above that, now it is time to move that effort indoors! Check out <http://saveourwater.com/what-you-can-do/tips/> for inspiration.

Irrigation repairs and updates:

- Park Water Reductions: ALL City Parks have now been put in Rain Shutdown (Off).
- Chichibu Park: A 3" water main-line break was repaired.
- Contra Loma Estates Park: Another water main-line break was incurred, and water is shut down until repairs can be made this week.
- Mira Vista: A new sink faucet was installed in the men's restroom, to replace the old faucet that was wasting water by not shutting off properly.
- Country Hills Dr. - 55 sprinklers repaired, 37 sprinklers adjusted and 1 valve rebuilt.
- Farallon Ct. – 5 sprinklers repaired, 10 wiper seals replaced and 1 valve rebuilt.
- A St Extension – 1 sprinkler repaired.
- Country Hills Dr. – 28 sprinklers repaired and 1 lateral line repaired.

PUBLIC WORKS UPDATES

Administration

- The Contractor will open the new Slatten Ranch Road westbound (WB) loop on-ramp and temporarily close the existing Hillcrest WB on-ramp for reconstruction, Fri. night, Dec. 4 into Sat. morning, Dec. 5. If you are heading northbound on Hillcrest (from Davison Drive and Dear Valley Road) you will now need to turn right on Slatten Ranch Road and then right on to the new westbound on-ramp. This is the permanent configuration for northbound traffic. If you are heading southbound on Hillcrest (from the railroad tracks) you will temporarily need to turn left on to Slatten Ranch Road and then right onto the new westbound on-ramp.
- In response to a possibility of an El Nino winter, Public Works has been making preparations for these conditions including intensified storm drain cleaning, procurement of extra sand bags and sand, as well as ensuring staff is ready for action 24/7. The City website will have additional information about what the City is doing and how the community can better prepare for the possibility of a severe winter.
- The City of Antioch is being required to reduce its 2015 water usage by 28% in 2015 using 2013 as the base year. Outdoor water conservation will be the primary focus of the City's program as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th. All Antioch customers will be mailed a letter explaining the program and prohibitions as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 am and 5:00 pm, shut off nozzles required on all hoses, and drinking water available only upon request at restaurants. Contra Costa Water District has incentives, such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. More information on water conservation programs and ideas on how to conserve water can be found at www.ccwater.com or www.antiochwater.com. Customers who are not in compliance with drought restrictions can be reported to the Antioch Drought Hotline at (925) 779-6140.

The water customers in Antioch reduced usage in November by 31.13% compared to November 2013. Our cumulative reduction from June 2015 through November is 33.37%. Great job!!

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction.
- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: CVS and Grocery Outlet stores are open for business and other building pads are in development and planning stages. Environmental clearances and USBR permitting requirements for the Phase 2 development are in progress.
- City Sports Club, located at 5001 Lone Tree Way: Building and parking lot construction is nearing completion.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: Staff is reviewing the final development plan and preparing project conditions of approval.
- Oakley Knolls Subdivision 9353, a 31-lot development by Discovery Builders, located north of Oakley Road 1,300 feet west of Phillips Lane: Staff prepared conditions of approval for a tentative map application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Staff is reviewing the 4th submittal map and plans.
- Taco Bell, 1706 'A' Street: Construction is nearing completion.
- SR4 Corridor Widening Project: The Highway 4 Project hit another milestone on November 21 with the opening of one new lane of traffic on eastbound (EB) Highway 4. The additional lane starts at the Loveridge Road Overcrossing in Pittsburg, and extends to the "A" Street Undercrossing in Antioch. Commuters will be able to travel EB using the additional lane, adding up to 50% more capacity along this segment. This follows the early November opening of an additional two westbound lanes, doubling the westbound capacity, from "A" Street to Contra Loma Blvd. The project also includes newly configured on- and off-ramps from the highway to local roads.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project is nearing completion. There will be one-way traffic control on "G" Street between W. Tregallas Rd. and Drake St., Thurs.-Fri., Dec. 3-4, from 9 a.m. to 3 p.m. There will be lane closures in the northbound (NB) and southbound (SB) directions of "L" St./Contra Loma Blvd., Thurs.-Fri., Dec. 3-4, from 9 a.m. to 3 p.m. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Bridgework continues at the 'A' St./Lone Tree Way

and Cavallo Road Overcrossings. Work to extend Sunset Drive from Bryan Avenue to "A" Street is ongoing. Pedestrians and motorists are advised to exercise caution while travelling through these areas.

- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Work continues on the Hillcrest Avenue Bridge widening, the Pedestrian Overcrossing (POC) and the Maintenance of Works (MOW) Tunnel. The Contractor will open the new Slatten Ranch Road westbound (WB) loop on-ramp and temporarily close the existing Hillcrest WB on-ramp for reconstruction, Fri. night, Dec. 4 into Sat. morning, Dec. 5. Pedestrians and motorists are advised to observe "SR4 WB" detour signs and exercise caution while travelling through this area.
- BART Parking Lot and Maintenance Facility: Staff approved the design for a proposed 12" sanitary sewer main from the new Maintenance Facility, north of the S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing grant deeds for public easement dedications. Staff returned comments to BART's Ownership and Maintenance of Utilities Agreement for storm drainage improvements.
- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: Staff is processing abandonment of existing easements and new easements.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: Staff continues to meet with the developer to discuss various site and infrastructure issues. The tentative map has been submitted and staff is creating conditions of approval.
- Quail Cove, a proposed 32 unit housing located on the south side of Prewett Ranch Drive west of Heidorn Ranch Road: The tentative map has been submitted and staff is creating conditions of approval.
- Aviano, approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School. Staff is working with developer on the park extension. Construction documents for the first phase of the development have been submitted for 1st review.

Capital Improvements Division

- Sunset Booster Pump Station Replacement: The proposed layout of the pump station equipment and control is currently being reviewed by Staff. Shop drawings and material submittals are under review by Kimley/Horn and Associates.
- Water Main Replacement at Various Locations: A pre-construction conference between Staff and D & D Pipelines was held on November 23rd. Initial construction activities are scheduled to commence on Sunset Drive next week.
- West Antioch Creek Channel Improvements: Staff and the Contra Costa County Public Works Real Property Division continue to negotiate terms for the final few easements and property acquisitions required for this project. U.S. Fish and Wildlife is developing the project Biological Opinion as part of their consultation with the U.S. Army Corps of Engineers. The State Historical Preservation Officer is

reviewing the updated Cultural Resource Study. U.S. Army Corps of Engineers and the California Department of Fish and Wildlife (CDFW) are reviewing the Re-vegetation and Monitoring Plan. Staff met with CDFW on November 24th to discuss the City's comments on the Routine Maintenance Agreement. Staff and RMC Water and Environment continue to work with PG&E, AT&T and Comcast regarding the relocation of existing utility facilities.

- Water Treatment Plant Disinfection Improvements: Staff has reviewed and returned the initial environmental documents developed by CDM Smith. Staff met with CDM Smith on November 19th to discuss the City's comments on the 60% draft project plans and specifications.
- Water Treatment Plant Electrical Upgrades: A project kick-off meeting between staff and TJC and Associates was held on November 25th. TJC has commenced reviewing the existing electrical plans for the Water Treatment Plant.
- Urban Water Management Plan Treatment: A project kick-off meeting between Staff and West Yost Associates was held on November 19th. West Yost has commenced compiling the information necessary to develop this report.
- Cathodic Protection Assessment: Staff is finalizing the contract with JDH Corrosion Consultants, Inc. to conduct a thorough assessment of all pipeline cathodic protection systems within the City and draft a comprehensive report summarizing the findings and providing remediation recommendations.
- County Hills Drive and Vista Grande Drive Water Main Replacement: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for January 12th at 2:00 P.M. in the City Council Chambers located at 200 "H" Street.
- 2015 Transportation Development Act (TDA) Grant: JD Partners completed the construction of 27 new curb ramps along Bluerock Drive and West Tregallas Road. The City Council will consider the final acceptance of the project at the January 12, 2016 meeting.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to update anticipated land uses and the transportation network to be used in the traffic model. The final draft Fee Study will be presented to the City Council for comments in January 2016.
- Prewett Water Park Improvements: RHAA is under contract for the design of the final improvements at Prewett Water Park. The 90% design plans and specifications of the spray ground and the play ground facility are completed and under review. The bid packages for both projects are expected to be out for bid in January 2016 and construction is expected to be completed by September 2016.
- North East Annexation Infrastructure Improvements: Staff is drafting a Request for Proposal for consulting services to provide engineering services and to prepare preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve the newly annexed Area 1 and 2B.

- Pavement Management Technical Assistance Program (P-TAP) Grant: Staff has submitted a \$95,000 grant application to MTC for consulting services to assist the City in updating the annual Pavement Management Program System by inspecting the pavement conditions of arterial, collector and residential streets and provide us with design recommendations for pavement rehabilitation projects.
- 2016 CalRecycle Rubberized Pavement Grant: CalRecycle has issued the Notice of Funding Availability for the Rubberized Pavement Grant Program. Staff will submit an application for funding for the 2016 Pavement Management Program, which will include potential streets recommended to receive Rubberized Cape Seal treatments. Grant applications are due December 10, 2015.
- 2016 Transportation Development Act (TDA) Grant: MTC is soliciting applications for the 2016/2017 TDA grant for Pedestrian and Bicyclist improvement projects. Staff is reviewing potential projects to be included in the grant application for funding for curb ramp upgrades to meet ADA requirements, installation of new sidewalks at needed locations and for bicyclist improvements. Grant applications are due January 21, 2016.

Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower. This is reoccurring and ongoing.
- Completed installing new wear shoes and floor strips in "B" basin.
- Installed a new 10 inch discharge line off of the EQ basin pump manifold.
- Cleaned out valve cans and electrical vaults around "B" plant.

Water Distribution

- Water crews had 204 stops for water service including disconnections.
- Water crews had a total of 62 Underground Service Alert (USA) tickets completed for utility location.
- Meter reading has started for the month of December and is on schedule.
- There were seven drought notices issued this week.
- Meter reading for the month of December has started and is on schedule.
- Water crews continue to monitor water meters, conservation and usage at all City buildings and parks.
- Water Distribution personnel continue to respond to drought hotline inquiries.
- Water field techs responded to customer calls regarding water related issues city wide.
- Water crews repaired a 12" water transmission main on Lone Tree Way.
- Water crews repaired a 6" water main on Sunset Lane.
- Water crews replaced a 1" water service on Poppy Way.
- Water crews replaced a 1" water service on Phillips Lane.
- Water crews assisted the streets crews with paving service cuts.

- Central Stores staff purchased materials for multiple emergency water breaks for Distribution crews.
- Central Stores staff continues to remove graffiti and household debris at Amtrak platform and Fulton Shipyard Rd. boat launch facility.
- Central Stores issued 185 line items from inventory and received 103 line items into inventory.
- Central Stores ordered materials for the rehab of existing backflow devices in several different areas within the city.
- Assisted various departments with ordering supplies/materials needed for daily use.

Public Works Operations – Parks and Landscape

- Playground and Park Safety Inspections: Completed at Chaparral, Deerfield, Heidorn, Knoll, Meadow Creek and Nelson Ranch Parks. Follow-up inspections were performed at Country Manor and Eagleridge Parks.
- Chichibu Park: Repaired a three inch water main line break.
- Citywide Parks: In the process of installing “Doggie Waste Dispensers” at four additional parks. This project is being spearheaded by a young man working on his Eagle Scout rating. Additional information and locations to follow in future updates.
- Contra Loma Estates Park: A new playground installation is complete and now open for use. Many thanks to all those involved in the construction. A gala grand opening was held on Saturday, November 21, 2015. Unfortunately, the newly installed fencing in the southwest corner of the park was recently vandalized. Crews repaired a four inch water main line break.
- Country Manor Park: Installed a new DX-2 irrigation controller for improved water conservation efforts.
- Markley Creek Park: Completed a playground surface repair.
- Markley Creek Dog Park: Installed a brand new memorial bench in the small dog area on November 17, 2015. This bench was donated and funded by Tammy Finden, in honor of her late husband, Marvin “Goose” Finden.
- Mira Vista: Replaced a leaking sink faucet in the men’s restroom.
- Park Water Reductions: All park irrigation has been turned off in preparation for the rainy season.
- Park Lighting Survey: Completed the annual inspection of all park and park restroom lighting. Repairs and lamp replacements are underway.
- Tree Removal Permits: No permits were issued.
- Irrigation: Repaired 122 irrigation leaks on City property which completes 2,825 irrigation repairs since June 10, 2015.
- Trim Crews: Black Diamond Dr., Heidorn Ranch Rd., Deer Valley rights of way, Prewett Ranch Dr. and the Deerfield Corridor.
- Pre-emergent Spraying: Lone Tree Way, Pawnee Trail, James Donlon Blvd., Prewett Ranch Dr., and Buchanan Rd.
- Trim Courts: Almondridge Area.

Public Works Operations – Streets Maintenance

- Graffiti Abatement: Removed graffiti from City property in numerous areas.
- Signs: Replaced 62 existing signs due to poor reflectivity.
- Pave Service Cuts: Paved 16 service cuts using 72 tons of asphalt.
- Debris: Removed a yard of illegally dumped debris from City rights of way.
- Potholes: Filled three potholes.
- Parks Division: Assisted the Parks Division with their annual pre-emergent weed spraying.

Public Works Maintenance Operations – Collections Division

- Calls for Sewer Service: Received and responded to four calls for service from the public and responding crews televised 70 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 19,792 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the 'hot spots.'
- Sewer Lateral Maintenance Program (SLMP): No emergency sewer lateral repairs reported this week. Crews televised two lateral(s).
- Manhole Inspection Program: Crews inspected 90 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of "SMART Manholes" in strategic areas will be utilized that will alert leadership staff within the division of potential SSO's. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 2,472 feet of sewer main lines. The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and SSOs.
- NPDES (National Pollutant Discharge Elimination System): Crews remove green waste from pruned trees at various creeks and channels and clean/inspect v-ditches. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways.

- Preventative Maintenance: Five services on City vehicles as scheduled.
- Unscheduled Repairs: 35 unscheduled, necessary repairs to City vehicles.
