Antioch had a very high **72.45% voter turnout** for the November 8<sup>th</sup> General Election. There are now 51,664 registered voters in the City of Antioch, an increase of 5,000 more than were registered for the June Primary.

22,057 Antioch registered voters cast mail-in ballots, while 14,376 voters cast their ballots at a precinct polling place.

- On Monday, ACT members met to nominate members to the new representative positions. This structure will help focus the council and enable them to better collaborate on new projects. Congratulations to Jafar Khalfani-Bey on becoming the Antioch Council of Teens first president!
- On Tuesday, final bookings were made for the teen retreat on January 7<sup>th</sup>. The teens will head to San Jose for a team building activity followed by dinner.
- On Wednesday, past Water Park buyout and slide rental customers were contacted with marketing material for 2017 buyouts. Rental applications open January 3<sup>rd</sup>.
- Throughout the week, staff began the process of updating the Water Park website.
   The update should be complete by the start of the New Year.
- On Monday, the City's Ansul system vendor completed semi-annual service to the commercial hood systems at the Senior Center, Community Center, and the Water Park. These services are completed as part of the City's fire prevention program.
- On Monday, City representatives met with a plumbing vendor to discuss replacing a grease trap at the Senior Center, a proposal will be forthcoming.
- On Monday, City staff met to collaborate on the possibility of utilizing a grant program for the installation of an Electric Vehicle charging station at Prewett Community Park. Adopting green technology is a key goal of the Recreation Department.
- On Wednesday, The City's door vendor installed a replacement door at the Water Park that was damaged by vandals.
- On Wednesday, Recreation maintenance staff worked to resolve several department door issues.
- On Thursday, Water Park staff completed outstanding items in preparation for the final Health Department inspection for the new Spray Ground.

# Senior Center Services

## **Housing:**

As previously reported, the County has decided to end their Neighborhood Preservation Program for all cities. This program rehabilitated homes for lower income homeowners, and was in operations for several decades.

Consortium members sought nonprofits to take on this task, and received one application from Habitat for Humanity of the East Bay/Silicon Valley. Habitat applied for the cities of Antioch, Pittsburg, Walnut Creek, and the County, as the County was seeking more capacity than its limited NPP program has at this time. We will be jointly meeting with the applicant to discuss the application details. The earliest that Habitat could begin service delivery is 7/1/17.

This application, along with the other CDBG and Housing Successor applications, will be reviewed by the CDBG Council Subcommittee in February and come before Council with funding recommendations in May 2017.

#### Homeless:

November Homeless Awareness Month donations continued through last week, and the barrel in City Hall will continue through January. The collection barrel is on the 2<sup>nd</sup> floor by the elevator.

Thanks to all who have contributed, we now have collected OVER 900 POUNDS of donated items!! Everything is being distributed to the nonprofit agencies in our community who serve those without shelter during these cold and rainy winter months, and they send you their heartfelt thanks!

# **Engineering & Development Services**

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18<sup>th</sup> Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction and provided a punch list for offsite improvements.
- The Habit Burger, 2424 Mahogany Way, a new restaurant development: The project was approved at the 7/20/16 Planning Commission meeting. Staff has approved construction drawings for building permit issuance.
- Olive Groves Subdivision, 263 single-family detached senior housing units with assisted living facility, commercial uses and open space, east of Deer Valley Road and south of Sand Creek: Residential portion gated with private streets. Staff is preliminarily reviewing the PDP-16-01 application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: The subdivision plan and map checks have been completed. The developer is currently grading the site "at-risk". A Resolution to form the East Lone Tree Specific Plan Benefit District will be presented at a public hearing at the 12/13/16 City Council meeting. A Resolution of Intention to form the Community Facilities District 2016-01 (Police Services) will also be presented at the 12/13/16 City Council with a public hearing to follow at the January 24, 2017 City Council meeting. A reimbursement agreement for roadway and utility improvements was approved by the City Council at the 11/22/16 meeting.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project has been accepted by the State. City staff is working with Caltrans to complete the punch list.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: City staff is working with Caltrans to complete the punch list.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and BART Tunnel Project: Staff
  prepared a punch list for Caltrans' contractor to complete. City staff is working with
  the CCTA to complete the punch list.

- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School: Staff is reviewing the 3<sup>rd</sup> submittal for the first phase of construction documents and plans. Staff received an estimate from the consultant for review of the 1<sup>st</sup> submittal for Phase 2.
- Staff is working with the developers to create Community Facilities Districts for Sand Creek Focus Area landscape maintenance.

- Zone I Transmission Pipeline Rehabilitation at HWY 4: Project plans and specifications are available for purchase at a cost of \$100 per set. The public bid opening for this project is scheduled for December 13<sup>th</sup> at 2:00 p.m. in the City Council Chambers located at 200 'H' Street.
- Downtown Sanitary Sewer Rehabilitation: Construction bids were publically opened on November 22<sup>nd</sup>. The lowest responsive bid was received from A-S Pipelines, Inc., in the amount of \$1,890,200. The award of this project is scheduled to be considered at the December 13<sup>th</sup> City Council meeting.
- Sunset Booster Pump Station Replacement: All work has been completed. The
  acceptance of the project is scheduled to be considered at the December 13<sup>th</sup> City
  Council meeting.
- Water Treatment Plant Disinfection Improvements: CDM Smith is developing the 100% draft project plans and specifications.
- Water Treatment Plant 'A' Electrical Improvements: TJC and Associates is developing the 100% draft project plans and specifications.
- Community Block Grant Downtown Roadway Pavement Rehabilitation: Staff is developing 50% draft project plans and specifications.
- West Antioch Creek Channel Improvements: Condemnation negotiations are proceeding regarding acquisition of property and easements located at 1400 and 1420 West 10<sup>th</sup> Street. U.S. Fish and Wildlife Services' review of this project's Biological Assessment continues to be delayed by the agencies current focus on the CA WaterFix project.
- Brackish Water Desalinization Plant: Carollo Engineers is developing a treatment process technical memorandum. State Water Resources Control Board is performing a management level review of the City's State Revolving Fund loan application.
- North East Annexation Infrastructure Improvements: BKF Engineering is now under contract to provide engineering services and preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve Annexation Areas 1 and 2B. BKF is working on the aerial survey and will provide the City with a complete survey in December.
- Prewett Water Park Improvements: Sierra Valley Construction completed the construction for the playground and the spray ground facilities and is working on the

- punch list items. Staff will schedule the County Health's and Fire District's final inspections. Grand opening of the playground was on November 5<sup>th</sup> and the park is open for public use.
- Antioch Pavement Management Street Survey: AMS Consulting Services will
  perform a comprehensive citywide pavement condition survey of all city streets.
  Inspection of the pavement condition will be done using Mobil Mapping System
  equipment. The citywide pavement inspection by the mobile mapping vehicle is
  underway.
- Retaining Walls Rehabilitation: Staff publicly opened bids on November 8<sup>th</sup>. The award of the project to the lowest bidder that met all qualifications will be considered at the December 13<sup>th</sup> City Council meeting. Construction is expected to start in January 2017 and completed by March 2017.
- "L" Street Path of Transit Corridor: MTC issued a call for projects for the ONE BAY AREA GRANT (OBAG 2) PROGRAM federal grant funding. Staff will be submitting an application for federal funding for bike lanes and pedestrian improvements on "L" Street from HWY 4 to the Antioch Marina. The grant application is due December 9, 2016.

## Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower.
- Cleaned and inspected Lone Tree and Mira Vista tanks. The tanks are in excellent condition. Minor repairs were made on the Mira Vista tank.
- Cut and removed cat tails and weeds away from the reservoir spillway.
- The #4 booster pump's motor was removed from service for repairs. The motor will be inspected and have new bearings installed.
- Plant "B" basin solids waste valve controls were reconfigured to operate on SCADA. This will provide more versatility for the waste position.

## Water Distribution

- Responded to 201 stops for water service including disconnections.
- Had a total of 38 USA tickets completed for utility location.
- Meter reading for the month of December has started and is on schedule.
- The City of Antioch now has a 0% water conservation goal through January of 2017 based on the State of California's "stress test". However the following prohibitions will remain in place:
  - Watering outdoor landscapes in a manner that causes excessive runoff such that water flows onto adjacent property, non-irrigated areas, private and public walkways, roadways, parking lots, or structures.
  - Using a hose without a shut off nozzle.
  - Washing paved or other hard-surfaced areas, including sidewalks, walkways, driveways, patios and parking areas.

- Use of City furnished water for non-recalculating decorative fountains or filling decorative lakes or ponds.
- Failing to repair a controllable water leak.
- Repaired a repaired a water main on Rossi Ave.
- Replaced a water service on Rotherham Dr.
- Replaced a damaged backflow device at Slatten Ranch.
- Repaired a main line valve on Fawn Hill Way.
- Meter test program has started in routes 11 thru 20.
- Now performing proactive leak detection.
- State mandated annual backflow testing program is on schedule.
- Staff performed citywide preventative maintenance on fire hydrants and water quality flushing.
- Central Stores staff cleared debris and graffiti from Amtrak platform.
- Central Stores staff cleared household debris and graffiti from the Fulton Shipyard Road boat launch area.

# <u>Public Works Operations – Parks and Landscape</u>

- Playground and Park Safety Inspections: Completed at Antioch Community and Canal Parks. Follow-up inspections were completed at Harbour Park.
- Park Irrigation: All park irrigation water is currently off.
- Antioch Community Park: Repaired lights at the playground restrooms.
- Antioch Water Park: Repairs have begun on the leaking water main-line.
- Chichibu Park: Removed graffiti from all four restroom exterior wall panels.
- Tree Maintenance Pruning: Completed at Antioch Community Park.
- Tree Removal Permits: Tree Removal permits were issued for 1123 Cook St. and 3100 Gentrytown Dr.
- Irrigation: Repaired nine irrigation leaks on City property as needed.
- Trim Crews: Deer Valley rights of way, Deerfield Corridor trail, Deer Valley medians, Mokelumne Dr., Delta Fair Blvd., Indian Hills Dr., Prewett Ranch Dr., and Dallas Ranch Rd.
- Spot Spray: City Hall, 2<sup>nd</sup> St. planters, and Canada Valley trail.
- Roadside Spray Program: G St., E. 18<sup>th</sup> St., and Wilbur Ave.
- Reprogramming of controllers to winter settings: 100% complete.
- Tree Limb Removals: Citywide due to high winds.

# <u>Public Works Operations – Street Maintenance</u>

- Graffiti: Removed graffiti from numerous areas around the City.
- Signs: Replaced 62 existing signs due to poor reflectivity or line of sight issues.
- Pave: Minaker Dr. cul-de-sac utilizing 80 tons of asphalt.
- Potholes: Filled 44 potholes.
- Weed: Conducting the annual right of way weed spray application.
- Street light survey: Began the annual night time survey of street lights, lighted street name signs at traffic signals, and sign reflectivity.

 Crews assisted the Parks Department by removing bollards in the green belt on Meadow Lake Dr.

# <u>Public Works Utilities – Collections Division</u>

- Calls for Sewer Service: Received and responded to 6 calls for service from the public. Responding crews televised 210 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 19,978 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified priority locations and integrate a proactive preventative cleaning schedule for these pipelines.
- Sewer Lateral Maintenance Program (SLMP): Repaired three laterals that were severely damaged requiring immediate repair. Crews also televised the three laterals.
- Manhole Inspection Program: Crews inspected 54 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.
- Sanitary Sewer Overflow (SSO) Reduction Program: Staff has completed the
  installation of SMART Manhole devices in strategic locations selected. The live
  system monitoring began October 11, 2016. The use of "SMART Manholes" in
  strategic areas will be utilized to alert leadership staff within the division of potential
  SSOs. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 6,844 feet of sewer main lines this past week. The CCTV Preventative Maintenance inspects sewer mains to identify the condition and causes of blockages and SSOs. The lateral crew inspected 173 sites and televised 138 public sewer laterals consisting of 4,844 linear feet.
- National Pollutant Discharge Elimination System: Crews picked up 85 yards of waste, 41 bags of trash, 2 mattresses, 2 couches, and 19 shopping carts of illegal dumping from various creeks and channels. Crews also repaired one damaged fence. These activities ensure the City meets the federal Clean Water Act requirements of municipalities discharging storm water into waterways.

# Public Works Operations – Fleet Division

- Preventative Maintenance: 14 services on City vehicles as scheduled.
- Unscheduled Repairs: 73 unscheduled necessary repairs to City vehicles.

## Public Works Operations – Municipal Marina

- The Marina responded to six berthing inquiries and provided one facility tour.
- Marina Maintenance: Removed hyacinth and debris from the Marina basin and trimmed trees along the trail, including removal of a dead tree.

- Adjusted the dock rollers along 'A' dock and installed lag bolts to the fire station on 'A' dock.
- Replaced 14 power pedestal light bulbs along 'A' & 'B' docks.
- Repaired boards along 'A' dock; 70% complete.
- Removed graffiti from four light poles.
- Serviced and lubricated the entrance gates.
- Installed Comcast Internet offering a cost effective and more reliable, stronger Wi-Fi. Commenced repairs to the public dock behind Humphrey's replacing three missing cleats and broken boards.
- Advertising and Outreach: Approved advertisements placed in Yachtsman magazine reaching over 40,000 boaters, Craigslist advertisements placed in Bay Area, Stockton, Sacramento, Monterey, and Santa Cruz listings. We are advertising Annual Boat Launch Ramp Passes for \$100 and the Automated Self fueling station on Craigslist.

- Animal services: Replaced multiple lights.
- City Hall: Decorated the Pine tree in front of City Hall with Christmas lights and installed a hasp lock on the vandalized water bill drop box. Crews completed resurfacing the floors on the 3rd floor.

- Police Department: Replaced a section of cast iron drain pipe in the evidence office.
- W. 2nd St.: Repaired multiple vandalized tree lights.
