FINANCE UPDATES

On December 30th, the Director of Finance received notice of approval of the Successor Agency to the Antioch Development Agency's Long Range Property Management Plan (LRPMP) from the California Department of Finance (DOF). The Director, MRG consultant and City Manager worked diligently with DOF to complete minor amendments to the LRPMP, which were approved by the Successor Agency Oversight Board on December 22nd. The LRPMP had to be approved by the DOF by December 31st in order for the Agency to implement the LRPMP or else the properties would have been subject to immediate disposition by the State. This is another huge milestone for the Agency (as a finding of completion was recently received) that will aid in the wind down of the former redevelopment agency and the use/transfer/or sell of all former redevelopment properties, which have been in limbo since AB 1X 26 was passed in 2011, which abolished redevelopment agencies across the state effective in 2013.

RECREATION UPDATES

- During the school winter break, a couple dozen youngsters enjoyed swim camps at the Antioch Water Park. Campers had a great time playing games, doing arts and crafts and ***Being Cool in the Pool*** during the cold weather!
- Last week, Water Park staff updated files, cleaned cabinets, and recycled unneeded documents to prepare for the 2016 season.
- Staff completed the first draft of the “Summer 2016 Employee Handbook for the Antioch Water Park.” It isn’t too early to get ready for the upcoming summer season!
- The pool rentals package for the Water Park has been updated for 2016; schools are already preparing for their end of the school year swim parties!
- Last week, staff completed annual and quarterly maintenance tasks at the Antioch Community Center, Nick Rodriguez Community Center and the Antioch Senior Center.
- The City's vendor for pool boiler maintenance completed annual service on four of the water park boilers this week. The fifth boiler has been deferred pending an evaluation for replacement.

- Reminder that there is no garbage and recycling collection on Christmas and New Year's Day. For customers with Friday service, your service will happen on Saturday.
- Holiday tree recycling:

- Drop-off Locations: You can drop off your unflocked trees from 8 a.m. - 5 p.m. **Saturday and Sunday, January 2nd and 3rd and January 9th and 10th, 2016**, in the designated areas at the Prewett Family Water Park parking lot and at the Antioch Marina overflow parking lot at 2nd and L Streets. Please remove tree stands, lights and all decorations before drop-off.
- Boy Scout Treecycling: Scouts will pick up holiday trees **Saturday - Sunday, January 2nd and 3rd, and Jan. 9th and 10th, 2016**. Have trees ready for pickup before 9 a.m. at the curb. Donations of \$10 for unflocked trees or \$1 per foot if taller than 10 feet or \$20 for flocked trees, payable to BSA, would be appreciated. - Any yard waste week: Place unflocked trees in yard waste cart. Branches must be 6 inches or less in diameter and 3 feet or less in length. Cut off tree top. Remove tree stand. Lid must be closed.

CDBG:

- Monitoring by Antioch and other Consortium members is underway and will continue through January.

Housing:

- Construction of a new Housing database and integration of all files is commencing with City Data Services (CDS), and monitoring of Housing Successor assets continues.

Homeless:

- Homeless Point in Time Count, mandated by HUD, will occur at the end of January. Antioch will host the East County meeting to train volunteers, on Saturday January 23 from 9-11 a.m.
- New members to the Council on Homelessness, including Antioch PD acting Captain Diane Aguinaga, are expected to be formally appointed to the Council in January.
- The Executive Team met to plan proposed actions and accomplishments for the Council on Homelessness in 2016, and will be holding a Council retreat in February.
- Efforts continue to house homeless Veterans before the end of the year.

Drought Updates:

It is now time to just turn those irrigation controllers off for the winter!

- For the first two weeks of December, our water production was 16.9% less than December of 2013. This brings our cumulative total to 32.7%. Our state mandated reduction of 28% has to be maintained through February, 2016 or possibly beyond if

drought conditions persist. To keep us above that, now it is time to move that effort indoors! Check out <http://saveourwater.com/what-you-can-do/tips/> for inspiration.

PUBLIC WORKS UPDATES

Administration

- The State Route 4 eastbound off ramp at Somersville Road has been resigned and restriped for right and left turns only (no straight traffic is allowed). This should improve the operation of the intersection in the evening commute.
- In response to a strong possibility of an El Nino winter, Public Works has been making preparations for these conditions including intensified storm drain cleaning, procurement of extra sand bags and sand, as well as ensuring staff is ready for action 24/7. The City website will have additional information about what the City is doing and how the community can better prepare for the possibility of a severe winter.
- The City of Antioch is being required to reduce its 2015 water usage by 28% in 2015 using 2013 as the base year. Outdoor water conservation will be the primary focus of the City's program, as well as fines for wasteful practices as identified in the Water Conservation Resolution adopted by the City Council on May 12th. All Antioch customers will be mailed a letter explaining the program and prohibitions, as well as 2013 monthly water usage. Examples of prohibitions are: three day per week residential outdoor watering, no watering between the hours of 9:00 a.m. and 5:00 p.m., shut off nozzles required on all hoses, and drinking water available only upon request at restaurants. Contra Costa Water District has incentives, such as residential high-efficiency clothes washer rebates, water-efficient landscape rebates and smart sprinkler timer rebates. More information on water conservation programs and ideas on how to conserve water can be found at www.ccwater.com or www.antiochwater.com. Customers who are not in compliance with drought restrictions can be reported to the Antioch Drought Hotline at (925) 779-6140.
- **The water customers in Antioch reduced usage in November by 31.13% compared to November 2013. Our cumulative reduction from June 2015 through November is 33.37%.**
- Final Statistics for the Delta Diablo Residential Recycled Water Fill Station Pilot Project – July through December 2015; the total water used by Antioch, Bay Point and Pittsburg residents combined was 2,045,426 gallons. 1,227,331 gallons of this amount were used by Antioch residents.

Engineering & Development Services

- Almondridge East Subdivision 8880, an 81-unit single family home development by KB Homes, located between East 18th Street and Oakley Road, east of Phillips Lane and west of the State Highway 160: Staff is reviewing plot plans for ongoing new home construction.

- Buchanan Crossings Shopping Center, a 103,139 square foot commercial center on a 13.5-acre site located at the northwest corner of Somersville Road and Buchanan Road: CVS and Grocery Outlet stores are open for business and other building pads are in development and planning stages. Environmental clearances and USBR permitting requirements for the Phase 2 development are in progress.
- City Sports Club, located at 5001 Lone Tree Way: Building and parking lot construction is nearing completion.
- DeNova Homes Mixed Use Project at Hillcrest Ave./Wildflower Dr.: Application for mixed use project consisting of 9.5 acres commercial, 8 acres multi-family, and 2.2 acres single family development. The Planning Commission discussed DeNova's PDP-15-01 application on August 19th.
- Laurel Ranch, a 186-unit housing development by Richland Communities, located at the eastern terminus of existing Laurel Road and west of Highway 4: Staff is reviewing the final development plan and preparing project conditions of approval.
- Oakley Knolls Subdivision 9353, a 31-lot development by Discovery Builders, located north of Oakley Road 1,300 feet west of Phillips Lane: Staff prepared conditions of approval for a tentative map application.
- Park Ridge Phase I, a 123-unit housing development by Davidon Homes, located west of Canada Valley Road and east of Highway 4: Staff returned comments to the 4th submittal map and plans.
- Taco Bell, 1706 'A' Street: The new restaurant is now open for business.
- SR4 (Segment 2) Contra Loma Blvd. Interchange/'G' Street Overcrossing Project: The project is nearing completion and punchlist items are being addressed by the contractor. Pedestrians and motorists are advised to exercise caution while travelling through this area.
- SR4 (Segment 3A) 'A' Street/Lone Tree Way Interchange, Cavallo Road/Garrow Drive Undercrossing Project: Work continues on the 'A' St./Lone Tree Way and Cavallo Road Overcrossings and the new Sunset Drive from Bryan Avenue to "A" Street extension. Pedestrians and motorists are advised to exercise caution while travelling through these areas.
- SR4 (Segment 3B) Hillcrest Avenue Interchange and eBART Tunnel Project: Work continues on the Hillcrest Avenue Bridge widening, the Pedestrian Overcrossing (POC) and the Maintenance of Works (MOW) Tunnel. The new Slatten Ranch Road westbound (WB) Loop on-ramp is open to traffic and the Hillcrest WB on-ramp is temporarily closed. Pedestrians and motorists are advised to observe "SR4 WB" detour signs and exercise caution while travelling through this area.
- eBART Parking Lot and Maintenance Facility: Staff approved the design for a proposed 12" sanitary sewer main from the new Maintenance Facility, north of the S.P.R.R. railroad line to the southerly extension of Willow Avenue and is reviewing grant deeds for public easement dedications. Staff returned comments to BART's Ownership and Maintenance of Utilities Agreement for storm drainage improvements.

- Deer Valley Business Park, commercial development fronting Country Hills Drive between Lone Tree Way and Deer Valley Road: processing abandonment of existing easements and new easements.
- The Vineyards at Sand Creek, a proposed 641 unit housing development located on Sand Creek Road between Heidorn Ranch Road and Hillcrest Avenue: staff continues to meet with the developer to discuss various site and infrastructure issues. The tentative map has been submitted and staff is creating conditions of approval.
- Ranch, a proposed 1,667 unit housing development located between Deer Valley Road and Empire Mine Road: staff is preparing comments for preliminary development plan.
- Quail Cove, a proposed 32 unit housing located on the south side of Prewett Ranch Drive west of Heidorn Ranch Road: The tentative map has been submitted and staff is creating conditions of approval.
- Aviano, an approved 533 unit housing development located west of the current terminus of Hillcrest Avenue, east and north of Dozier-Libby Medical High School. Staff is working with developer on park extension. First phase of construction documents submitted for 1st review.

Capital Improvements Division

- Sunset Booster Pump Station Replacement: Reviewed material submittals were returned to the contractor with instructions to take various actions. Staff will be meeting with JMB Construction to discuss the layout of the pump station equipment and controls.
- Water Main Replacement at Various Locations: D & D Pipelines is installing new water facilities on Sunset Drive. The contractor will continue progress after the holidays.
- West Antioch Creek Channel Improvements: Property and easement acquisitions or rights of entry have been obtained from all effected private land owners. Contra Costa County Public Works Real Property Division is negotiating terms with the State of California's 23rd District Agricultural Association pertaining to land acquisitions within the footprint of the Contra Costa Fairgrounds. U.S. Army Corps of Engineers continues permitting consultations with the U.S. Fish and Wildlife and the State Historical Preservation Officer. The revised Routine Maintenance Agreement provided by the California Department of Fish and Wildlife is under review. PG&E is developing the electric design for 1201 West 10th Street. AT&T has performed exploratory excavations of their utilities within West 10th Street.
- Water Treatment Plant Disinfection Improvements: CDM Smith is developing the 90% draft project plans and specifications. Staff will be meeting with CDM to discuss equipment programming and redundancies within the new disinfection facilities.
- Water Treatment Plant Electrical Upgrades: Existing Water Treatment Plant electrical plans are being reviewed by TJC and Associates. A site investigation of the plant's existing electrical facilities has been scheduled for early January.

- Urban Water Management Plan: West Yost is compiling the information necessary to develop this report. Notification letters to adjacent water agencies regarding the City's intent to review and consider amendments to the Urban Water Management Plan have been mailed.
- Cathodic Protection Assessment: Staff is finalizing the contract with JDH Corrosion Consultants, Inc. to conduct a thorough assessment of all pipeline cathodic protection systems within the City and draft a comprehensive report summarizing the findings and providing remediation recommendations.
- Country Hills Drive and Vista Grande Drive Water Main Replacement: Project plans and specifications are available for purchase at a cost of \$75 per set. Copies may be obtained by logging on www.blueprintexpress.com/antioch or by calling BPXpress Reprographics at (707) 745-3593. The public bid opening for this project is scheduled for January 12th at 2:00 P.M. in the City Council Chambers located at 200 "H" Street.
- 2015 Transportation Development Act (TDA) Grant: JD Partners completed the construction of 27 new curb ramps along Bluerock Drive and West Tregallas Road and working on new ramps along San Joaquin Avenue. The City Council will consider the final acceptance of the project at the January 26, 2016 meeting.
- Transportation Impact Fee Study: Staff is working with the consultant, EPS, to finalize the land use forecasts and the transportation improvement list and network to be used in the traffic model. The final draft Fee Study will be presented to the City Council for public review and comments in April 2016.
- Prewett Water Park Improvements: RHAA is under contract for the design of the final improvements at Prewett Water Park. The 90% design plans and specifications of the spray ground and the play ground facility are completed and under review. Both bid packages are expected to be out for bid in February 2016; construction is expected to be completed by October 2016.
- North East Annexation Infrastructure Improvements: Staff is drafting a Request for Proposal for consulting services to provide engineering services and to prepare preliminary plans, estimates and studies for the planning and the design of infrastructure improvements needed to serve the newly annexed Area 1 and 2B.
- Pavement Management Technical Assistance Program (P-TAP) Grant: Staff has submitted a \$95,000 grant application to MTC for consulting services to assist the City in implementing and maintaining the annual Pavement Management Program System by inspecting the pavement conditions of arterial, collector and residential streets and provide us with design recommendations for pavement rehabilitation projects.
- 2016 CalRecycle Rubberized Pavement Grant: CalRecycle has issued the Notice of Funding Availability for the Rubberized Pavement Grant Program. Staff has submitted an application to supplement the gas tax monies that will be used for the 2016 Pavement Management Program.
- 2016 Transportation Development Act (TDA) Grant: MTC is soliciting applications for the 2016/2017 TDA grant for Pedestrian and Bicyclist improvement projects. Staff is reviewing potential projects to be included in the grant application for

funding for curb ramp upgrades to meet ADA requirements, installation of new sidewalks at needed locations and for bicyclist improvements. The grant application will be reviewed by the Parks and Recreation Commission as the City's Bicycle Advisory Committee at the January 21, 2016 meeting.

Water Treatment Plant

- Cleaned Solar Bees out on the municipal reservoir. Solar Bees circulate the water in the reservoir; cleaning the Solar Bees prevents weeds from restricting the circulation. Also cleaned the staff gage on the tower.
- Sealed the sluice plate in "B" applied channel.
- Completed annual maintenance on "B" Plant basin.
- Placed "B" in service and removed "A" plant from service for its annual maintenance.

Water Distribution

- Water crews had 150 stops for water service including disconnections.
- Water crews had a total of 59 USA tickets completed for utility location.
- Meter reading for the month of December has been completed.
- There were no drought notices issued this week.
- Water crews continue to monitor water meters, conservation and usage at all City buildings and parks.
- Water Distribution personnel continue to respond to drought hotline inquiries.
- Water field techs responded to customer calls regarding water related issues city wide.
- Water crews replaced a 1" water service on Peridot Court.
- Water crews exercised valves on Country Hills Drive.
- Water crews replaced a fire hydrant on Deer Valley Road.
- Water crews replaced a fire hydrant on Bluejay Drive.
- Water crews repaired a fire hydrant on Roosevelt Lane.
- Water crews repaired a 20" water main leak on Deer Valley Road.
- Water crews repaired a 10" water main on Somersville Rd.
- Water Crews repaired an 8" valve on Homestead Way.
- Water Crews repaired an 8" valve on Prewett Ranch Ct.
- Central Stores ordered replacement globes and lamps for downtown fixtures and park fixtures.
- Central Stores staff replaced and coordinated class 3 safety jackets for Public Works.
- Central Stores ordered parts for emergency dewatering pumps for the Collections Division.
- Central Stores ordered new a Pavement Breaker (jackhammer) for Collections Division.
- Central Stores staff continues to remove graffiti and household debris at Amtrak platform and Fulton Shipyard Rd. boat launch facility.

Public Works Operations – Parks and Landscape

- Playground and Park Safety Inspections: No park inspections were performed.
- Park Lighting Survey: Completed the annual inspection of all park and park restroom lighting. Repairs and lamp replacements are in progress.
- Turf Fertilization: Fertilized turf to thicken and promote optimum growth for Antioch Community, City, Country Manor, Deerfield, Fairview, Hansen, Jacobsen, Marchetti and Williamson Ranch Parks. Minimum watering has been turned back on at these parks to assist with the turf thickening. All irrigation in remaining City parks have been turned off for the rainy season.
- Tree Removal Permits: No permits were issued this week.
- Irrigation: Repaired 13 irrigation leaks on City property, which completes 2,942 irrigation repairs since June 10, 2015.
- Leaf Removal: Indian Hills Dr. from Lone Tree Way to Sagebrush Dr.
- Tree Limb Removal: Deer Valley Rd. south of Bluerock Dr.

Public Works Operations – Streets Maintenance

- Graffiti Abatement: Removed graffiti from City property in numerous areas.
- Signs: Replaced 71 existing signs due to poor reflectivity.
- Debris: Picked up 15 yards of debris in the right of way.
- Potholes: Filled 65 potholes.
- Parks Division: Assisted the Parks Division with their annual pre-emergent weed spraying.

Public Works Maintenance Operations – Collections Division

- Calls for Sewer Service: Received and responded to two calls for service from the public. Responding crews televised 1,225 linear feet of public sewer laterals connecting to the City's sewer system.
- Sewer Mains: Daily preventative maintenance performed on over 20,056 linear feet of sewer main lines.
- Quarterly Sewer Main Cleaning: The route schedule is under review to increase inspection frequency of identified 'hot spots' and integrate a proactive preventative cleaning schedule for the 'hot spots.'
- Sewer Lateral Maintenance Program (SLMP): Crews repaired one lateral that was severely damaged requiring immediate repair. Crews also televised 35 laterals.
- Manhole Inspection Program: Crews inspected 72 manholes. Manholes are inspected for loose lids, debris, locking mechanisms, and status of infrastructure for future maintenance and rehabilitation. We are updating the program and processes for integration in our computerized maintenance management system.

- Sanitary Sewer Overflow (SSO) Reduction Program: Staff is working on formal inspection criteria to inspect manholes in rural areas. The use of “SMART Manholes” in strategic areas will be utilized that will alert leadership staff within the division of potential SSOs. This program will also address the need for locking mechanisms.
- Closed Caption Televising (CCTV): Crews televised 669 feet of sewer main lines. The CCTV Preventative Maintenance crew inspects sewer mains to identify the condition and causes of blockages and SSOs.
- National Pollutant Discharge Elimination System (NPDES): Crews cleaned 1,400 linear feet and removed 75 yards of debris from v-ditches. These activities ensure the City meets the Federal Clean Water Act requirements of municipalities discharging storm water into waterways.

Public Works Operations – Fleet Division

- Preventative Maintenance: 11 services on City vehicles as scheduled.
- Unscheduled Repairs: 29 unscheduled, necessary repairs to City vehicles.

Public Works Operations – Municipal Marina

- Website: The new Marina website is attracting web traffic with over 2,000 total views. View the new Marina website at: <http://ci.antioch.ca.us/antioch-marina>. Customers can now pay online, apply for berthing, and schedule overnight reservations.
- Maintenance: Removed hyacinth and debris from the Marina basin. Cleared logs and debris from boat launch and guest dock ramps. Cleared green debris from parking lot curbs. Removed water from three vessels and monitored others due to the recent rains.
- Advertising and Outreach: Approved advertisements placed in Yachtsman magazine reaching over 40,000 boaters. Craigslist advertisements placed in Bay Area, Stockton, Sacramento, Monterey, and Santa Cruz listings. Advertising current fuel prices on Craigslist.

POLICE DEPARTMENT UPDATES

- On 12/29/15 at 6:44 pm 24 year old Kevin Sanchez entered the Wal-Mart and cut the security cords from several electronic display items. He then attempted to fraudulently return them for cash but was denied. Sanchez then left the store with the merchandise and was stopped by the store's loss prevention officer. Sanchez fought with loss prevention staff attempting to retain the property and escape. They were able to detain Sanchez who intentionally poked a loss prevention officer with a tack while they were trying to detain him. Sanchez was taken into custody and sent to county jail on the charge of robbery.
- 12/29/15 at 10:59 am detectives tracked one of our homicide suspects to a residence on Power Av. in Pittsburg. They set up a perimeter until a search warrant was authorized and signed by a judge. Afterwards, the Investigations Unit deployed to the location and initiated a Surround and Call-Out. The 26 year old suspect, Travis Richards, was inside with his children and surrendered peacefully. He was taken into custody and transported to the APD Jail. Good job by all.
- On 12/29/15 at 11:51 am officers responded to the area of "A" St and HWY 4 to contact several transients loitering in the area. They contacted 44 year old Charles Farmer who gave the officers his cousin's name because he was on parole and thought he had a warrant. The information was not adding up and Farmer's identity was ultimately discovered. He was arrested and transported to county jail.
- On 12/28/15 at 7:30 pm staff from the Commons located at 4751 Dallas Ranch Rd. called to report a 77 year old female resident walked away from the facility and could not be located. Staff advised she suffered from dementia and did not have warm clothing when she left. Staff advised they had searched the complex and she was nowhere to be found. We spent significant time searching for the victim who was eventually located sleeping in a vacant unit at the complex while searching each room again.
- On 12/28/15 at 3:04 pm 3 people just returned to a house on W. 7TH St. when a white Ford Explorer slowly drove by and opened fire. A car in the driveway was struck by gunfire, and the house was also hit. Afterwards, the white Ford Explorer fled and the victims got into a white IROC Camaro and gave chase. No persons were struck by gunfire that we knew of. While we were investigating this shooting Pittsburg PD advised of a white car chasing another vehicle in their city shooting at it. It was suspected that this may have been related, but that has not been confirmed. Video was collected from the victim's residence, and we were not able to locate the Camaro or the initial shooters. Several .22 caliber casings were collected.
- On 12/27/15 at 10:33 pm 19 year old Emerald Fisher was driving on Fredrickson Ln. with two 19 year old passengers and a 17 year old female passenger. Fisher stated that she was driving at approximately 90 mph when she lost control of the vehicle and struck a city owned wall. One passenger sustained a laceration to her head which was bleeding profusely. The other three occupants had complaints of pain,

were transported to the hospital, and released. Fisher was arrested for DUI and sent to county jail.

- On 12/27/15 at 1:03 pm the 41 year old Dava Seward and the 35 year old female victim are transients and got into a heated argument on the front patio of the A St. Jack in the Box. During the argument Seward brandished a mid-sized folding knife and stabbed the victim in the ribcage. Seward tried to stab her again but the victim blocked it. The employees called the police and an officer was just down the street. The officer pulled up and contacted Seward trying to walk away from the scene. Seward discarded the knife that was used and was armed with another one. Seward discarded that knife as well and was taken into custody. The victim was contacted and had a deep puncture to the ribcage. She was transported to an area where she was admitted. The injury was listed as non-life threatening.
- On 12/26/15 at 10:41 am On Christmas Day BART PD contacted 27 year old Charles Goetting at a BART station in Hayward. Goetting opened fire on two (2) officers striking one of them in the arm. The officers returned fire and wounded Goetting. The injured officer will be all right. Goetting was struck several times and transported to a local hospital where he is in stable condition. When BART PD searched the U-Haul Goetting was associated with they located a murdered body of Goetting's 40 year old male roommate. It appeared that Anderson was not murdered in the U-Haul, and they suspected he may have been killed at his residence. Anderson and Goetting were roommates and both had ties to Antioch. Goetting was on felony probation on Jennifer Ct. and Anderson had been recently arrested by us on Alcalá St. BART PD Investigators requested our assistance with this part of their investigation in locating a possible homicide scene in Antioch. The Antioch PD Investigations Unit activated our on-call detectives and deployed to assist BART PD. In a joint effort the investigators ultimately determined both locations in Antioch were no longer good, and a crime scene was not located or determined to be in Antioch at this time. APD Detectives responded very quickly and had the investigation wrapped up fast. BART PD was extremely appreciative of the support and assistance in their investigation.
- On 12/26/15 at 1:46 am officers responded to a 911 call of shots fired in the 1900 block of Cavallo Rd. On arrival they located a Nissan and Mercedes Benz that had been struck. Both vehicles belonged to the same 61 year old victim. Officers also located 56 year old female inside of a home with a non life threatening gunshot wound to the lower right leg. She refused medical. Officers located seven .45 cal spent casings; one .45 cal bullet in the Mercedes Benz roof. There were many people in the area but nobody saw anything. There are no suspects at this time.
- On 12/25/15 at 6:48 pm a neighbor called to report 6-7 gunshots being fired from the rear yard of a home on South Lake Ct. While officers were on scene, 24 year old Wesley Smetzer-Van Pelt came from a side yard gate into the front yard. Officers contacted him and he was extremely intoxicated and uncooperative. The victim was transported to an area hospital and later determined to have a broken pelvic bone and ankle. His injuries were not life threatening but would require surgery. Four 9mm spent casings were located at the scene. The victim stated a black male from Stockton known to him as "Murk" was the one who shot him and he was in a newer model silver Jeep. The responsible was not located but the investigation is on-going.
- On 12/25/15 at 5:10 pm officers were dispatched to an alarm at Goodwill, which has been burglarized several times recently. A 36 year old employee arrived on scene prior to officers and advised he could hear voices from inside the fenced yard. Officers arrived on scene and set up a perimeter. Two subjects attempted to flee from the yard but were contained inside by the perimeter units. A K-9 officer made several announcements into the yard but got no response. The K-9 subsequently searched the yard and apprehended 40 year old Bryan Thompson who was trying to hide in a storage container. The second subject was able to evade capture. Thompson was medically cleared for the dog bite to his arm and then booked at county jail for burglary and violation of probation.

Officers arrived and contacted Morgan, who was extremely intoxicated. He was arrested and transported to county jail for a sobering period. The bartender declined to pursue charges for the assault.
- On 12/23/15 at 11:55 pm an officer was patrolling on A St. at Texas St. when he ran the plate of a Honda Civic in front of him. The Civic was a stolen vehicle out of Bay Point and it was occupied by three subjects. The Officer followed the Civic as other Officers responded to his location. Stout lives locally and it was learned that he had a rifle and a shotgun. Officers contacted Stout at his residence, but he was intoxicated and refused to come out. Stout challenged officers to kick his door down and refused to exit. A perimeter was established and phone contact was

made. After about two (2) hours of stand-off family members convinced Stout to come out peacefully. Stout was taken into custody and two (2) firearms were collected. Stout was extremely intoxicated. He was transported to county jail.

- On 12/22/15 at 8:29 am an officer received a LoJack hit on Buchanan at Mission. The vehicle was reported stolen out of Oakland, which stemmed from a domestic in their city and they had suspect info. The officer tracked the hit to Pear St. where we located the vehicle parked in a garage. Officers made contact with an elderly lady at the door who knew nothing about the stolen vehicle.
